## Next PANA meeting of 13 October 2016

### Public Hearing: International standards set at supranational level by international & intergovernmental bodies, and their enforcement

On 13 October 2016, from 9h00 to 12h30, the Members of the PANA Committee envisage to hold a hearing on "International standards set at supranational level by international & intergovernmental bodies, and their enforcement".

Invited speakers are representatives of the Organisation for Economic Co-operation and Development (OECD, as the international standard setter on information exchange for tax purposes), the Financial Action Task Force (FATF, as the international standard setter on anti-money laundering measures), the European Police Office (Europol), the Committee on the Evaluation of Anti-Money Laundering Measures and the Financing of Terrorism (Moneyval), and the European Banking Authority (EBA) (all speakers are 'to be confirmed').

[+ possibly in addition: Eurojust, and the European Anti-Fraud Office (OLAF)]

The purpose of the hearing is to understand how international standards in the area of information exchange for tax purposes and Anti-Money Laundering (AML) are set, and which are the bodies and mechanisms which assess their effective implementation and enforcement.
