Introductory words by Thomas Händel

The first EMPL Committee meeting of the month will take place on 7 and 8 November. It will start with a hearing on Health and



safety related to the new generation jobs, followed by exchanges of views with the directors of the Global Indicators Group and the EU Agency for Fundamental Rights. We will also hold our second European Youth Event follow-up hearing and exchange views with representatives of the European Commission on a Commission Delegated Regulation.

Furthermore, there will be an exchange of views on the Posting of workers in the framework of the provision of services, and the Committee will consider the amendments tabled to the draft report on A European Pillar of Social Rights. Finally, it will adopt the question for oral answer on Establishing a Skills Guarantee.

During the Committee meeting on 29 November, there will be an exchange of views with Commissioner Malmström on the social and labour aspects of international trade negotiations and agreements. In addition, Members will consider the draft report on the Amendment to Directive 2004/37/EC on the protection of workers from the risks related to exposure to carcinogens or mutagens at work. Finally, the EMPL Committee will vote on the motion for resolution and oral question on European Qualifications Framework for lifelong learning.

During the last plenary session, the resolution on Parliament's position on the EU budget for 2017 was approved. Among other things, MEPs call for an extra €1.5 billion to be made available to fund the Youth Employment Initiative.

I would also like to announce that on 17 November, the European Foundation for the Improvement of Living and Working Conditions (Eurofound) and the EMPL Committee will hold a joint conference on Changing working conditions in Europe: Moving towards better work.

Finally, let me inform you that the biannual Tripartite Social Summit took place on 19 October. The guiding theme was 'Addressing Europe's common challenges: generating growth, creating jobs and ensuring fairness', and discussions focussed on the European Semester, the New Skills Agenda for Europe and the integration of refugees into the labour market.

Joint Eurofound-EMPL conference on Changing working conditions in Europe: Moving towards better work

On 17 November, Eurofound and the EMPL Committee will hold a joint conference on Changing working conditions in Europe: Moving towards better work. At this occasion, Eurofound will present the sixth European Working Conditions Survey, providing fresh evidence to illuminate job quality and the working lives of Europeans at work and beyond. It aims to help policymakers improve working conditions and share evidence on people's everyday scenarios at work. This latest edition of the survey covers 35 European countries and examines issues ranging from work-related physical and psychosocial risks, working time and work organisation to developing skills at work and lifelong learning, work–life balance, work and gender and health and well-being.

Plenary follow-up of EMPL reports



During the last plenary session, the resolution on Parliament's position on the EU budget for 2017 was approved. Among other things, MEPs call for an extra €1.5 billion to be made available to fund the Youth Employment Initiative to help youngsters desperately seeking a job. The plenary vote triggers three weeks of "conciliation" talks with the Council, with the aim of reaching a deal between the two institutions in time for next year's budget to be voted by Parliament and signed by its President in December.
