## Background

In a context of high unemployment and the ongoing debate about the challenges, impact and possible responses to digitalisation in Europe, coupled with growing inequalities and the underutilisation of human capital, it is important to share evidence on how people work and get on at work. With this in mind, Eurofound's sixth European Working Conditions Survey provides fresh evidence to illuminate job quality and the working lives of Europeans at work and beyond.

In particular, the survey maps changes in work over time and provides the first comprehensive image of job quality in Europe since the Great Recession. This latest edition of the survey covers 35 European countries (EU-28 and Norway, Switzerland, Albania, FYROM, Montenegro, Serbia, Turkey) and examines aspects ranging from work-related physical and psychosocial risks, working time and work organisation to developing skills at work and lifelong learning, work–life balance, work and gender, and health and well-being.

Against the background of the diverse picture of Europe at work, the survey underlines the complex reality with which Europe's policymakers are confronted as they seek to build a fair and competitive Europe. Work is a central activity in Europe and fundamental to the achievement of the EU's goals for smart, sustainable and inclusive growth as part of a highly competitive social market economy – aiming towards full employment and social progress, a high level of social protection and the improvement of the quality of the working environment.

During this conference, European policy actors will evaluate EU policy responses to job quality challenges by building on a description of the seven dimensions of job quality and assessing how European workers fare in terms of job quality. Job quality is a key element in sustainable work over the life course and this will be examined in the second session, with particular attention to work and care over the life course as well as to ageing at work. Finally, the third session will go beyond the European borders to examine what a global agenda on working life over the coming decades could look like.

The conference is also particularly timely in light of the European Commission's recent proposal for a European pillar of social rights which has launched a rich debate among policymakers and to which this conference hopes to contribute.
