During the month of December, the EMPL Committee will meet twice. On 5 December, we will hold an exchange of views on the



Greek labour market reforms with Pedro S. Martins, Member of the Expert Group for the review of the Greek labour market institutions. The agenda also foresees the consideration of draft opinions on the so-called European Accessibility Act, the EU flagship initiative on the garment sector and the functioning of franchising in the retail sector.

During the meeting on 8 December, the EMPL Committee will consider draft reports on the 'Amendment to Directive 2004/37/EC on the protection of workers from the risks related to exposure to carcinogens or mutagens at work' and on the 'European Semester for economic policy coordination: Employment and Social Aspects in the Annual Growth Survey 2017'. We will also consider six draft opinions on the discharge 2015 and two on the cross-border exchange and use of works protected by copyright for the benefit of persons who are blind, visually impaired or otherwise print disabled.

Moreover, the Committee will vote on the draft report on A European Pillar of Social Rights and on draft opinions related to the European Globalisation Adjustment Fund (EGF); the Comprehensive Economic and Trade Agreement between Canada and the EU; the status of fish stocks and the socioeconomic situation of the fishing sector in the Mediterranean; and the need for an EU strategy to end and prevent the Gender Pension Gap.

Let me recall that following the Council's formal approval of the conciliation agreement with Parliament, the Chamber approved the EU budget for 2017 during the last part session.

I would like to thank you for your attention throughout the year and look forward to providing you with a new round of EMPL bulletins in January 2017. I would also like to take this opportunity to send you my best wishes for the holiday season.

# European Semester for economic policy coordination: Employment and Social Aspects in the Annual Growth Survey 2017

#### **Consideration of draft report**

In her draft report, which will be considered on 8 December, the rapporteur welcomes the fact that the Annual Growth Survey 2017 emphasises the need to ensure social fairness. Among other things, she underlines that the implementation of the Youth Guarantee should be strengthened and encourages Member States to make further efforts in order to reach the Europe 2020 employment rate target of 75%. She also calls on Member States to better align education and training with labour market needs and stresses that insufficient investment in education may undermine Europe's competitive position and the employability of its workforce.

# Approximation of the laws, regulations and administrative provisions of the Member States as regards the accessibility requirements for products and services

#### **Consideration of draft opinion**

On 5 December, EMPL Members will consider the draft opinion on the so-called "European Accessibility Act". The proposed

Directive aims to improve the functioning of the internal market by removing barriers created by divergent national legislation through harmonised compulsory accessibility requirements for a list of products and services. In his draft opinion, the rapporteur tabled 230 amendments to the Commission proposal.

# EU flagship initiative on the garment sector Consideration of draft opinion

In her draft opinion, which will be considered during the EMPL meeting on 5 December, the Rapporteur argues that voluntary initiatives are not adequately addressing issues such as health and safety, wages, social security and working time. She stresses the importance of free trade unions, independent labour inspections and factory-level Occupational Safety and Health policies and action plans. The draft opinion also calls for a platform to share best practice on management/worker training. In order to ensure that responsibility extends throughout the entire supply chain, the draft opinion concludes that the EU should develop a common framework through legislation on mandatory due diligence and supply chain transparency and that information gathered as a result of EU action should be publicly available.

# The functioning of franchising in the retail sector

#### **Consideration of draft opinion**



In his draft opinion, which will be considered on 5 December, the recalls rapporteur that franchising is an effective way people to set up their own business and thus

employment. He argues that despite this, 100% of the investment comes from the franchisee. Moreover, he notes that the rules on franchising vary greatly from one Member State to another and calls on the Commission and the Member States to implement measures to improve protection of franchisees and their employees while ensuring that the business concerned remains viable.

# Cross-border exchange and use of accessible format copies of works protected by copyright for the benefit of persons who are blind, visually impaired or otherwise print disabled Consideration of draft opinions

On 8 December, the EMPL Committee will consider two opinions on the Commission proposals for a regulation and a directive dealing with *cross-border exchange* and *use* of accessible format copies of works protected by copyright for the benefit of persons who are blind, visually impaired or otherwise print disabled. With these proposals, the Commissions aims to allow the Union to fulfil an international obligation under the 2013 Marrakesh Treaty to Facilitate Access to Published Works for Persons who Are Blind, Visually Impaired, or Otherwise Print Disabled.
