4. CONTROL OF THE REGISTER AND COMPOSITION OF THE COMMISSION'S EXPERT GROUPS

In light of the findings of a study commissioned by CONT and BUDG in 2015 and the need for an adequate follow-up of this issue the Conference of Committee Chairs approved on 26 November 2015 the CONT-proposal for the elaboration of an own-initiative report on the register and composition of the Commission's expert groups.

On 1 March 2016, the Rapporteur published a working document for CONT, outlining his main concerns with the existing horizontal rules and register.

The Commission adopted on 30 May 2016 its Decision establishing horizontal rules on the creation and operation of Commission expert groups.

In his initiative report the rapporteur addresses inter alia the following issues: the public nature of the deliberations in expert groups, their minutes, as well as to the assurance of a balanced composition in specific cases. In addition, the discussions concentrated on the enforcement of the revised rules and the reimbursement of costs of interest representatives, other than those relating to travel and accommodation.

On 27 April 2016 BUDG committee adopted its opinion on the expert groups.

On 29 November JURI adopted its opinion on the same issue.

57 amendments were tabled by CONT Members and are available on <u>CONT website.</u>

Two compromise amendments were tabled by the rapporteur concerning respectively the Commission expert groups covered by the new rules and about the transparency principle regarding the minutes of the meetings of the experts groups.

The final voting was circulated to Members on 20 December.

5. The role of Whistleblowers in the protection of EU's financial interests

Funds mismanagement and misallocations are frequently related to corruption, conflict of interest or other types of unethical behaviour. In this context, the effectiveness of whistle-blowers is linked to the existence of an organised and integrated system allowing people (both

internal and external to the EU institutions) to report any type of funds mismanagement on condition that an effective and efficient whistleblowing policy exists.

In his draft initiative report, Dennis De Jong emphasises that a legislative instrument is needed in addition to an independent European institution with sufficient budgetary resources protecting both external and internal whistle-blowers, in order to protect the financial interests of the European Union. In addition, whistle-blowers are important to address irregularities in a broader sense, including those not immediately affecting the financial interests of the Union. The draft report notes that the protection of whistle-blowers should be addressed more broadly.

The English version of the draft report was sent to Members on 12 September 2016 and was published on the CONT website.

The English version of the 103 amendments was circulated on 25 October 2016 and published with other language versions on the <u>CONT website</u>. AFCO adopted its opinion on 21 October 2016.

Three compromise amendments were tabled by the Rapporteur concerning the establishment of an EU body and a unit in the Parliament to help whistle-blowers to disclose their information on possible irregularities affecting the financial interests of the Union, and concerning the establishment of procedures for receiving and protecting whistle-blowers in OLAF and EPPO.

The voting list was circulated to Members on 19 December.

Those Institutions received the questions put by CONT Members with technical and specific matters on 21st November. Their replies were emailed to Members on 20 December 2016.

According to the Court of Auditors, the expenditure in 2015 of the Other Institutions was free of material error. No significant weaknesses were detected by the ECA in relation to the topics audited.

CONT committee invited the Secretary Generals of the "Other Institutions" to attend the exchange of views of 9 January. Their presence was confirmed except for the Council's Secretary General. In the exchange of views the Members will assess the management of the expenditure and the performance of those Institutions during the financial year of 2015.
