Therefore, the panel should also look into strengthening the role of consumers, workers, SMEs and the environment in standard-writing activities so that standards in Europe reflect a modern inclusive society. The panellists can share their first-hand knowledge and experiences on how the standardisation system can be improved and made more inclusive. When it comes to harmonised standards, the panel should also explore if the timeliness, quality and involvement of these standards needs to be improved. (25 min)]
