# **Ondrej Maly**

Former Member of the Council for the Czech National Regulatory Authority for Electronic Communication Services



Mr. Ond ej Malý was born on 13 July 1979 in Prague, where he has lived all his life. He studied journalism (Bc.) and International Territorial Studies, specialized in American Studies (Mgr.) at the Faculty of Social Sciences, Charles University in Prague. He had a one-semester stay in the Renvall Institute at the University of Helsinki during his Master studies.

His work career has always been oriented at modern technologies – from 1997 he worked as a computer games reviewer for Score and then Level journals. From 1999 to 2001 he worked in the online daily iDNES, where he was

responsible for the IT and science sections and contributed to the MF DNES technological supplement.

From 2001 to 2005 he also learned what it is like to produce the games themselves, which he did for the best-known Czech computer games producer – Brno company Illusion Softworks (today's 2K Czech). He participated in the design and production of Circus Grande and Chameleon games and other projects.

From 2007 he worked as a technology, telecommunication and IT journalist for the economic editorial board in Lidové noviny. In the middle of 2010 he left LN for the economic editorial board in Hospodá ské noviny, where he dealt with the same topics, i.e. mostly telecommunications and information technologies.

In March 2012 he was appointed a Member of the Council of the Czech Telecommunication Office by the Government of the Czech Republic for five years, i.e. until 2017.

In his free time he is fully devoted to his son.

Kevin Martin is the Vice-President for Mobile and Global Access Policy at Facebook where he oversees, among others, Facebook's connectivity programs and communication regulatory issues.
