Dr. Matthias Boll, M.C.L. *Deputy Head of ESF Managing Authority Ministry of Social Affairs and Integration Baden*-*Württemberg*

Dr. Matthias Boll studied Law and Comparative Law in Heidelberg, Speyer, Mannheim and Adelaide. He has been working for the Ministry of Social Affairs and Integration Baden-Württemberg since 2003. Initially his responsibility was in the fields of Long-term Care Insurance Law and the supreme supervisory authority for nursing homes, then he was in charge of the supply with ambulance services. After a one-year leadership course at the Leadership Academy Baden-Württemberg he took up the position of the deputy head of the "Basic Income Support for Job Seekers and Social Welfare" unit in 2010 and changed to the "ESF-Managing Authority" unit in 2014. The managing authority is in charge of the planning and implementation of the operational program including the cooperation on the national and transnational level, fulfilment of the reporting requirements and public relations work.



Dr. Jorge Núñez Ferrer, Senior Research Fellow at the Centre for European Policy Studies (CEPS)

Jorge Núñez Ferrer is Senior Research Fellow at CEPS and visiting lecturer at the Central European University in Budapest. He is a specialist on the EU budget and financial instruments, having worked on EU financial issues as a Commission official and as a consultant to various Member States and EU institutions.

He has recently acted as project leader for the preparation of the independent background report on EU Own Resources for the High Level Group led by Mario Monti. He also coordinates Framework Programmes on the EU budget for the Parliament and the Committee of the Regions. Next to this, he also works on issues related to energy policy, innovation and Smart Cities.

Mr. Monnart has over 30 years of professional experience among which 11 years in the banking industry acting as Director in British and German banks and 14 years in European institutions, the Commission (DG Fish) and EFSA (Parma). His duties at EFSA cover budget, financial management, procurement and accounting.

François has extensive experience in budget management, financial systems, managing risks, and implementing internal control systems.

Dr Edward Best, Head of Unit "European Decision-making" European Institute of Public Administration (EIPA)

Edward Best is Head of Unit and professor at the European Institute of Public Administration (EIPA), Maastricht, and Senior Fellow of Maastricht University.

He specializes in European institutions and the political aspects of European integration, as well as comparative regionalism and the management of regional organizations.

He is the author of Understanding EU Decision-Making (Springer, 2016) and EU Law-Making in Principle and Practice (Routledge, 2014), and is co-editor of The Institutions of the Enlarged European Union (Edward Elgar, 2008). He has produced numerous articles on the EU and institutional arrangements for regional integration, including contributions on transparency, citizen participation, and governance indicators in regional contexts, as well as a commissioned study for the Committee of Regions on Direct and Participatory Democracy in the EU.

He has been responsible for successive framework contracts to provide training and consultancy services to the EU institutions on European governance, and gives regular courses in the European Commission, European Parliament, Agencies and other bodies of the EU.



Mr Lukás Wagenknecht, Chairman of the Czech NGO "Good Governance"

Lukas deals with the topic of financial management and internal audit in the private and public sectors for last 15 years.

He graduated the Faculty of Economics and Administration at the University of Pardubice. In his professional practice engaged internal audit and audit of the Structural Funds on the Interior Ministry, Regional Council of the Cohesion Region Central Bohemia and at the Deloitte Audit Prague office.
