


DR. ERIK VAN DER MAREL

Erik van der Marel is a Senior Economist at ECIPE, consultant economist at the World Bank's Trade Department, as well as Associate Professor at the ULB. His areas of expertise are in services trade and digital trade and trade policy, Russia's trading patterns, as well as productivity analysis and digital trade . He has extended experience in economic policy analysis for developed as well as developing countries.

Prior to his appointment at ECIPE, Erik was a full-time lecturer at the London School of Economics where he taught International Political Economy and The Political Economy of International Trade at post-graduate level. In the past, Erik also gained various professional experiences as a consultant at the European Commission (DG Internal Market), OECD, APEC as well as the World Bank. Erik received his PhD in international economics from Sciences-Po Paris under the supervision of Professor Patrick Messerlin and Bernard Hoekman, specializing in links between regulation and productivity, comparative advantage in services, and the heterogeneous trade effects of services regulation.

His current work for the World Bank includes research and analysis on services trade, global value chains and digital trade factors. Other trade policy work for the World Bank focuses on Romania's ICT sector, China's GVC (global value chains) integration and Turkey's services trade competitiveness in connection to GVCs. At ECIPE, Erik is developing a database and index indicator that covers the regulatory cost factors of all sorts of digital trade policies including data policies such as data localization and conditional flow regimes. In this project, Erik is responsible for the economic oversight and methodology of the project. Erik also holds a blog called "Bruxenomics".

Jacques Pelkmans is Senior Fellow at CEPS (www.ceps.eu) in Brussels and visiting professor at the College of Europe in Bruges. Between 2001 and August 2012 he was Jan Tinbergen Chair and Director of the Economics dept at the College. A Ph. D. in economics from Tilburg University, he has been associate professor of economics at the European University Institute in Florence, professor of Economics at the European Institute of Public Administration (Maastricht) and professor for European Economic Integration at Maastricht University. He has held a part-time position at

the WRR (think-tank of the Dutch Prime minister), is founding Director of the European Institute of Asian Studies in Brussels and was professor in 'Business & Europe' at the Vlerick Business School (Gent, Leuven, Beijing, St. Petersburg). Dr. Pelkmans has been advisor to the European Commission, the OECD, the World Bank, UNIDO, ASEAN and governments in Europe and Asia. In 2015, he was a member of the High Level Group on the Single Market Strategy appointed by the European Parliament.
