# General budget of the European Union for the financial year 2018 - all sections

Vote on draft opinion and on budgetary amendments (see meeting documents)

20 amendments have been tabled to the draft opinion + 89 budgetary amendments

#### 1. Draft opinion

On 30 May 2017 the Commission proposed a Draft Budget (DB) for 2018 of EUR 161 billion in total (in commitments, +1.7% compared to 2017), focused on jobs, investments, migration and security. As a general rule, the Commission aligned its DB 2018 proposal to the amounts foreseen in the Multiannual Financial Framework 2014-2020, as modified by the mid-term revision adopted in 2017. Commissioner Öttinger stressed that the DB 2018 may be the last one for 28 Member States. In her draft opinion, the Chair particularly stresses that every effort should be made to reach the 20 % target of climate-related funds, and calls for sufficient resources to be allocated to the protection of biodiversity. The Chair also particularly disapproves of staff reductions in agencies under ENVI's remit, which could negatively impact their work. The Chair also recalls that Pilot Projects (PPs) and Preparatory Actions (PAs) should receive adequate funding throughout their life cycle, so that they can reach their full potential. 20 amendments were tabled on, among others, climate change, the transition to a low carbon economy, the European Solidarity Corps, agencies and pilot projects.

#### 2. Budgetary amendments

89 budgetary amendments were tabled:

- 24 are PPs or PAs 16 are new PPs; 6 are amendments prolonging existing PPs; 2 are new PAs.
- 45 are 'restore DB' AMs: 42 tabled by the Rapporteur after the Council position was issued, as agreed with groups; 3 tabled before the Council position was issued;
- 20 are other kinds of budgetary AMs: 16 AMs increase commitments and/or payment appropriations; 3 concern establishment plans (agencies); 1 creates a new budgetary line.

# Objection pursuant to Rule 105: Total diet replacement products

Vote on draft motion for a resolution (see <u>meeting documents)</u>

Total diet replacement for weight control is a product specially formulated for overweight or obese adults who intend to achieve weight reduction. This delegated Regulation updates the existing rules regarding total diet replacement for weight control with an energy content between 3 360 kJ (800kcal) and 5 040kJ (1200kcal) and lays down specific rules on total diet replacement with an energy content



fewer than 3 360kJ (800kcal). The objectors, Julie Girling and Annie Schreijer-Pierik, oppose the draft measure on the grounds that the Commission's draft delegated act as it currently stands, if adopted, would result in a lower standard of products

being available to consumers, in lower quantities, and at a higher price, thus reducing the uptake of this valuable weight loss option and potentially driving consumers towards riskier alternatives.

## Action Plan for nature, people and the economy

Consideration of draft motion for a resolution (see meeting documents)

The Commission launched in 2014 a comprehensive evaluation of the Nature Directives, which was concluded in December 2016, when the Commission published the 'Fitness Check' evaluation. This evaluation found that, as part of broader EU biodiversity policy, the Nature Directives are fit for purpose, but that achieving their objectives and realising their full potential will depend upon substantially improving their implementation. This comprehensive action plan aims to rapidly improve practical implementation of the Nature Directives and accelerate progress towards the EU 2020 goal of halting and reversing the loss of biodiversity and ecosystem services. The draft motion for resolution stresses the importance of taking immediate, substantial and additional efforts in order to achieve the 2020 targets, of involving all actors, including civil society, of improving coherence with the Common Agricultural Policy (CAP), and of ensuring adequate funding for biodiversity and nature conservation.

#### **Environmental Implementation Review**

Consideration of draft motion for a resolution (see *meeting documents*)



On 3 February 2017 the Commission published the first edition of the Environmental Implementation Review (EIR). The EIR aims to provide an overview of Member States' implementation of EU environmental law, and to support them if necessary. The publication includes 28 country

reports, a Commission summary of the most common problems, and suggestions for improvement.

The motion for resolution adresses, inter alia, the following key issues:





- the need of putting implementation problems high on the political agenda and to create a structured implementation dialogue;
- the need to increase the coherence of the EU action by linking the EIR to the European Semester, the 7th Environment Action Plan and the Sustainable Development Goals;
- the need to include important areas such as climate change, chemicals and industrial emissions in future versions of EIR;
- the need to increase data comparability;

- the importance of the exchange of best practices and peer-to-peer review among national authorithies and of a better use of the EU funds.
