Dear Colleagues,

The first of our two committee meetings this month will be held in Strasbourg. ITRE will have the pleasure welcoming of Commissioner Elżbieta Bieńkowska to discuss two very important Commission proposals. The first is the Programme for European Defence Industrial Development. This 2-vear programme will not only have significant budget but will also, for the first time, provide EU-wide coordination for the EU defence industry. The second proposal is recent Commission communication on a renewed EU Industrial Policy. For Committee this is a very important document that the Commission prepared in direct response to the requests from the Parliament earlier this year.

During our meeting in Strasbourg, ITRE will also consider its draft opinion on the digital trade strategy. Our Committee feels the responsibility of giving its opinion on this issue since an increasingly digitalised international trade has a direct impact on EU industries and SMEs as well as the citizens.

ITRE will also adopt its reports on the European Electronic Communications Code, on BEREC and on the Bio-Based Industries Joint-Undertaking. Moreover, the Committee will vote on its opinions on the Regulation on Privacy and Electronic

Towards a digital trade strategy

Consideration of draft opinion

Rapporteurs: Reinhard Bütikofer

ITRE will be considering the draft opinion of Reinhard Bütikofer (Greens) on the INTA own-initiative report entitled 'Towards a digital trade strategy'. The purpose of this report is to outline the Parliament's position on digital trade issues and new e-commerce initiatives at the WTO, as the issue of digital trade has not been sufficiently addressed to date. ITRE is providing an opinion as it is the competent committee for the Union's industrial policy and related measures, as well as for the digital agenda. The Rapporteur stresses that the EU must develop strategies to harness the benefits of digital technology for its citizens, businesses and consumers, ensure fair market access and protect the fundamental rights of citizens. At the same time the deployment of infrastructure adequate in coverage, quality and security is crucial to implement those strategies. He also focuses on the social aspects and impact of digital trade.

European Electronic Communications Code (Recast)

This draft report has received 1517 amendments and the compromise amendments negotiated cover the majority of the report. The opinion-giving Committees for this proposal are IMCO, CULT, JURI and LIBE. The final report for this proposal together with the negotiating mandates will be voted in Strasbourg on 2 October. The interinstitutional negotiations are then likely to kick-off soon after.

Exchange of views with Commissioner Elżbieta Bieńkowska on EU's Industrial policy and in particular on the Defence Industrial Development Programme

The ITRE committee will have an exchange of views with Commissioner Bieńkowska on the Commission's proposal for a Programme for European Defence Industrial Development, which is planned to cover the years 2019-2020, with a budget of EUR 500 million for the two-year duration. The ITRE rapporteur is Ms Grossetête (EPP). In addition to this, discussions are expected on the Commission's recently-published communication on a renewed EU Industrial Policy Strategy, which was requested by Parliament in its resolution of July 2017.
