11:20-11:30 First results of the LIFE-IP ZENAPA project

Prof Peter HECK, Managing Director of the LIFE-IP ZENAPA – Zero Emission Nature Protection Areas (Trier University of Applied Sciences, Institute for Applied Material Flow Management - IfaS): The project aims to work on the nexus between climate change mitigation and biodiversity protection and to establish viable economic solutions in nature protection areas and surrounding regions to reduce greenhouse gas emissions in line with national and pan-European climate protection targets (CAP 2020 and CPP 2050).

11.30-11.40 First results of the LIFE-IP MAŁOPOLSKA project

Mr Tomasz PIETRUSIAK, Director of the LIFE-IP MALOPOLSKA (Województwo Małopolskie): The aim of this project is the implementation of an air quality plan in the Małopolska region of Poland, and regional and local air quality policies the province of Silesia, and adjacent regions in Slovakia and the Czech Republic. Specific project objectives include the elimination of the barriers created by very low institutional capacities and insufficient implementation of air quality actions at the municipal level by establishing a network of eco-managers; increasing recognition of the significance of air quality management by local decision makers in Małopolska and in other regions; etc.

11.40-11.50 First results of the LIFE-IP C2CCC project

Mr Rolf JOHNSEN, Coordinator of the LIFE-IP C2CCC - Coast to Coast Climate Challenge (Central Denmark Region): The overall objective of C2C CC project is to create climate-resilient cities in a climate-resilient region by drawing up with local stakeholders a common, long-term strategy. This strategy will lead to the targeted implementation of local climate change adaptation (CCA) plans, coordinated CCA analyses and activities, and the identification and improvement of the resources and adaptive capacities of citizens, municipalities, utilities and companies in the water sector. The CCA plans address cities as well as the countryside and coastlines, and include solutions in the hinterlands to prevent flooding in the cities.

11.50-12.00 First results of the LIFE-IP GESTIRE2020 project

Mrs Elisabetta Maria ROSSI, Technical Coordinator of the LIFE-IP GESTIRE2020 (Regione Lombardia): The objective of the project is the creation of an integrated management structure for achieving conservation objectives, set out in the Habitats and Birds directives, for the Natura 2000 regional network in Lombardy. This will be achieved by developing policies and management actions for the Natura 2000 regional network that include the active management of habitats and species, the guarantee of coherence between the regional Natura 2000 network and external territories, the monitoring of the results of the actions undertaken, the guarantee of supervision of activities interfering with Natura 2000 sites, and the training of professionals in appropriate management for the regional network.
