Composition of the European Parliament



Consideration of amendments

Co-Rapporteurs: Danuta Maria Hübner, AFCO Chair (EPP), and Pedro Silva Pereira, AFCO Vice-Chair (S&D)

During this Committee meeting there will be a first exchange of views on the 170 tabled amendments. The amendments cover a broad range of issues regarding the future of the Parliament's composition. The principle of degressive proportionality is common ground for most of the amendments, but various approaches to seats distribution are suggested, ranging from introducing a permanent system for either the 2019 or 2024 elections, to electing a set number of MEPs on transnational lists or rejecting the creation of any joint constituency as such. Some of the contentious points stem from Brexit and include the redistribution of UK seats and the situation of Irish citizens in the UK.

A second consideration of amendments will take place during the next ordinary meeting on 21st November and the vote on the proposed amendments is scheduled to take place on 28 November in AFCO and in December in Plenary.

INTRODUCTORY WORDS BY THE CHAIR



Dear Readers,

I am very happy to present the 42nd issue of the AFCO Newsletter, a tool prepared by the Secretariat, which aims to inform you about AFCO activities and increase awareness of institutional challenges that the EU is facing.

During the morning session of our meeting on 11 October, the amendments on the composition of the European Parliament will be considered.

We will also vote on the draft opinion concerning the reform of the European Union's system of own resources which, among other issues, suggest a stronger role of the Parliament in order to achieve a higher level of transparency, democracy and legitimacy.

The second vote will concern the draft opinion on the next MFF post-2020.

Other highlights of this meeting include the discussion on the Commission's proposal to amend the Regulation on the Statute and funding of European political parties and European political foundations and an exchange of views on the role of cities in the institutional framework of the Union, enhancing their role in the EU decision-making and their involvement in the institutional architecture. Finally, progress on the working document regarding national

October 2014 on the statute and funding of European political parties and foundations, as Parliament had asked in its resolution of 15 June 2017. During the last meeting on 28 September, the Commission presented its proposal, which will be discussed during this Committee meeting. The co-rapporteurs will present the assessment of the proposal and they may suggest some amendments (corrections or additions to the proposal), while also listening to possible comments on it.

An agreement with the Council would have to be reached before the next European elections or, even more desirable, by the summer of next year so that it can apply for the budgetary year of 2019.

These amendments have specially the aim of reinforcing the draft opinion by making the system of own resources more transparent, democratic, legitimate and closer to the spirit of the Treaties. A higher involvement of the Parliament in the procedure for the adoption of own resources is suggested as well as a focus of the EU budget on areas with the highest "European added value".

The next MFF: Preparing the Parliament's position on the MFF post-2020

The Committee will vote on the draft opinion on the next MFF, to which 31 amendments have been timely tabled. Some amendments suggest highlighting the link between the reform of the MFF and the need to introduce genuine own resources, as the revenue and expenditure sides of the budget should not be looked at separately. There is a difference of opinion concerning the duration of the MFF. Some amendments point to the link with Brexit and its impact on the future MFF.

Interparliamentary Committee Meeting on "The future of Europe: Perspectives on the European Parliament's proposals and the Commission White Paper"



AFCO will hold an Interparliamentary Committee Meeting on 'The Future of Europe' on Wednesday 11 October in the afternoon. This will be an opportunity to continue the discussions with members of national parliaments about the future institutional evolution of the Union.

There will be a particular focus on the European Parliament's proposals of 16 February 2017, the Commission White Paper of 1 March 2017 and the accompanying reflection papers, as well as proposals made by the Commission in the context of the State of the Union 2017. Interventions are foreseen from the Commission Vice-President Valdis DOMBROVSKIS, the President of the Council of the EU, Matti MAASIKAS, and EP Vice-President Mairead McGUINNESS. The European Economic and Social Committee will also be presenting its views on the future of the EU expressed in its opinion entitled "Towards a Common Sense of Purpose".
