

HELP judges, prosecutors and lawyers to apply European human rights standards in their daily work, mainly by training



























# HELP course on Violence against women (VAW) and domestic violence (DV)

**VAW:** violation of HR and discrimination against women.

Many forms: physical, sexual, stalking, FMG or forced marriages.

Structure:

- 1. Understanding VAW and DV
- 2. Int'l and European Legal Framework
- 3. Overcoming barriers to Justice / A2J
- 4. Criminal Justice Response
- 5. Civil Justice Response
- 6. Alternative Dispute Resolution


