Scope of the research

- Local (one country based) study measuring impact of "Mobility Package" on national markets
 - Field research with Polish transport enterprises (>140 statistically valid sample)
 - Augmented by in-depth interviews
- EU-wide econometric study measuring relation between development of transport sector and economic growth

$$\ln(GDP_{p_{it}}) = \beta_{i0} + \beta_{i1}\ln(x_{it}) + \varepsilon_{it}$$

where: *GDPp* is a GDP per capita per country i in period t, x – is a measure of transport sector development in country i and period t, ε is error factor, and (i=1.2....24), (t=2000. 2016).
