For the financial year 2016, the eight Joint Undertakings (JUs) subject to the discharge procedure by the Parliament are the following: IMI, ECSEL, SESAR, CLEAN SKY, FCH, BBI, F4E and Shift2Rail. Shift2Rail (S2R) JU will be subject of discharge for the first time.

The European Court of Auditors in its reports has indicated that the accounts of all eight JUs present fairly, in all material respects, the financial position of the Joint Undertaking at 31 December 2016 in accordance with their Financial Regulation and with accounting rules adopted by the Commission's accounting officer. However for ECSEL the Court has added a qualified opinion as to projects taken over by the Artemis and ENIAC JUs due to variation of methodologies and procedures used by the National Funding Authorities (NFAs).

From the 8 Joint Undertakings, the Rapporteur selected four of them to be invited to the hearing:

- ITER and the Development of fusion for Energy (F4E)
- Electronic Components and Systems for European Leadership (ECSEL)
- Innovative Medicines Initiatives 2 (IMI)
- Shift2Rail (S2R)

Other JU representatives are also welcome to attend the hearing if they so wish.

The transactions subject to audit by the European Court of Auditors in the section concerning "migration and security" of Chapter 8 "Security and citizenship" of its annual report 2016 represent EUR 1.6 Billion excluding decentralised agencies, or approximately 1% of the EU budget.

Most expenditure for "migration and security "is from two funds: the Asylum Migration and Integration fund (AMIF) and the Internal Security Fund (ISF). In 2014 AMIF and ISF replaced the previous SOLID programmes (Solidarity and Management of Migration Flows). Like the SOLID programme, the management of most AMIF and ISF funds is shared between the Member States and the Commission.

The documents of particular relevance for the exchange of views as regards the 2016 Commission discharge are:

- The ECA's 2016 Annual Report, Chapters 1, 2 and 8 part 2;
- The Commission's follow-up report COM (2016) 674 final and SWD (2016) 338 and;

Goods entering the EU from outside the European Union are subject to customs controls by Member States before they are released for free circulation within the EU. Customs controls can only ensure the protection of the EU's financial interests if they are based on common rules and if they are applied in a harmonised and standardised manner by the Member States. At the time of entry, the customs authorities of the Member State of import should require the importer to pay or to secure any customs duties due on the imported goods. However, importers can deliberately reduce or evade customs duty liability by, for example, undervaluing their goods, declaring a false country of origin or shifting to a product classification with a lower duty rate. Customs duties make up 14 % of the EU budget. Their evasion increases the customs gap and must be compensated by higher Gross National Income (GNI) contributions by Member States. The cost is ultimately borne by European taxpayers.

The ECA examined whether the European Commission and the Member States ensure that import procedures protect the EU's financial interests. Important weaknesses and loopholes were found, which indicate that the controls are not applied effectively, resulting in an adverse effect on EU finances.

During its audit, the ECA found serious weaknesses indicating that there are shortcomings in the customs legal framework as well as an ineffective implementation of customs controls on imports and this adversely affects the financial interests of the EU. The ECA noted that the Member States are not sufficiently financially encouraged to perform customs controls. Those which perform customs controls but are not successful in recovering losses to the revenue of the EU risk financial consequences, whereas those which do not carry out such controls may not suffer such consequences. In addition, Member States have made progress towards the uniform application of customs legislation, but they have differing approaches in terms of customs controls to tackle undervaluation, misdescription of origin and misclassification and to impose customs penalties.

The ECA recommends that the Commission should:

- develop a methodology and produce periodic estimates of the customs gap from 2019 and take into account its results for the allocation of resources and for setting operational targets;
- consider all available options to strengthen support for national customs services in their important EU role in the new Multiannual Financial Framework, including a review of the appropriate rate of collection costs;
- in the next Multiannual Financial Framework propose that the next EU action programmes, which support the Customs union, should be used to contribute to financial sustainability to the customs European Information Systems;
- be more precise in the requests contained in a Mutual Assistance communication to ensure their uniform implementation by Member States;
- propose amendments to customs legislation in 2018 aimed at making compulsory the indication of the consignor in the customs import declaration.

The ECA recommends that the Member states should:

- make overrides of controls suggested by a particular risk filter conditional on prior or immediate hierarchical approval;
- introduce checks in their electronic release systems to block import declarations applying for duty relief on goods with declared value above 150 euros or for commercial consignments declared as gifts;
- set-up investigation plans to tackle abuse of this relief on e-commerce goods trade with non-EU countries.

# 12. ECA SPECIAL REPORT 21/2017 (2017 DISCHARGE): GREENING: A MORE COMPLEX INCOME SUPPORT SCHEME, NOT YET ENVIRONMENTALLY CONT/8/

The audit of the European Court of Auditors covers the design of greening and its first two years of implementation (claim years 2015 and 2016), as well as the coherence between this scheme and the other environmental instruments of the CAP (Common Agricultural Policy), i.e. cross-compliance and the environmental measures under rural development.

The Court's main objective was to assess whether greening was capable of enhancing the CAP's environmental and climate performance, in accordance with the objective set in the relevant EU legislation.

The Court found that the green payment lacks a fully developed intervention logic. The Commission has not set specific targets or otherwise specified what greening can be expected to achieve for the environment and climate.

The initial Commission proposal for greening was more ambitious in environmental terms but the subsequent dilution of the policy's environmental content did not change the level of funding proposed. This was set, from the outset, at 30 % of CAP direct payments.

On average, greening subsidies exceed significantly the cost to farmers (including from lost income) of meeting greening requirements. This is because the greening budget was fixed without a link to the policy's level of environmental ambition. Greening remains, essentially, an income support scheme. Greening is unlikely to provide significant benefits for the environment and climate, mainly because of the significant deadweight that affects the policy. This deadweight arises primarily from the fact that greening requirements are generally undemanding and largely reflect normal farming practice. Additionally, due to extensive exemptions most farmers (65 %) are able to benefit from the green payment without actually being subject to greening obligations. As a result, greening leads to a positive change in farming practices on only a very limited share of EU farmland.

The Court also found that certain design limitations reduced the effectiveness of the three greening practices. Crop diversification could not provide the full environmental benefits of crop rotation. The Environmentally sensitive permanent grassland (ESPG) designation was based mainly on biodiversity-related criteria and poorly targeted carbon rich permanent grassland outside Natura 2000 areas. Finally, the predominance of productive Ecological Focussed Area (EFA) types, combined with a lack of meaningful requirements on management, limited the positive impact of EFAs on biodiversity.

The Court made several recommendations and in particular asked the Commission, for the next CAP reform, to develop a complete intervention logic for the EU environmental and climate-related action regarding agriculture, including specific targets and based on up-to-date scientific understanding of the phenomena concerned.

Over the 2014-2020 period, the EU budget is expected to provide 1.78 billion euro to cover both future losses on the guaranteed portfolio and the costs of managing the instruments. As of 31 December 2016, the average expected loss in relation to the guarantee agreements already signed was 9% (or EUR 0,98 billion). This was higher than under the predecessor SME Guarantee Facilities (the average expected loss rate was 5.4 % for the 1998-2000 period, 5.1 % for the 2001-2006 period and 6.8 % for the 2007-2013 period).

Under the 1998-2000 SME Guarantee Facility, 52 % of financial intermediaries incurred losses corresponding to 90 % or more of the expected loss on their portfolio. Under the 2001-2006 Facility this was the case for 53 % of financial intermediaries. It is too early to provide similar data for the 2007-2013 SME Guarantee Facility.

For the current instruments, as of 31 December 2016, the loan portfolio (EUR 22,32 billion) of the contracted intermediaries was guaranteed for an amount of EUR 10,79 billion euro, or at a rate of nearly 50 %. The total expected amount of lending to businesses was EUR 27.55 billion.

In 2015 the European Fund for Strategic Investments (EFSI) was established. In 2016 the Commission, the European Investment Bank (EIB) and the EIF decided to make part of EFSI's budgetary resources available to top up the EU contribution for the two centrally managed instruments. The Loan Guarantee Facility will be topped up with EUR 0.55 billion and the InnovFin SME Guarantee Facility will be topped up with 0.88 billion euro. Therefore, total EU resources will increase from EUR 1.78 billion to EUR 3.13 billion.
