Value


- ▶▶ Market enabler for interoperable e-procurement solutions
- ▶▶ Significant simplification and improvement of the on-boarding process for buyers and suppliers that want to trade electronically

▶▶ Opportunities

- ▶▶ Digital transformation of public procurement can be done faster through the PEPPOL approach and sharing of knowledge and tools across MS

▶▶ Concerns

- ▶▶ Certain standardisation bodies' business model and IPR policies hampers stakeholder involvement and effective usage of European standards

▶▶ Relevance of the Commission's initiatives

- ▶▶ Capability and capacity building efforts among public buyers and their suppliers need to address digital transformation challenges and opportunities as part of the procurement professionalisation
- ▶▶ OpenPEPPOL support the EC efforts on new e-forms and will facilitate use of PEPPOL BIS messages as a source for information about public procurement transactions
- ▶▶ OpenPEPPOL support EC efforts to further improve and promote tools and standards and will support more MS in becoming market enablers for interoperable e-procurement solutions
