The rapporteur insists that the EU Budget, as a consequence of the budget-focused-on-results initiative, be presented according to the political objectives of the Multiannual Financial Framework.

He calls on the Commission to commit to fundamentally review the young farmers' greening schemes in light of the findings of the European Court of Auditors before the next financing period. Mr Zeller also calls on the Commission to speed up the delivery of cohesion policy programmes and the related payments with the objective of bringing down the implementation period -initially- to n+2.

The original versions of the 450 amendments tabled to part I, and the 28 amendments tabled to part II of the Commission discharge report were circulated to CONT Members respectively on 6 and 2 March. The English version of the amendments became available on 9 March.

The draft voting list, including the rapporteur's position, was sent out on 20 March 2018. The draft reports, the amendments and the opinions are available in all languages on the <u>CONT website</u>.

The Committee on Budgetary Control (CONT) held an exchange of views on the draft report on the 2016 EIB annual report right after the presentation and exchange of views in the presence of the Vice-President of the EIB, Mr Stubb, on 18 January 2018.

The draft report focuses, inter alia, on the promotion of financially sustainable activities providing long-term impact from EIB investments, the deepening of the monitoring of added value/additionality and the mapping of the levers for change in the implementation of Union's public policy goals, the achievements of EFSI, and the enhancing of EIB's corporate governance.

The deadline for tabling amendments was 6 February 2018, 72 amendments were tabled.

The Committee on International Trade (INTA) delivered an opinion on this CONT report on 20 February 2018 for which Mr Sander Loones was appointed Rapporteur.

On the basis of the CONT report, OLAF presented its annual report on 22 June 2017, this was followed up by a set of written questions, to which OLAF replied on 19 July 2017. On 28 September 2017, Commissioner Oettinger presented the EC report "Protection of the European Union's financial interests - Fight Against Fraud - Annual Report 2016 (COM (2017)383)".

In his report, Mr Pargneaux notes with satisfaction that the total number of fraudulent and non-fraudulent irregularities reported in 2016 (19 080 cases) was 15% lower than in 2015 (22 349 cases) and their value had decreased by 8% (from EUR 3.21 billion in 2015 to EUR 2.97 billion in 2016). He noted the slight decrease of 3.5% in the number of irregularities reported as fraudulent, which continued the downward trend observed since 2014. Mr Pargneaux welcomes the adoption of the Directive on the fight against fraud to the Union's financial interests by means of criminal law (the PIF Directive) and the decision of 20 Member States to proceed with the establishment of an European Public Prosecutor's Office through enhanced cooperation. He expresses his concern about losses due to the VAT gap and fraud relating to EU VAT, which amounted to EUR 159.5 billion in 2015. He noted with concern that tobacco smuggling to the EU has intensified in recent years and, according to estimates, represents an annual loss of EUR 10 billion in public revenue to the EU and Member States' budgets, while at the same time represents a major source of organised crime, including terrorism. He also regrets that this is the fourth year in which the irregularities reported as fraudulent in direct management increased in number (16 cases in 2015 and 49 cases in 2016) and value (EUR 0.78 million in 2015 and EUR 6.25 million in 2016)

There were 77 amendments received by the deadline of 10 January 2018. The draft report and the amendment are available in all languages on the <u>CONT website</u>.

### 8. THE VOLKSWAGEN LOAN CASE CONT/8/12536

### **Exchange of views representatives of the European Investment Bank**

Last year, OLAF completed an investigation into a EUR 400 million loan from the EIB to the Volkswagen Group. At the time, the President of the EIB, Werner Hoyer, stated: "We still cannot exclude that one of our loans, the 400m EUR loan Volkswagen Antrieb RDI', was linked to emission control technologies developed at the time the defeat software was designed and used. We will now review OLAF's conclusions and consider all available and appropriate action. [...]We are very disappointed at what is asserted by the OLAF investigation, namely that the EIB was misled, by VW about the use of the defeat device."

CONT will hold an exchange of views with representatives of the European Investment Bank.

### Exchange of views to follow-up the fact-finding mission

On the morningof 26 February at 8.41 am, the Slovak daily newspaper Dennikn published the news that Ján Kuciak, together with his fiancée, was killed. He worked for <a href="www.aktuality.sk">www.aktuality.sk</a>, a news portal belonging to the media group Ringier Axel Springer Media AG. Mr Kuciak was one of the few journalists researching and investigating a number of politically sensitive cases, such as the Panama papers, economic crime, potential fraud in distributing EU funds at the national level, VAT fraud, carousel schemes, etc.

An ad-hoc EP delegation consisting of LIBE and CONT Members was prepared at short notice with the help of the EP Liaison Office Bratislava and the Slovak Ministry of Foreign Affairs.

The meetings were taking place in an overall very constructive and positive atmosphere and allowed for enriching exchanges and the pursuit of the fact-finding objective.

After the mission to Slovakia, the Members approved a <u>mission report</u> which served as the basis of the Parliamentary debate on the situation in Slovakia on Wednesday 14 March 2018. A parliamentary resolution on this issue will be voted on the next parliamentary session.

### **Consideration of draft opinion**

The LIBE Committee is drafting a resolution on the situation in Hungary. As CONT has organised a delegation to Hungary in September 2017, which was followed by discussions on various EU funded projects based on the investigations of OLAF and problems highlighted by the European Commission, it decided to draft an opinion to this resolution and nominated Ms Gräßle as the rapporteur.

In her opinion, the Rapporteur highlights the number of investigations carried out by the European Anti-Fraud Office (OLAF) on 2013-2016 in relation to Hungary (41 cases), is the second highest in the Union. Additionally, 85 % of the investigations were concluded with judicial and financial recommendations. Ms Gräßle believes that the current level of corruption, and the lack of transparency and accountability on public finances, affects Union funds in Hungary. She considers that this might represent a breach of values referred to in Article 2 of the Treaty on European Union (TEU) and warrants the launch of the procedure under Article 7(1) TEU. Ms Gräßle notes with concern that the share of contracts

awarded after public procurement procedures that received only a single bid remains very high (36%), this is the second highest number in the Union.
