#### Adoption of motion for a resolution

Following the debate in plenary on 12 March 2018 on the integrity policy of the Commission, in particular, the appointment of the Secretary-General of the European Commission, the Conference of Presidents decided, at its meeting of 15 March 2018, to task the Committee on Budgetary Control to consider the case and table a motion for a resolution on the subject.

There were 134 written questions drafted by CONT and transmitted to the Commission on 20 March. . The replies from the Commission were circulated on 25 March.

On 27 March, CONT Members had the opportunity to exchange views with Commissioner Oettinger in this regard. Following the exchange views, 61 follow-up questions were sent to the Commission. The replies from the Commission were circulated on 4 April.

The draft motion of resolution was transmitted to CONT Members on 28 March.

There were 129 amendments received by the deadline of 5 April 2018. The draft resolution and the amendments are available in all languages on the <u>CONT website</u>.

### 4. HEARING OF THE CANDIDATES FOR THE POST OF DIRECTOR FOR THE EUROPEAN ANTI-FRAUD OFFICE (OLAF)

CONT/8/12621

Article 12(2) of the OLAF Regulation (Regulation 1073/1999) provides that:

"2. With a view to appointing the Director, the Commission shall, following a call for application which shall, if appropriate, be published in the Official Journal of the European Communities and after a favourable opinion has been given by the Supervisory Committee, draw up a list of suitably qualified candidates. After consultations with the European Parliament and the Council, the Commission shall appoint the Director."

On this occasion, CONT will hear the four candidates shortlisted by the Commission in a public meeting on 16 April 2018.

The timetable (indicative) for the hearings is as follows:

- > 19.30 20.10 Hearing of Ville Itälä
- > 20.10- 20.50 Hearing of Ivailo Kalfin
- 20.50 21.30 Hearing of François Kruger
- 21.30 22.10 Hearing of Andreas Mlitzke

Each candidate will make a 5-minute presentation followed by questions from Members (35 minutes).

Subsequently, CONT will evaluate the candidates <u>in camera</u> and, following a vote by secret ballot, establish its ranking of the candidates.

Afterwards, a High Level Group representing Parliament, Commission and Council will discuss the appointment. Parliament's delegation will comprise the CONT Bureau (Chairman and Vice-Chairmen) and the rapporteur.
