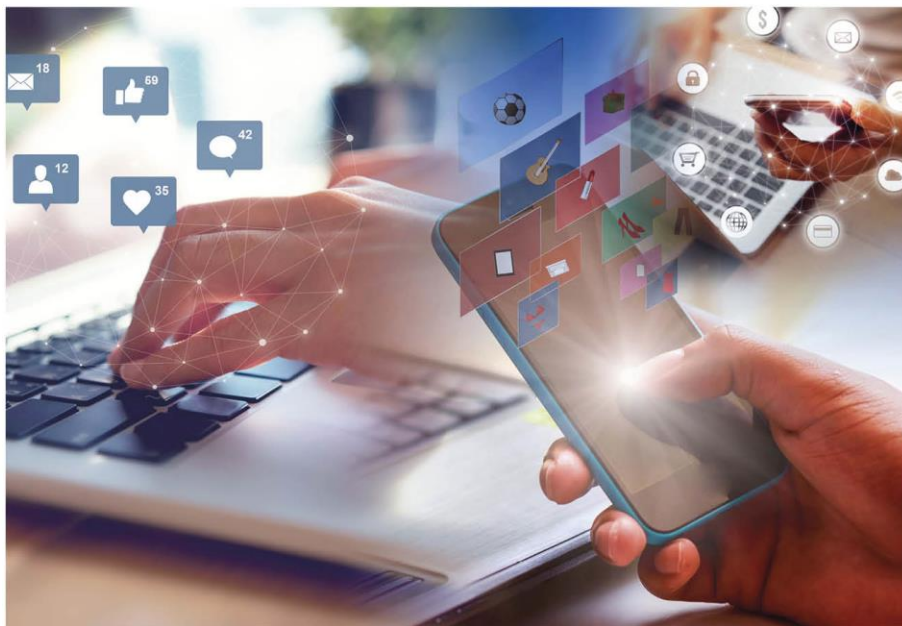

CHRISTINA ANGELOPOULOS

Christina Angelopoulos is a Lecturer in Intellectual Property at the University of Cambridge and a member of CIPIL (Centre for Intellectual Property and Information Law). Next to her position at the University of Cambridge, Christina is also an Associate Research Fellow at the Information Law & Policy Centre of the Institute of Advanced Legal Studies in London. She specialises in copyright, with a particular focus on intermediary liability. From 2011 to 2015, she wrote her PhD on the European harmonisation of the liability of online intermediaries for the copyright infringements of third parties at the Institute for Information Law (IViR) of the University of Amsterdam. Her thesis was published by Kluwer Law International in 2016 under the title “European Intermediary Liability in Copyright”.



JOE McNAMEE

Joe McNamee is Executive Director of European Digital Rights (EDRi), an association of 39 digital civil rights in 20 European countries, where he has worked since 2009. He has worked extensively on issues related to personal data protection and content regulation online, among others. He has a particular interest in issues surrounding the privatisation of law enforcement activities in the hands of internet giants.

DAPHNE KELLER

Daphne Keller studies the ways that Internet content platforms – and the laws governing them -- shape information access and other rights of ordinary Internet users. As the [Director of Intermediary Liability](#) at the Stanford Center for Internet and Society, she has written and spoken widely about the [Right to Be Forgotten](#), [copyright](#) notice-and-takedown systems, [cross-border](#) content removal orders, platforms' own [discretionary](#) content-removal decisions, and more. She has testified on these topics before legislatures, courts, and regulatory bodies around the world. In her previous role as Associate General Counsel at Google, Daphne worked on cases including [Viacom](#), [Perfect 10](#), [Equustek](#), [Mosley](#), and [Metropolitan Schools](#); and was the primary counsel for products ranging from Web Search to the Chrome browser. Daphne has taught Internet law at Stanford, Berkeley, and Duke law schools. She is a graduate of Yale Law School and Brown University, and mother to some awesome kids in San Francisco.

LORD RICHARD ALLAN

One of the most senior Facebook representatives, currently leads global teams on content, elections integrity, disinformation, WhatsApp policy and competition among others. He joined Facebook in June 2009 and led the company's public policy work in Europe till last year. Lord Allan was elected as Member of Parliament for Sheffield Hallam in 1997 and re-elected in 2001 before giving up his seat in 2005. He entered the House of Lords on 26 July 2010. He specialises in technology policy issues, and in the UK Parliament was a principal spokesman on a several bills including the Data Protection Act, the Regulation of Investigatory Powers Act and the Communications Act.

Michal came to Seznam.cz in 2004. He started his career in Seznam.cz as an IT operator with experience from other on-line portals and companies. In February 2008 he became member of the board of directors. His current responsibility is in legal and public affairs. In 2016 he has been appointed Deputy General Manager.



MARCO PANCINI

Born in Rome, Marco Pancini started his professional career as part of the start-up project of iBazar, the first on line auction web site in Europe, and then he joined eBay, when iBazar was acquired. From 2002 to 2007 Marco was Head of Legal and Trust and Safety at eBay.it, the Italian subsidiary of the world biggest online marketplace. On July 2007 he joined the Google team as European policy counsel in charge of government relationship for the Italian market, representing Google in important international meetings as the Internet Governance Forum of United Nations. Marco Pancini is now EU Director for Google for Public Policy and Government Relations, focusing on making sure the Web remains an open and safe place, and in particular on open Internet issues, freedom of expression, child safety, terrorist content and hate speech, and intermediary liability.
