Proposal for Regulation 868/2004 on competition in air transport

Presentation of draft report

Rapporteur: Markus Pieper (EPP)

Following the presentation of Mr Pieper's report, MEPs across all political groups expressed their support for the Commission's initiative and agreed that a new instrument protecting EU carriers against unfair competition from third countries should be efficient and dissuasive at the same time.

According to some MEPs, all measures going against these two objectives, such as extensive requirements and conditions put on the Commission to start investigation, excessive consultation periods or investigation deadlines, should be discarded in order to allow for a smooth and quick procedure.

There was an overwhelming consensus about sending a strong message to the Council confirming that the Parliament firmly stands behind the Commission's initiative.

However, at closer look, there were also different opinions, above all when it came to the solutions which should be applied in the process. These included, for example, Parliament's role in the consultation process, finding a definition of "Union's interest" without politicising it too much or dealing with the notions of "thread of injury" and negative effects on regional connectivity as triggers to launch the Commission's investigation.

As the next step, the TRAN Committee will assess the amendments to Pieper's report on 20th February.

Odometer manipulation

Presentation by Policy Department and EPRS

The two studies deal with an issue of odometer tampering used in the second-hand car market in the EU. They also provide for cost benefit analysis of potential EU legislative action in this field. Studies estimate the cost of odometer tampering at around €8.8 billion a year. In some Member States the fraud may relate to 80% of cars imported from other Member States. Currently, there are only national solutions in a limited number of Member States, such as Car-Pass in Belgium. There is a lack of cross border exchange of data. A cost benefit scenario for potential EU-wide legislative action is positive for most policy options.

Members underlined that it is important to enable cross-border exchange of odometer readings. Members also mention block chain technology as an option to tackle odometer fraud in new cars. External dimension of exporting used cars outside the EU should also be addressed according to Members.

The studies bring valuable input for reflection on EU-wide legislative action tackling odometer manipulation. The debate will continue with a presentation of Mr Ertug's report at the Committee meeting on 22/23 January 2018.

Proposal for a Council Decision on the signing, on behalf of the European Union, and provisional application of the Transport Community Treaty - COM(2017)0324

Presentation by the Commission

Alain Baron (EC) presented this Treaty, signed by the Western Balkans parties (ratified by all of them, except Montenegro) and applied provisionally.

The aim of the Treaty is the creation of a Transport Community in the field of road, rail, inland waterway and maritime transport; as well as the development of the transport network between the EU and the Southern European parties. It is based on the progressive integration of transport markets into the EU transport market on the basis of the relevant acquis, including the areas of technical standards, interoperability, safety, security, traffic management social policy, public procurement and environment, for all modes of transport, excluding air transport, with a 5-year rolling work programme and a permanent secretariat (in Belgrade).

At the debate, the Rapporteur (Mr Taylor) and other MEPs proposed to support this Treaty as a way to prepare the future Western Balkan's accession to the EU and to coordinate with the TEN-T.



Memoranda of Understanding on rail statistics

Exchange of views with Eurostat, the European Union Agency for Railways (ERA) and DG MOVE

In the context of its work on the revision of the Regulation of Rail transport statistics, the TRAN Committee had an exchange of views with Eurostat, the Commission (DG MOVE) and the European Union Agency for Railways (ERA).

In order to conclude the inter-institutional negotiations on the previous revision of the Regulation on Rail transport statistics in 2016, the European Parliament insisted on better cooperation between Eurostat, ERA and DG MOVE to share data and provide easy access to this data. As a consequence, the memoranda of understanding between these institutions were revised. Eurostat explained that on this basis, administrative arrangements have been signed and action plans defined.

Members reiterated the importance of having comprehensive, accurate and reliable statistics on freight and passenger rail transport as a basis for better law-making, and adequate funding of transport policy and priorities. They expressed disappointment about the attitude of some Member States not ready to provide data on rail, in particular regarding passengers' movements.

Members welcomed the efforts of the institutions to collaborate in the collection of reliable statistical data on the basis of harmonised procedures. They insisted on the fact that data should be available from a central point and be user-friendly. In this context, they recalled the importance to get statistical data on European Rail Traffic Management System and on the cross-border railway sections.
