# **Contents**

This document is the annual report to the budgetary authority on the contracts and concessions awarded by Parliament in 2017. In accordance with Article 53 of the Rules of Application (RAP) for the Financial Regulation, it also includes contracts concluded on the basis of exceptional negotiated procedures referred to in Article 134(1)(a) to (f) of the RAP.

This report relates to contracts awarded by Parliament and therefore does not cover modifications to ongoing contracts under Article 114a(3) of the Financial Regulation (raising of ceiling). Those modifications are publicised in accordance with Articles 123 and 124 of the RAP.

# I - INTRODUCTION

## A. Regulatory provisions governing reporting

1. The Financial Regulation (FR) and its Rules of Application (RAP), which came into force on 1 January 2013<sup>1</sup>, lay down the information to be provided to the budgetary authority, and to the public, concerning the award of contracts by the institution.

The rules which came into force on 1 January 2016<sup>2</sup> made it possible for Parliament to award concessions, meaning that this document also covers the concessions awarded by Parliament.

### *Degree of publicity*

2. In accordance with Articles 53 and 124 of the RAP (see Annex 1), the institution sends the budgetary authority (a) a report on the exceptional negotiated procedures launched on the basis of Articles 134(1)(a) to (f) of the RAP, and (b) a list of building contracts and of contracts declared to be secret. In addition, in accordance with the resolution accompanying the decision concerning the discharge in respect of the implementation of Parliament's budget for 2001, the Secretary-General ensures that the Committee on Budgetary Control regularly receives full information on Parliament's procurement activities<sup>3</sup>.

Meanwhile, pursuant to Article 103 of the FR and Articles 123 and 124 of the RAP (quoted in Annex 1), Parliament publishes the following on its website annually:

- (i) a **list of contractors**<sup>4</sup> in respect of contracts with a value of more than €15 000 (see point 3 below);
- (ii) **information on the value and contractors in respect of specific contracts based on a framework contract signed** during the reference year when the aggregate value of those specific contracts exceeds €15 000 (specific contracts signed in 2017). In the interests of transparency, Parliament publishes this information on interinstitutional framework contracts for the part concerning Parliament even where it is not the lead institution for these framework contracts (cf. Article 124(4) of the RAP);
- (iii) **a list of the contracts modified under Article 114a(3)(a) to (c) of the FR** where the value of the modification is over €15 000.

3. As regards ex-post publicising, transparency is ensured by publishing on the Internet the list of contractors in respect of contracts awarded with a value greater than €15 000 - see also point 4 - and by forwarding to Parliament the list of contractors to whom property contracts and contracts declared secret have been awarded (cf. Article 124(2) of the RAP), which is done by means of this report.
4. Pursuant to paragraph 35 of the Parliament's resolution of 23 April 2009<sup>5</sup> with observations on discharge in respect of the implementation of the institution's budget for 2007, and interpreting it in the light of the new Financial Regulation, a single and complete annual list of contractors awarded contracts by Parliament with a value of more than €15 000 is published on Parliament's website.
5. In addition, pursuant to paragraph 61 of Parliament's resolution of 5 May 2010<sup>6</sup> on discharge in respect of the implementation of the general budget of the European Union for the 2008 financial year, a list of economic operators awarded contracts by Parliament following a negotiated or restricted procedure is required. To meet this requirement, Parliament decided to add information about the type of procedure used (open, restricted or negotiated) to the annual list of contracts awarded, which is already published on the Internet. Consequently, the list of contracts awarded in 2017 now shows the name and address of the contractor, where the contractor is a legal person, or the NUTS code where the contractor is a natural person, and the subject of the contract, the amount, the currency and the type of procedure.
6. Lastly, in accordance with paragraphs 105 and 106 of Parliament's resolution of 29 April 2015<sup>7</sup> on discharge in respect of the implementation of the general budget of the European Union for the financial year 2013 and with paragraphs 100 and 101 of the Parliament's resolution of 27 April 2017<sup>8</sup> on discharge in respect of the implementation of the general budget of the European Union for the financial year 2015, and paragraph 126 of Parliament's resolution of 18 April 2018<sup>9</sup> on discharge in respect of the implementation of the general budget of the European Union for the financial year 2016, this report gives the number and value of contracts awarded following exceptional negotiated procedures and provides a thorough analysis of them.

## B. Methodology

7. The annual report on contracts awarded by Parliament has been drawn up by DG FINS on the basis of the information which the authorising departments in each directorate-general had entered in the WebContracts register of contracts awarded as at 6 June 2018 (the latest date for acceptance by the DG FINS Central Financial Unit, hereinafter referred to as 'the CFU', of reviews of contracts awarded in 2017 before the relevant information is sent to DG COMM for annual publication on the internet). It relates to contracts awarded in 2017 with a value greater than € 15 000<sup>10</sup>. Authorising departments are responsible for ensuring that all contracts are entered, and also for the accuracy of the information relating to them.
8. However, the CFU carries out a number of checks for consistency with regard to the data entered in the WebContracts register. Following such checks, authorising departments are notified of any corrections which they can, if they so decide, carry out and validate before the CFU proceeds with the annual publication operations.
9. The information contained in this report summarises the main characteristics of the service, supply, works and building contracts with a value greater than €15 000 awarded in 2017. The analysis is based on tables compiled from the lists of contracts awarded, which are appended as Annexes 2, 4, 5 and 6.

## II - CONTRACTS AWARDED: OVERALL SITUATION

10. The phased implementation of WebContracts (2011: requirement to enter contracts worth more than €5 000; January 2012: extension of this requirement to direct order forms; 2013 : registration of new direct and framework contracts, changes and specific order forms and specific contracts; 2014 : requirement to enter everything, resulting in a greater volume of encoding.

This confirms the need for, and usefulness of, a centralised management tool, with a view to real-time information entry and reliable reporting.

11. Minor corrections had to be made to the tables containing the figures for 2016; they mainly relate to certain contracts encoded and published in 2016. Only one 2016 contract was validated late, after the annual publication operations for 2017, in the WebContracts register of contracts awarded.

The contract concerns a DG PERS interinstitutional contract (for which the lead institution is the Commission), launched as an open procedure and relating to the setting-up of training courses to develop the general skills of staff employed by the EU institutions. The share allocated to Parliament was €541 600.

Corrections totalling €1 090 000 related to:

- An interinstitutional DG PERS contract relating to advisory services in the field of organisational development within the institutions, bodies and agencies of the European Union. That regularisation consists of an adjustment of €290 000 to the share of the amount granted to Parliament, increasing that share from €500 000 to €790 000.

- An interinstitutional DG PERS contract relating to advisory services in support of the training and development of staff employed by the institutions, bodies and agencies of the European Union. That regularisation consists of an adjustment of € 800 000 to the share of the amount granted to Parliament, increasing the EP's share for Lot 1 – experts in European and international affairs, governance and law of the Union – from €500 000 to €1 100 000, and for Lot 4 – experts in the field of professional communication – €500 000 to €700 000.
12. The data supplied show that all Parliament DGs awarded contracts with a value greater than €15 000 in 2017. The combined value of those 224 contracts was €587.07 m (€ 501.54 m in 2016). If concession contracts are excluded, the total value of contracts awarded is €579.78 m. If low-value contracts, i.e. those with a value equal to or less than €60 000, are excluded, the total figure for the other 142 contracts (128 in 2016) is €583.73 m (€497.85 m in 2016). The 49 medium-value contracts (between €60 000 and the Directive's thresholds<sup>11</sup>) totalled €11.57 m.
  13. It should be noted that, as regards interinstitutional contracts, Parliament's share is taken into account in this report in so far as it is known, even where Parliament is the lead institution, whereas on the Internet the total value of interinstitutional contracts is shown where Parliament is the lead institution.
  14. The following table indicates the total values (in €) and numbers of contracts awarded for 2016 and 2017:

15. In 2017, the total value of the contracts awarded was greater than that in the previous year (a rise of 17.05 % compared with 2016). The increase in the value of the contracts awarded is due, among other factors, to the award of a maintenance contract for all Parliament's buildings in Brussels, Luxembourg and Strasbourg for a total of EUR 179.97 million. The number of contracts awarded in 2017 was also very much unchanged from the previous year (1.83% fewer in 2016 than in 2017).
16. In total, 142 contracts with a value greater than €60 000 were awarded, and 82 with a value of between €15 000 and €60 000, in 2017. These figures show that contracts with a value less than or equal to €60 000 accounted for 36.6 % (41.8 % in 2016) of the total number of all types of contract awarded by Parliament, but for just 0.57 % (0.74 % in 2016) of the total value. In conclusion, the percentage share of low-value contracts (equal to or below €60 000) fell in terms of both number and value.

17. It should be pointed out, however, that the number and value of contracts awarded can fluctuate greatly from year to year, depending on the timing of tender procedures. The concept of ‘contracts awarded’ is not the same as budget expenditure in a year. Contracts may relate to a period longer than a year, depending on the needs of DGs.

18. It should also be pointed out that 14 contracts awarded in 2017 had a value of more than €10 m (overall value of €442.12 m). An analysis of those contracts reveals that four directorates-general awarded high-value contracts:

- **DG Innovation and Technological Support** awarded seven contracts:

) Three service contracts for maintenance and IT maintenance by third parties on all Parliament sites (€30 million – 72 months); the integration of systems (€10.75 m) and the TESTA system (Trans-European Services for Telematics between Administrations).

) four supply contracts for the purchase of IT terminal equipment (€24 million – 120 months); multifunctional apparatus with consumables and related services (Lot 1: €16.45 m – 120 months); data centre computing solutions including acquisition, leasing of servers and related services (€16.69 million – 108 months) and equipment solutions and supplies in the field of TV distribution (€14.50 million – 60 months).

Those seven contracts, totalling €123.19 m, represent nearly 21% of all contracts awarded in 2017.

- **DG Infrastructure and Logistics** awarded five contracts:

) a supply contract for the acquisition of furniture and office accessories for Parliament (€28.20 million – 60 months).

) four services contracts relating to: the running and maintenance of technical installations in buildings occupied by Parliament in Brussels, Strasbourg and Luxembourg (€179.98 million – 72 months); assistance for project supervision in the context of the renovation of the SPAAK building (€15 million – 144 months); architectural and technical services 2017-2021 for the buildings at Parliament’s various sites (€14.63 million – 48 months) and maintenance and upkeep of finishing work at Parliament’s buildings in Brussels (€13.64 million – 48 months).

The total value of those five contracts is €251.45 m, representing nearly 43% of the total for contracts awarded in 2017;

- A service contract has been awarded by **DG Communication** on the planning and purchase of advertising space for Parliament (€36 million – 60 months);

- Lastly, **DG Security and Protection** has awarded a contract for general security and external surveillance, fire safety and assistance to persons services at Parliament’s site in Luxembourg (€31.50 million – 48 months).

## **A. Types of contract awarded**

19. The breakdown by type of all contracts awarded in 2017 and 2016 in terms of number and value, including building contracts, was as follows:

As in 2016, the table for 2017 shows that, in terms of number and value, service contracts formed the largest category. They alone accounted for 79% and 76% of contracts awarded in terms of number and value respectively. In terms of number and value, supply contracts formed the second-largest category.

#### *Building contracts*

20. The year 2017 was typified by a lack of property contracts, unlike the previous year.

#### *Service contracts*

21. Service contracts accounted for the largest share of the value of contracts awarded in 2017 (76%). Thirty-two service contracts were awarded with a value equal to or greater than €1 m (as against 34 in 2016), totalling €422.37 m, or 94.6 % of the total value of such contracts. The four largest service contracts (with a value exceeding €20 m) were awarded by DG INLO, DG COMM, DG ITEC and DG SAFE (see point 17 of this report). The largest service contract was awarded by DG INLO and related to the running and maintenance of technical installations in buildings occupied by Parliament in Brussels, Luxembourg and Strasbourg (€179.98 m), as referenced in point 18 of this report.



22. In 2017, authorising officers used 58 open procedures to award service contracts totalling €402.10 m, or 90% of the total value of such contracts. The other service contracts were awarded by negotiated procedure with at least three or five candidates, or by negotiated procedure based on Articles 134 and 135 of the RAP.

### *Supply contracts*

23. Supply contracts accounted for 23% of the total value of the contracts awarded in 2017, compared with 31% in 2016. The total value of contracts (€133.86 million) is down on 2016 (-14%), although the number of contracts awarded in 2017 is much the same as in 2016. One reason for this development is the impact of the stepping-up of security measures at Parliament's sites in 2016. Lastly, the largest supply contract in terms of value was awarded by DG INLO – €28.2 m – the second-largest being a €24 m DG ITC contract (see point 18).

### *Works contracts*

24. Eleven works contracts were awarded in 2017, as against 13 in the previous year. In terms of value, however, there was a major decrease of over 93% between 2016 and 2017. Three contracts were awarded with a value greater than €1 m, representing 76% of the total value. No contract exceeded the value of €EUR 10 m in 2017, unlike in 2016 where three contracts were awarded above this threshold. No works contract was awarded for a value above the threshold set in the Directive and applicable to the works<sup>12</sup>. Of the 11 works contracts, three were awarded by open procedure, five by exceptional negotiated procedure under Article 134 of the RAP, and three under the negotiated procedure with at least 5 candidates.

## B. Procedures used

25. The breakdown of contracts awarded in 2017 and 2016 by type of procedure used, in terms of number and value, was as follows:

26. Of a total of 224 contracts awarded in 2017, 79 were based on open or restricted procedures, with a value of some €517 m, and €145 on negotiated procedures, with a total value of around €70 m.
27. Exceptional negotiated procedures launched in accordance with Article 134(1)(a) to (f) of the RAP accounted for 23 % of procedures launched in 2017. A more detailed report on the procedures is given below, beginning at point 40.
28. Use of the open procedure increased in 2017 over 2016. There was an increase of 10% in the number of contracts (78 against 71) and a 20% increase in their overall value (€ 488 m in 2017 compared with €408 m in 2016). Restricted procedures accounted for 5% of the total volume of contracts in 2017 (remaining stable in comparison with 2016) and all-in-all are used quite rarely. The value of restricted-procedure contracts therefore fell by 3% between 2016 and 2017, and there were also far fewer such contracts (1 in 2017 as against 7 in 2016).

29. It should be noted that negotiated procedures decreased slightly in terms of value as a percentage of the total value of contracts awarded, from 13% in 2016 to 12% in 2017, though in terms of volume there was an increase of almost 10% between 2016 and 2017 (€70.5 m in 2017 as against €64.28 m in 2016).
30. As regards types of procedure in 2017, the DGs made most use of the negotiated procedure, as in the previous year, followed by the open procedure and then the restricted procedure.

#### *Open invitations to tender*

31. Under the open tender procedure, any legal or natural person may submit a tender. Contracts with a value equal to or greater than the thresholds laid down by the Public Procurement Directive (2014/24/EU) are automatically subject to this type of procedure (or to a restricted procedure following publication of a notice in the OJEU). However, there is nothing to prevent awarding departments from using the open procedure for contracts whose value is below the thresholds set by the Directive. In 2017, accordingly, two contracts with a value below the thresholds set by the Directive were awarded by open procedure.
32. In 2017, Parliament awarded a total of 78 contracts (71 in 2016), with an aggregate value of €488 m (€408 m in 2016), by open procedure. As already referred to in point 17 above, the largest open procedure in 2017 was the €179.97 m contract awarded by DG INLO.

#### *Restricted invitations to tender*

33. A contract award procedure is restricted when, following the publication of a notice in the OJEU, only candidates who meet the selection criteria are invited by the contracting authorities simultaneously, and in writing, to submit a tender. In some cases, the candidates invited to submit a tender may be selected from a list drawn up following a call for expressions of interest (CEI) or after the implementation of a dynamic purchasing system. The rules provide for the use of such lists for all contracts with a value lower than the thresholds in the Directive. The number of candidates invited to submit a tender in a restricted procedure may not be less than five, provided that a sufficient number of candidates meet the selection criteria. In all cases, the number of candidates permitted to submit a tender must be sufficient to ensure genuine competition.
34. In 2017, Parliament awarded just one contract by restricted procedure (as against 7 in 2016) with publication of a notice, the aggregate value being €28.2 m, representing a 3% reduction over 2016 (€29.19 m). No restricted procedure based either on a CEI list or on a dynamic purchasing system was used in 2017.

#### *Negotiated procedures*

35. In a negotiated procedure, the contracting authorities contact the tenderers of their choice who meet the selection criteria, which have already been established and announced, and negotiate the terms and conditions of the contract with one or more of them. The number of candidates allowed to submit tenders must be sufficient to ensure genuine competition.
36. However, the use of negotiated procedures for contracts with a value higher than €15 000 and lower than the Directive's thresholds entails prior publicising on the internet so as to enable potential candidates to express their interest, which is not the

case with exceptional negotiated procedures under Article 134 of the RAP, since no prior internet publicising is required.

37. The use of a negotiated procedure without prior publicising of a contract notice is only possible in the cases set out in Article 134 of the RAP, irrespective of the value of the contract. Although in number terms the use of these procedures increased slightly (51 in 2016 compared to 52 in 2017), there was a significant increase of 185% in value terms (see Chapter III below).
38. The breakdown of contracts awarded in 2017 and 2016 by type of negotiated procedure used, in terms of number and value, was as follows:

### *Concessions*

39. Estimated amounts for concession contracts are laid down on the basis of the contractor's potential turnover during the concession period. Strictly speaking, those estimates are not expenditure. Reference is made to concession contracts in Article 135(1)(c) of the RAP, which is a provision introduced on 1 January 2016. No contract was concluded under this specific procedure in 2017. However, it should be noted that 4 concessions were awarded by open procedure by DG INLO and DG COMM. Indeed, there is no legal obstacle to a contracting authority entering into a procedure that is legally more transparent when awarding such concessions. Those 4 concessions together represent an estimated total of €7.29 m and are included in the table of procedures used (in open procedures) under point 25.

### III - REPORT ON EXCEPTIONAL NEGOTIATED PROCEDURES

40. Pursuant to the provisions of Article 53 of the RAP, authorising officers by delegation ‘record, for each financial year, contracts concluded by the negotiated procedures referred to in points (a) to (f) of Article 134(1)’. Thus building contracts (as referred to in Article 134(1)(g)) and contracts declared secret (as referred to in Article 134(1)(i)) ,which are not covered by Article 53 of the RAP, are not included in this report. No secret contracts (Annex 6) or building contracts (Annex 5) were awarded in 2017.
41. If the proportion of negotiated procedures in relation to the number of contracts awarded by the same authorising officer by delegation increases appreciably in relation to earlier years or if that proportion is distinctly higher than the average recorded for the institution, the authorising officer responsible must report this to the institution, setting out any measures taken to reverse that trend. Each institution forwards a report on negotiated procedures to the budgetary authority.
42. Paragraph 50 of the resolution on discharge in respect of the implementation of the general budget of the European Union for the 2008 financial year *‘invites the authorising officers to present to the discharge authority - for the financial year 2009 and onwards - more information allowing for a more thorough supervision of the Parliament's use of exceptional negotiated procedures (Articles 134 and 135 of the RAP) by including in their Annual Activity Report an annex providing clear information as regards:*
- *why it was necessary in the first place to conclude a contract under Article 134 or 135 of the RAP<sup>15</sup>,*
  - *why the authorising officer found a specific contract to fall under one of the established categories (‘no suitable tenders’, ‘technical or artistic reasons’, ‘urgency’, etc.) in Article 134(1) and Article 135(1),*
  - *the number of candidates with which negotiations have been carried out, and*
  - *the criteria for the acceptability of the offer;’*
- and *‘further, invites the Central Financial Unit to consolidate the information to be given in that new annex in the “Annual report on the contracts awarded by the European Parliament”.’*

In addition, in paragraphs 105 and 106 of its resolution on discharge in respect of the implementation of the general budget of the European Union for the 2013 financial year, Parliament:

- *requests that not only the total number of contracts is indicated but also the aggregate value of those contracts;*
  - *takes the view that authorising officers should offer comprehensive and transparent justifications for making use of an exceptional negotiated procedure; requests that information be compiled by the Central Financial Unit in the annual report on contracts awarded to the discharge authority;*
43. Consequently, since 2014 an annex has been attached to the annual activity reports detailing any contracts awarded using the exceptional negotiated procedure and giving the reasons why that procedure was used. In response to the resolution on discharge for

2013, the amount of the contracts awarded by exceptional negotiated procedure – by DG and aggregated – has been incorporated into the table shown in paragraph 46; a new table with explanations, giving details of exceptional negotiated procedures according to legal basis, may be found in paragraph 51, ‘Analysis by legal basis’.

44. Moreover, with a view to providing even greater assurance to the political authorities as to the regularity of the use of this type of procedure, and to increase transparency, the Secretary-General asked the DGs to apply the following measures as from January 2011:

- an annex to the award decision to be systematically drafted by the authorising officer responsible in which he/she must state the reasons for making use of an exceptional negotiated procedure (type of contract, exceptional circumstances prompting use of such a procedure, very tight deadlines, decisions taken at institution level, etc.);
- an opinion to be systematically requested from the Public Procurement Forum on all contracts worth more than €135 000<sup>16</sup> as regards making use of an exceptional negotiated procedure under Article 53 of the RAP. The opinion, which is not binding, is to be annexed to the authorising officer’s award decision. This measure entered into force for all exceptional negotiated procedures launched in 2011 and subsequently.

45. This report deals with two subjects:

- (i) The variations between 2016 and 2017 in all contracts with a value greater than €15 000 concluded by negotiated procedure in accordance with Article 134(1)(a) to (f) of the RAP. This part consolidates the information communicated by the directorates-general in their annual activity reports regarding that procedure. A check has been performed for consistency with the information previously entered in the WebContracts register of contracts awarded.
- (ii) Points 56 to 61 cover the observations arising from the establishment of the system of referrals to the Public Procurement Forum required by the Secretary-General (see also point 44 above).

**(i) Trends in contracts subject to the exceptional negotiated procedure**

46. The table below shows the trend, by DG and for the institution as a whole, in the use of negotiated procedures in terms of the number of contracts awarded and the aggregate value of the contracts awarded by exceptional negotiated procedure as referred to by Article 53 of the RAP.

47. Annex 4 lists in detail the contracts awarded by exceptional negotiated procedure in 2017, together with the relevant legal basis given by the authorising officers for using that procedure.

48. The number of exceptional negotiated procedures rose in 2017 over 2016, with the total value of the contracts concerned falling substantially (from €10 m in 2016 to €47 m in 2017).

49. Four directorates-general did not use this type of procedure in 2017 (as opposed to seven in 2016), three awarded fewer such contracts than in the previous year, five awarded more, and two awarded the same number.

50. The authorising officers by delegation who used an exceptional negotiated procedure one or more times justified that use in their annual activity reports as follows:

- DG IPOL: One exceptional negotiated procedure was used by this DG, concerning the leasing of offices and equipment during the COP 23 under Article 134(1)(b) of the RAP.
- DG EXPO: One exceptional negotiated procedure was used by this DG, concerning logistics and security services in the context of an electoral observation mission to Kosovo.
- DG COMM: Article 134(1)(b) of the RAP was invoked for two procedures relating to protection of intellectual property and to monopoly situations.
- DG INLO: Article 134(1)(a) was invoked after an initial invitation to tender was declared unsuccessful. The authorising officer by delegation justified five exceptional negotiated procedures on the basis of contracts being awarded to the only economic operators able to perform the contracts in question (Article 134(1)(b)). Two cases of extreme urgency were invoked (Article 134(1)(c) of the RAP) in connection with work relating to natural crises (storms and hail). Finally, one procedure was launched under Article 134(1)(e) for cleaning services for buildings recently occupied by Parliament.
- DG TRAD : The DG took part in one exceptional and interinstitutional procedure under Article 134(1)(b), for which the Commission was the lead institution, concerning maintenance services for SDL Studio translation software.
- DG ITEC: The authorising officer by delegation justified three exceptional negotiated procedures on the basis of contracts being awarded to the only economic operators able to perform the contracts in question (Article 134(1)(b)). Another, relating to IT consultancy, was based on Article 134(1)(e) for a contract that could only be awarded to a specific economic operator.
- DG EPRS: The 17 exceptional negotiated procedures used by this DG were based on Article 134(1)(b) of the RAP. They concerned subscriptions to on-line databases or press agencies.
- DG INTE : One exceptional negotiated procedure was used by this DG in connection with technical equipment for audio-visual services under Article 134(1)(b) of the RAP. A second exceptional negotiated procedure concerned catering services. The successful contractor had a monopoly on this service within a public sector organisation in the Belgian region in which the DG organised a political group event.
- DG SAFE: Two exceptional negotiated procedures were launched by this DG under Article 134(1)(b) of the RAP. One of the procedures related to the protection of the contractor's intellectual property in respect of clocking-in machines, while the other related to support services for the selection and training of DG SAFE staff. A third procedure was based on Article 134(1)(e) for fire safety, assistance to persons and external surveillance services.
- EMAS unit : The authorising officer by delegation justified one exceptional negotiated procedure on the basis of contracts being awarded to the only economic operators able to perform the contracts in question (Article 134(1)(b)).



## Analysis by legal basis

51. The table below shows all the exceptional negotiated procedures launched in 2017, broken down by Parliament DG and legal basis, for contracts with a value of more than €15 000. It is followed by an analysis of the most frequent cases, supplementing the analysis by DG.

52. This table shows that 87% of exceptional negotiated procedures take Article 134(1)(b) of the RAP as their legal basis, referring to the use of a single economic operator for technical or artistic reasons, or for reasons connected with the protection of exclusive rights.
53. Exceptional negotiated procedures under Article 134(1)(a) relate to cases where, following an open or restricted procedure, no tenders or no suitable tenders are received by the authorising officer. This was the case for the procedure launched concerning the provision of handling staff in Luxembourg.
54. Exceptional negotiated procedures as referred to in Article 134(1)(b) mainly concern cases of exclusive rights: monopoly situations linked to the press, rights of reproduction (copyright) or IT licences.
55. Exceptional negotiated procedures under Article 134(1)(c) relate to cases of extreme urgency for reasons not attributable to the contracting authority (e.g. damage caused by natural events, such as measures to prevent technical installations during icy periods or work to mitigate the impact of bad weather in late 2017).

Exceptional negotiated procedures under Article 134(1)(e) relate to additional services which cannot be hived off from a basic project. These services are generally of a technical nature (lifts, goods lifts) and are the result of Parliament moving into new buildings, e.g. the HEH (House of European History) buildings, the WIM (Wilfried Martens building) and the BMT (Belmont Court), which came into service in 2017 and 2018. Cleaning and ancillary

services had to be provided for these buildings. It was therefore necessary to extend such services to the new premises.

**(ii) Procedure for referrals to the Public Procurement Forum - sixth year of application**

56. Since 1 January 2011, any DG wishing to launch a negotiated procedure as referred to in Article 53 of the RAP, where the value of the contract is estimated at more than €60 000<sup>19</sup>, has had to obtain an opinion from the Public Procurement Forum (PPF) in advance. See also point 44 of this report.
57. In 2017, the PPF was consulted 10 times. Of the 10 requests for the launching of a procedure submitted to the PPF, an unfavourable opinion was delivered on three. It should be pointed out that the opinion of the PPF is not binding and that it must be attached to the authorising officer's award decision. Moreover, should the opinion be departed from in any way, reasons must be given by the authorising officer responsible and included in the list of exceptions in his/her directorate-general's annual activity report.
58. The table below shows the breakdown, by DG, of referrals to the PPF and the opinions delivered:

59. As the opinions of the PPF are not binding, a contract was awarded in 2017 in one of the three cases in which it delivered an unfavourable opinion.
60. Of the seven favourable opinions, five resulted in procedures being launched; the contracts awarded are listed in Annex 4. Two procedures will be launched in 2018.
61. In conclusion, the PPF referral procedure helped to make procedures more transparent and to harmonise interpretation of the provisions concerned. The WebContracts application made it possible to monitor procedures carefully.

## **Annex 1: Regulatory provisions governing the advertising of contracts and information for the budgetary authority**

Financial Regulation and Rules of Application (entry into force since 1<sup>st</sup> January 2016)

*Article 103 of the Financial Regulation*

### **Publicity measures**

1. For procedures with a value equal to or greater than the thresholds referred to in Article 118(1) or Article 190, the contracting authority shall publish in the *Official Journal of the European Union*:
  - (a) a contract notice to launch a procedure, except in the case of the procedure referred to in point (d) of Article 104(1);
  - (b) a contract award notice on the results of the procedure.
2. Procedures with a value below the thresholds referred to in Article 118(1) or Article 190 shall be advertised by appropriate means.
3. Publication of certain information on a contract award may be withheld where its release would impede law enforcement, or otherwise be contrary to the public interest, would harm the legitimate commercial interests of economic operators or might prejudice fair competition between them.
4. The Commission shall be empowered to adopt delegated acts in accordance with Article 210 concerning detailed rules on the requirements for the advertising of procedures by reference to their value in comparison to the thresholds referred to in Article 118(1), on advertising which the contracting authority may undertake with full respect for the principle of non-discrimination, and on the content and publication of notices.’.

\*\*\*\*\*

*Article 123 of the Rules of Application*

### **Advertising of procedures equal to or greater than the thresholds under Article 118(1) of the Financial Regulation or for contracts falling within the scope of Directive 2014/24/EU**

1. The notices for publication in the *Official Journal of the European Union* shall include all the information set out in the relevant standard forms referred to in Directive 2014/24/EU to ensure transparency of the procedure.
2. The contracting authority may make known its intentions of planned procurement for the financial year through the publication of a prior information notice. It shall cover a period equal to or less than 12 months from the date on which the notice is sent to the Publications Office.

The contracting authority may publish the prior information notice either in the *Official Journal of the European Union* or on its buyer profile. In the latter case, a notice of publication on the buyer profile shall be published in the *Official Journal of the European Union*.

3. The contract notice shall be used as a means of launching a procedure with an estimated value equal to or greater than the thresholds laid down in Article 118(1) of the Financial Regulation, except for the procedure set out in Article 134 of this Regulation.
4. The contracting authority shall send to the Publications Office an award notice on the results of the procedure no later than 30 days after the signature of a contract or framework contract with a value equal to or greater than the thresholds laid down in Article 118(1) of the Financial Regulation.

However, notices relating to contracts based on a dynamic purchasing system may be grouped together on a quarterly basis. In such cases, the contracting authority shall send the notice no later than 30 days after the end of each quarter.

Award notices shall not be published for specific contracts based on a framework contract.

5. The contracting authority shall publish an award notice:

- (a) before signing a contract or a framework contract with a value equal to or greater than the thresholds laid down in Article 118(1) of the Financial Regulation and awarded pursuant to the procedure under Article 134(1)(b) of this Regulation;
  - (b) after signing a contract or a framework contract with a value equal to or greater than the thresholds laid down in Article 118(1) of the Financial Regulation including awarded pursuant to the procedures under points (a) and (c) to (f) of Article 134(1) of this Regulation.
6. The contracting authority shall publish in the *Official Journal of the European Union* a notice of modification of contract during its duration in the cases set out in points (a) and (b) of Article 114a(3) of the Financial Regulation where the value of the modification is equal or greater than the thresholds defined in Article 118(1) of the Financial Regulation.
  7. In case of interinstitutional procedure, the contracting authority responsible for the procedure shall be in charge of the applicable publicity measures.

\*\*\*\*\*

#### *Article 124 of the Rules of Application*

#### **Advertising of procedures falling below the thresholds under Article 118(1) of the Financial Regulation or falling outside the scope of Directive 2014/24/EU**

1. Procedures with an estimated contract value below the thresholds laid down in Article 118(1) of the Financial Regulation shall be advertised by appropriate means. Such advertising shall involve appropriate *ex ante* publicity on the internet or a contract notice or, for contracts awarded in accordance with the procedure set out in Article 136 of this Regulation, the publication of a notice for a call for expressions of interest in the *Official Journal of the European Union*. This obligation shall not apply to the procedure set out in Article 134 of this Regulation and the negotiated procedure for very low value contracts under Article 137(2) of this Regulation.
2. For contracts awarded in accordance with points (g) and (i) of Article 134 of this Regulation, the contracting authority shall send a list of contracts no later than 30 June of the following financial year, to the European Parliament and Council. In the case of the Commission, it shall be annexed to the summary of the annual activity reports referred to in Article 66(9) of the Financial Regulation.
3. Contract award information shall contain the name of the contractor, the amount awarded and the subject matter of the contract and, in the case of direct and specific contracts, it shall comply with Article 21(3).

The contracting authority shall publish a list of contracts on its internet site no later than 30 June of the following financial year for:

- (a) contracts below the thresholds laid down in Article 118(1) of the Financial Regulation;
- (b) contracts awarded in accordance with points (h) and (j) to (m) of Article 134 of this Regulation;
- (c) modifications of contracts as set out in point (c) of Article 114a(3) of the Financial Regulation;
- (d) modifications of contracts as set out in points (a) and (b) of Article 114a(3) of the Financial Regulation where the value of the modification is below the thresholds laid down in Article 118(1) of the Financial Regulation;
- (e) specific contracts under a framework contract.

For the purposes of point (e) of the second subparagraph the published information may be aggregated per contractor for the same subject matter.

4. In case of interinstitutional framework contracts, each contracting authority shall be responsible for advertising its specific contracts and their modifications under the conditions set in paragraph 3.

\*\*\*\*\*

**Report on negotiated procedures**

Authorising officers by delegation shall record, for each financial year, contracts concluded by the negotiated procedures referred to in points (a) to (f) of Article 134(1) and Article 266 of this Regulation. If the proportion of negotiated procedures in relation to the number of contracts awarded by the same authorising officer by delegation increases appreciably in relation to earlier years or if that proportion is distinctly higher than the average recorded for the institution, the authorising officer responsible shall report to the institution setting out any measures taken to reverse that trend. Each institution shall send a report on negotiated procedures to the European Parliament and Council. In the case of the Commission, that report shall be annexed to the summary of the annual activity reports referred to in Article 66(9) of the Financial Regulation.’;

### **Annex 3: Regulatory provision governing exceptional negotiated procedures**

#### **Rules of Application (entry into force since 1<sup>st</sup> January 2016)**

#### **(Article 134 of the Rules of Application of the Financial Regulation)**

##### **Article 134**

##### ***Use of a negotiated procedure without prior publication of a contract notice***

##### ***(Article 104(5) of the Financial Regulation)***

1. When the contracting authority uses the negotiated procedure without prior publication of a contract notice, it shall follow the arrangements on negotiation set out in Article 104(4) of the Financial Regulation and in Article 128(5) of this Regulation.

The contracting authority may use the negotiated procedure regardless of the estimated value of the contract, in the following cases:

- (a) where no tenders, or no suitable tender, or no request to participate or no suitable request to participate as provided for in paragraph 2 have been submitted in response to an open procedure or restricted procedure after this procedure has been completed, provided that the original procurement documents are not substantially altered;
- (b) where the works, supplies or services can only be provided by a single economic operator under the conditions set out in paragraph 3 and for any of the following reasons:
  - (i) the aim of the procurement is the creation or acquisition of a unique work of art or artistic performance;
  - (ii) competition is absent for technical reasons;
  - (iii) the protection of exclusive rights including intellectual property rights must be ensured;
- (c) in so far as is strictly necessary where, for reasons of extreme urgency brought about by unforeseeable events, it is impossible to comply with the time limits laid down in Articles 152, 154 and 275 and where the justification of such extreme urgency is not attributable to the contracting authority;
- (d) where a service contract follows a design contest and is to be awarded to the winner or to one of the winners; in the latter case, all winners must be invited to participate in the negotiations;
- (e) for new services or works consisting in the repetition of similar services or works entrusted to the economic operator to which the same contracting authority awarded an original contract, provided that these services or works are in conformity with a basic project for which the original contract was awarded after publication of a contract notice, subject to the conditions set out in paragraph 4;
- (f) for supply contracts:
  - (i) for additional deliveries which are intended either as a partial replacement of supplies or installations or as the extension of existing supplies or installations, where a change of supplier would oblige the contracting authority to acquire supplies having different technical characteristics which would result in incompatibility or disproportionate technical difficulties in operation and maintenance; when the institutions award contracts on their own account, the duration of such contracts may not exceed three years;
  - (ii) where the products are manufactured purely for the purpose of research, experimentation, study or development; however such contracts shall not include quantity production to establish commercial viability or to recover research and development costs;
  - (iii) for supplies quoted and purchased on a commodity market;

- (iv) for purchases of supplies on particularly advantageous terms, from either an economic operator which is definitively winding up its business activities, or the liquidators in an insolvency procedure, an arrangement with creditors, or a similar procedure under national law;
  - (g) for building contracts, after prospecting the local market;
  - (h) for contracts for any of the following:
    - (i) legal representation by a lawyer within the meaning of Article 1 of Council Directive 77/249/EEC in arbitration or conciliation or judicial proceedings;
    - (ii) legal advice given in the preparation of the proceedings referred to above or where there is tangible indication and high probability that the matter to which the advice relates will become the subject of such proceedings, provided that the advice is given by a lawyer within the meaning of Article 1 of Directive 77/249/EEC;
    - (iii) for arbitration and conciliation services;
    - (iv) document certification and authentication services which must be provided by notaries;
  - (i) for contracts declared to be secret or for contracts whose performance must be accompanied by special security measures, in accordance with the administrative provisions in force or when the protection of the essential interests of the Union so requires, provided the essential interests concerned cannot be guaranteed by other measures; these measures may consist of requirements to protect the confidential nature of information which the contracting authority makes available in the procurement procedure;
  - (j) for financial services in connection with the issue, sale, purchase or transfer of securities or other financial instruments within the meaning of Directive 2004/39/EC of the European Parliament and of the Council, central bank services and operations conducted with the European Financial Stability Facility and the European Stability Mechanism;
  - (k) loans, whether or not in connection with the issue, sale, purchase or transfer of securities or other financial instruments;
  - (l) for the purchase of public communication networks and electronic communications services within the meaning of Directive 2002/21/EC of the European Parliament and of the Council;
  - (m) services provided by an international organisation where it cannot participate in competitive procedures according to its statute or act of establishment.
2. A tender shall be considered unsuitable where it does not relate to the subject matter of the contract and a request to participate shall be considered unsuitable where the economic operator is in an exclusion situation under Article 106(1) of the Financial Regulation or does not meet the selection criteria.
  3. The exceptions set out in points (ii) and (iii) of point (b) of paragraph 1 shall only apply when no reasonable alternative or substitute exists and the absence of competition is not the result of an artificial narrowing down of the parameters when defining the procurement.
  4. In the cases referred to in point (e) of paragraph 1, the basic project shall indicate the extent of possible new services or works and the conditions under which they will be awarded. As soon as the basic project is put up for tender, the possible use of the negotiated procedure shall be disclosed, and the total estimated amount for the subsequent services or works shall be taken into consideration in applying the thresholds referred to in Article 118(1) of the Financial Regulation or in Articles 265(1)(a), 267(1)(a) or 269(1)(a) of this Regulation in the field of external actions. When the institutions award contracts on their own account, that procedure may only be used during the performance of the original contract and at the latest during the three years following its signature.
