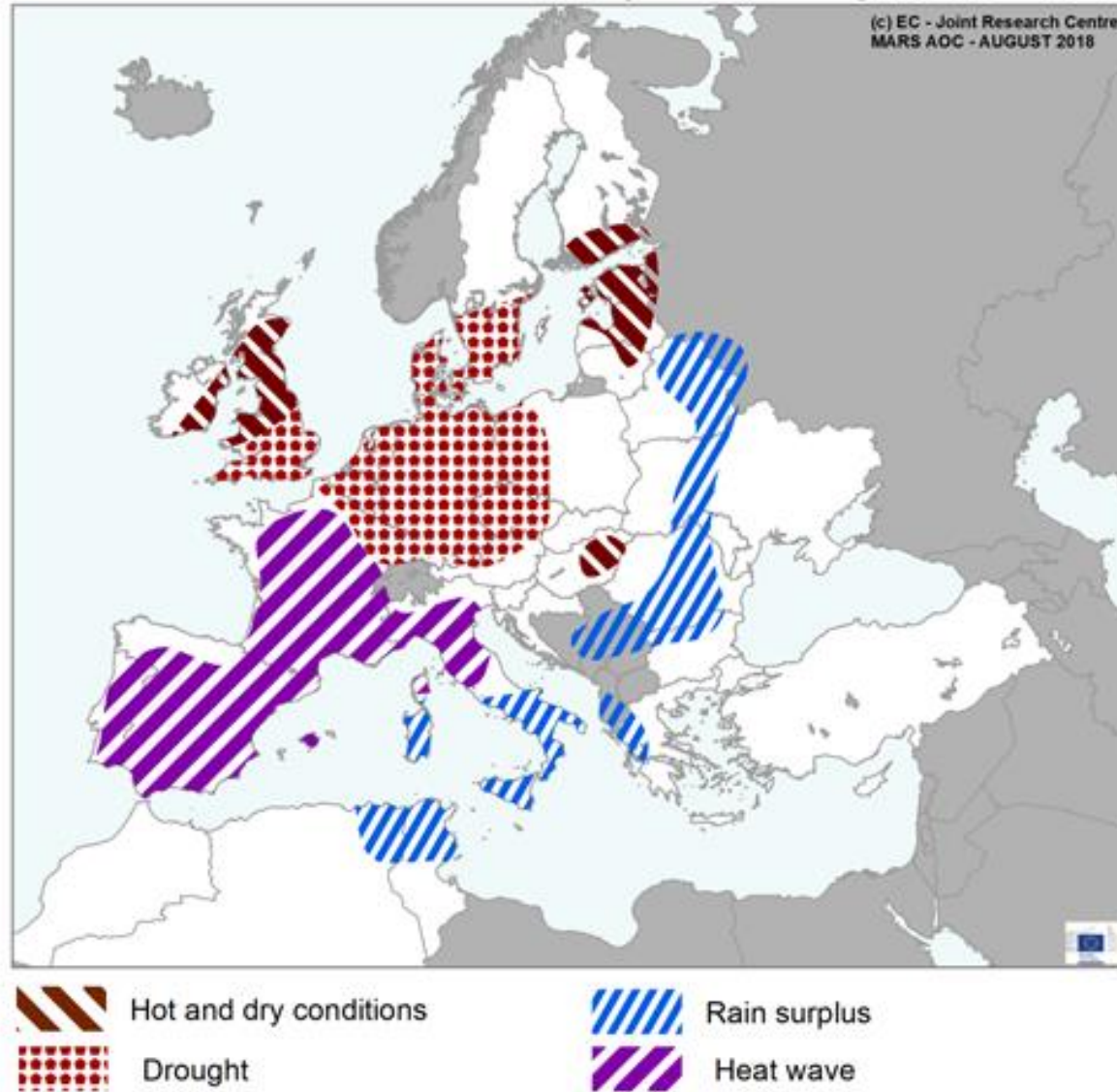

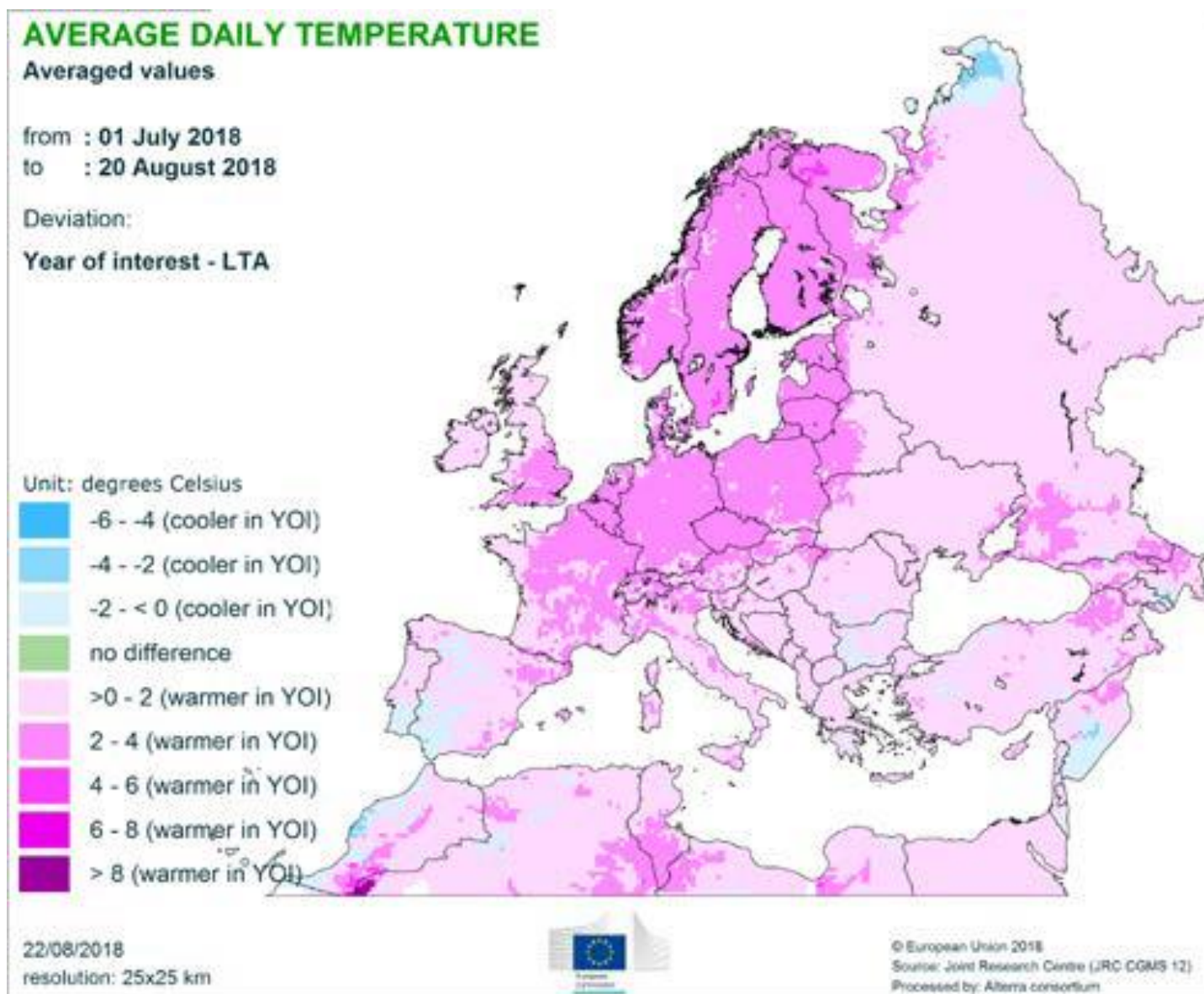
WEATHER SITUATION

NUMBER OF DAYS WITH SIGNIFICANT RAINFALL

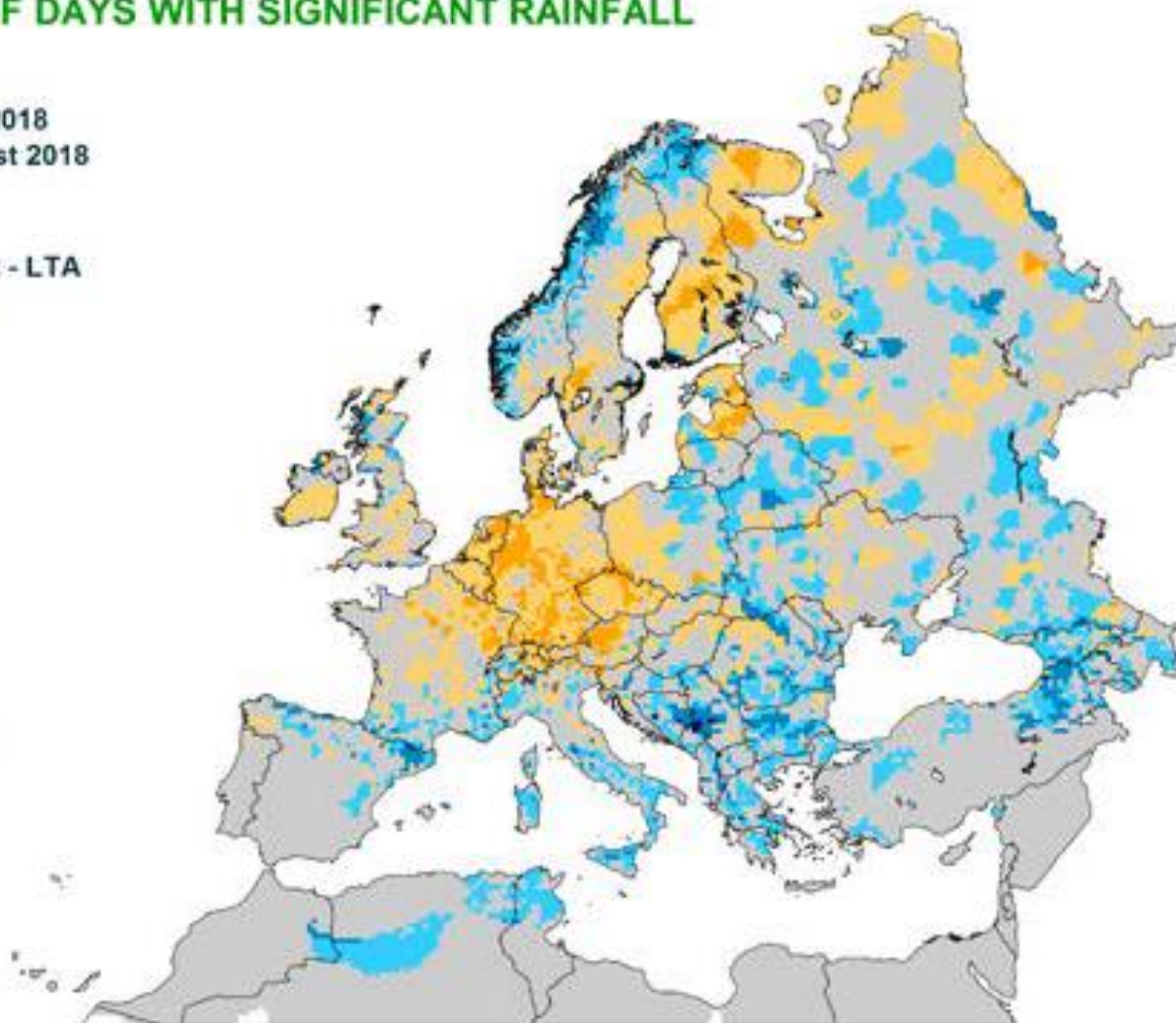
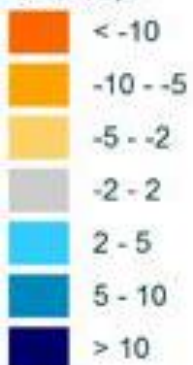

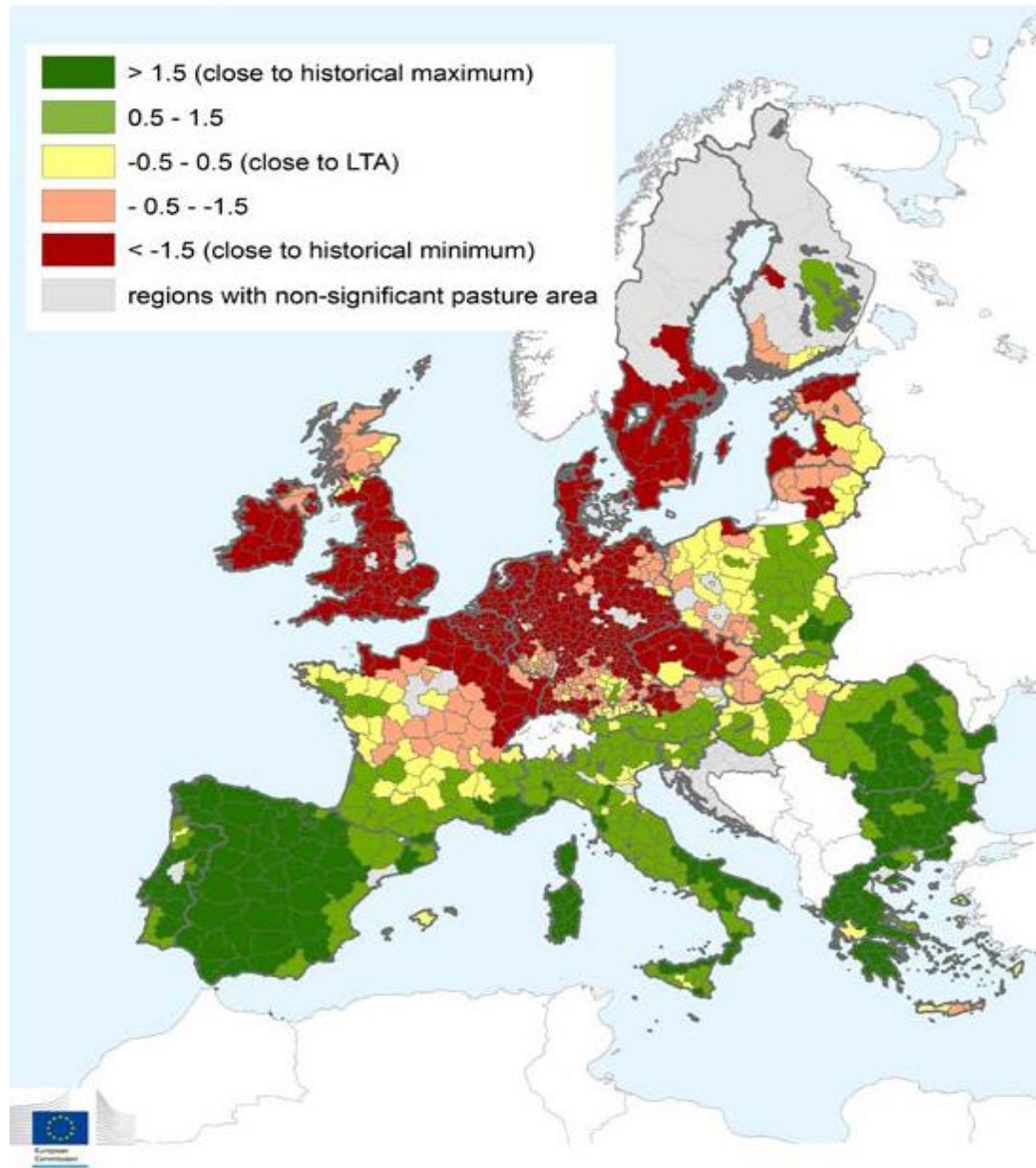

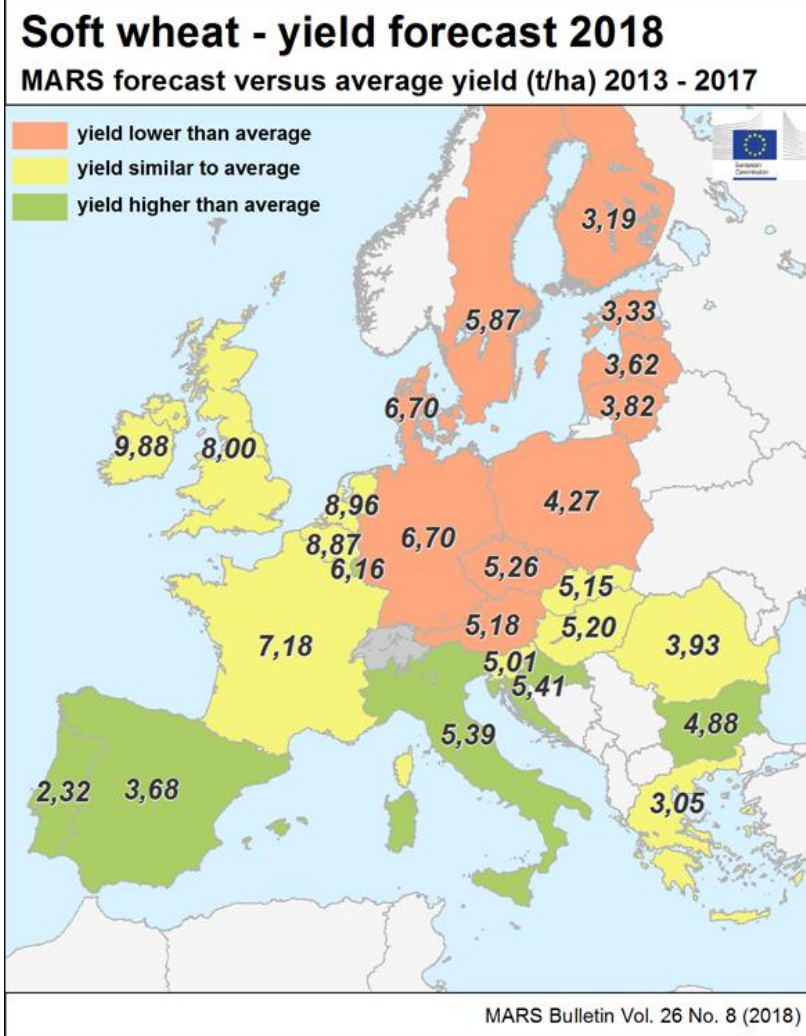

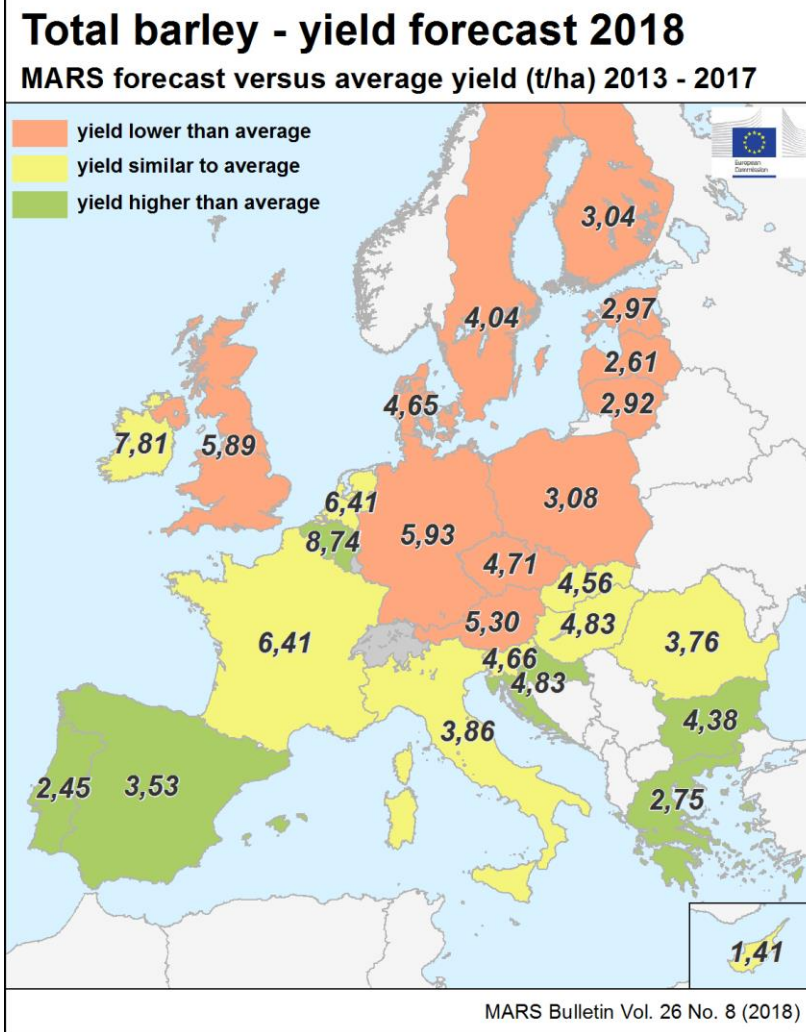

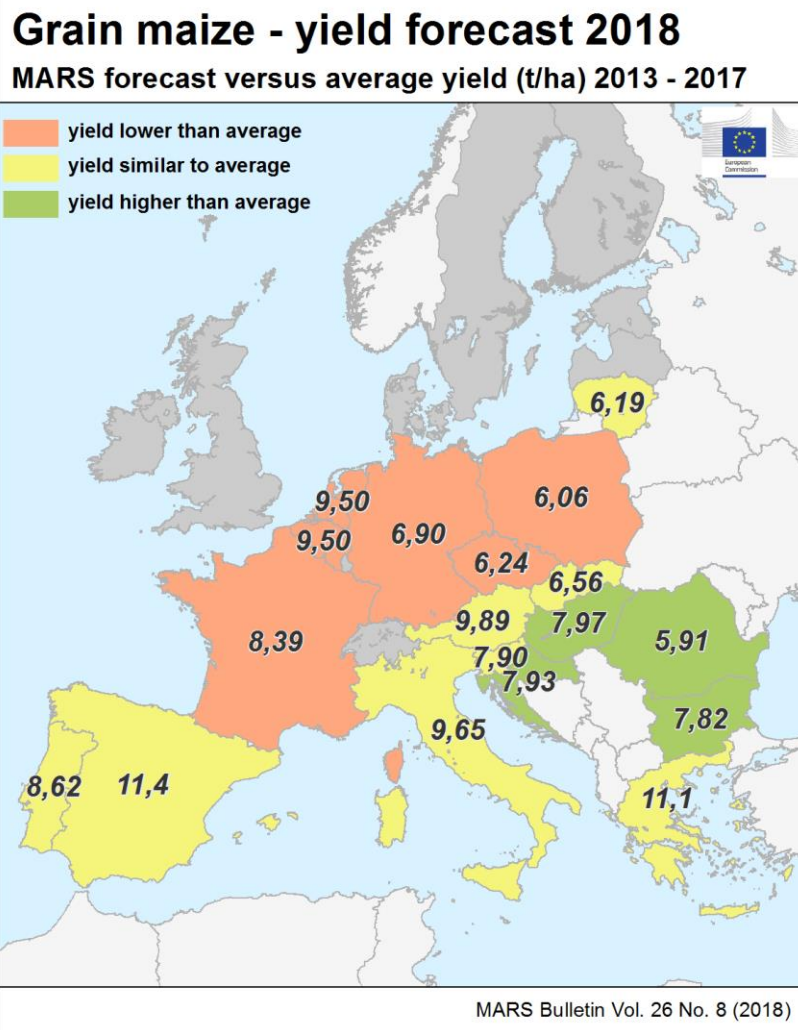
IMPACT ON CROPS

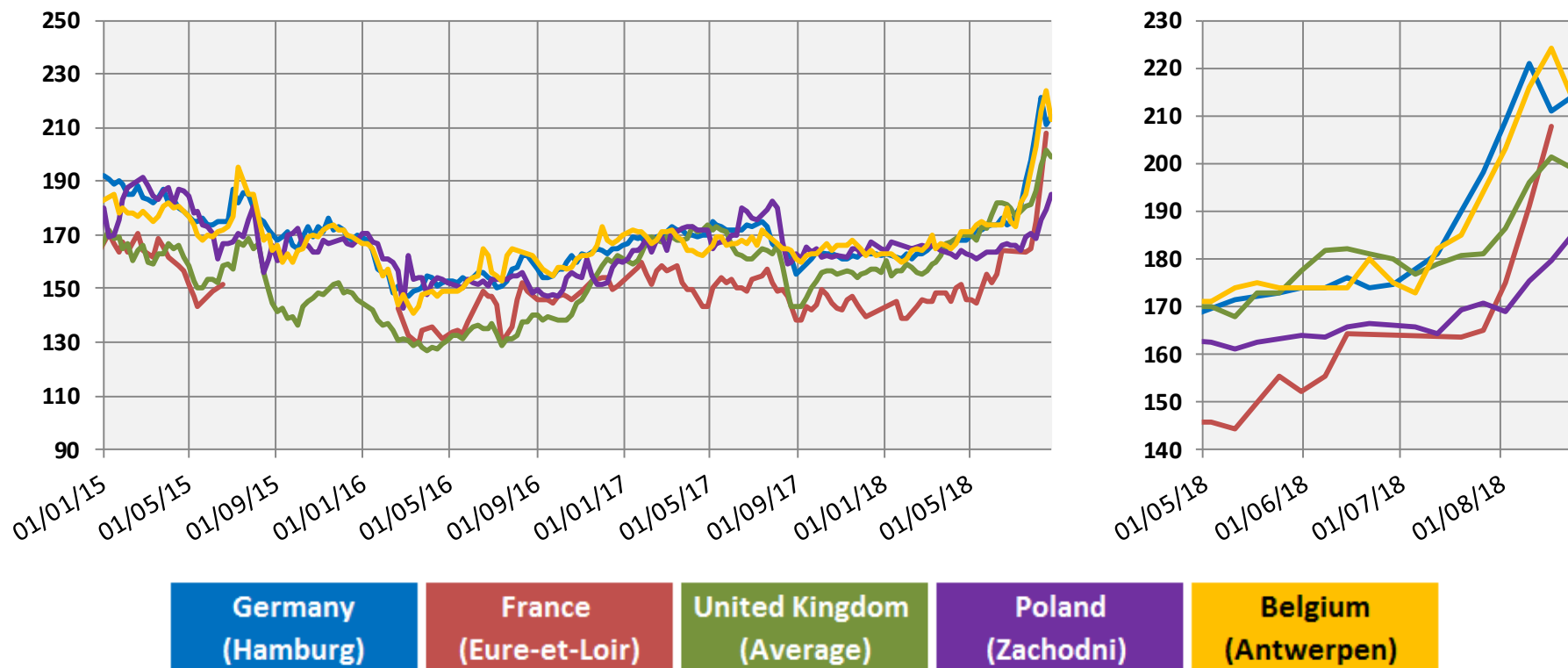

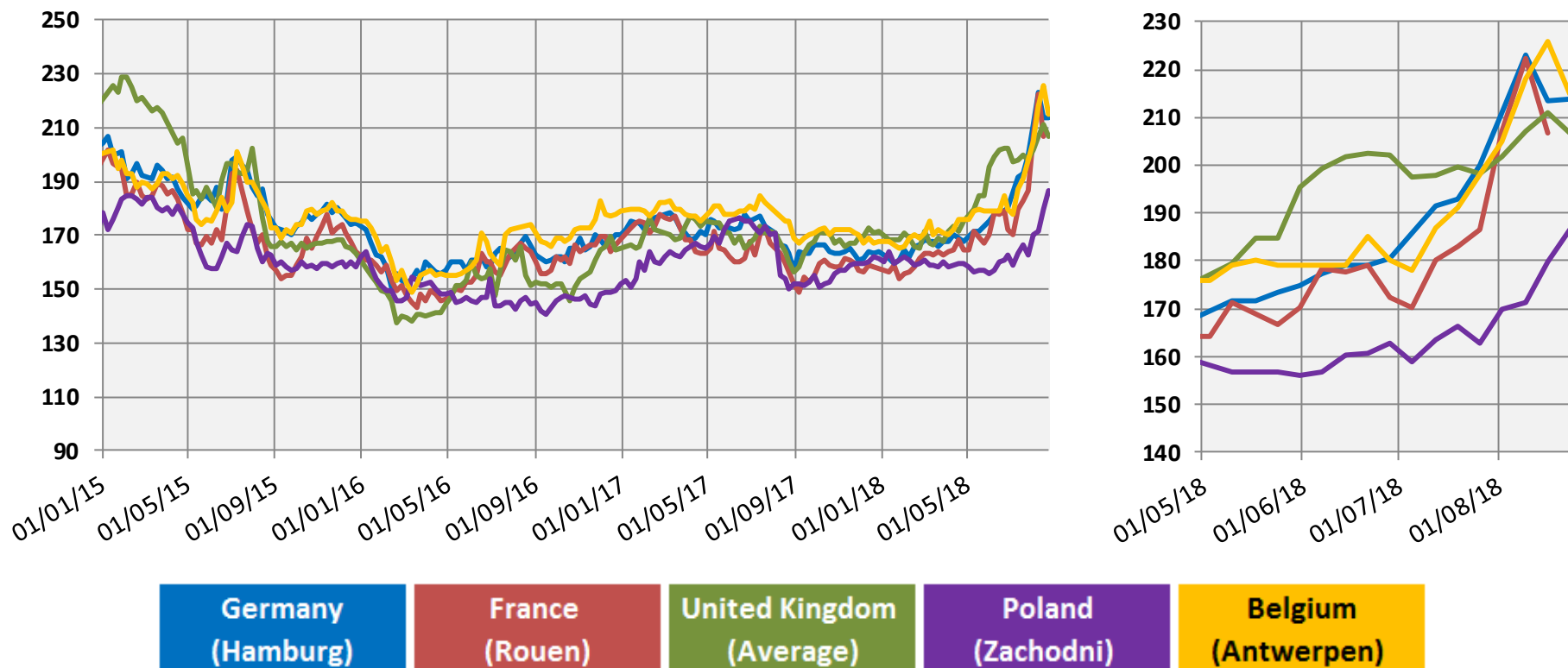
EU Market prices for feed wheat (€/tonne)

COMMISSION AND MEMBER STATE RESPONSE

- Commission **acted swiftly**:
 - remind MS of **support options already available** (RD, greening flexibility) 
 - **derogation to greening rules** to allow fodder production on land lying fallow 
 - initiate work on **further derogations** (to allow **higher and earlier advance payments** and further **greening** derogations) 

COMMISSION AND MEMBER STATE RESPONSE options available



- **State aid:**
 - up to 80% of the damage caused by drought (e.g. purchase of fodder can qualify)
 - compensation for damage can also be granted without the need to notify the Commission (the so-called "de minimis aid" - up to €15 000 per farmer over three years)

COMMISSION AND MEMBER STATE RESPONSE options available



- **Rural development:**
 - up to 100% for **restoration of agricultural production potential** (e.g. re-seeding pastures)
 - possibility to recognise **exceptional circumstances** (release from commitments with no penalty)
 - **risk management** instruments (mutual funds or income stabilisation tool)
 - **RDP modification**

COMMISSION AND MEMBER STATE RESPONSE – derogations & interpretation

- **Greening:**
 - 14/08: adoption of decision allowing EFA fallow land to be harvested/ grazed
 - 30/08: discussion with MS of second decision (1) allowing fodder production on EFA catch crop area and (2) adaptation of period to allow sowing of winter crop
 - Force majeure: interpretation to ease use in MS to avoid administrative burden
 - Possibility to cut/ graze EFA with catch crops: interpretation

COMMISSION AND MEMBER STATE RESPONSES derogations



- **Advances:**
 - 30/08: discussion with MS
 - Increase max advance to 70% of direct payments and 85% of rural development support
 - October instead of December
 - **Higher and Earlier**

COMMISSION AND MEMBER STATE RESPONSE – requests from MS

- **Advances:**
 - Belgium, Czech Republic, Ireland, Italy, Greece, France, Latvia, Lithuania, Luxembourg, Hungary, Croatia, Poland, Portugal (Azores), Romania, Finland, Sweden, United Kingdom (Northern Ireland)
- **Greening (1&2nd Decision):**
 - Belgium, Estonia, Denmark, Ireland, Germany, Finland, France, Latvia, Lithuania, Netherlands, Poland, Portugal, Finland, Sweden

COMMISSION AND MEMBER STATE RESPONSE – requests & announcements by MS

- **Greening/other environmental obligations – force majeure:**
e.g. France
- **State aid:**
e.g. Germany, Ireland, Poland, Sweden
