Before AFCO meeting, a joint committee meeting AFCO/PETI will take place, during which Jo Leinen (AFCO) and Yana Toom (PETI) will report on Ombudsman's strategic inquiry OI/2/2017 on the transparency of legislative discussions in the preparatory bodies of the Council of the EU.

The Co-rapporteurs will present their Draft report endorsing the European Ombudsman's recommendations requesting Council to take all measures necessary to implement for:

- systematically record the identity of Member State governments when they express positions in Council preparatory bodies;
- developping clear and publicly available criteria for how it designates documents as 'LIMITE' and
- reviewing the 'LIMITE' status of documents at an early including informal negotiations in trilogues.
