Transparency and sustainability of the EU risk assessment in the food chain



Members will vote on the draft opinion to the ENVI Committee report on the proposal "transparency and sustainable of the eurisk assessment in the food chain", otherwise known as the "General Food Law". 226 amendments have been tabled and the Rapporteur Ms Karin Kadenbach (S&D, AT) has negotiated 13 compromise amendments.

Horizon Europe – the Framework Programme for Research and Innovation (Regulation)



Members will vote on the draft opinion to the ITRE Committee report on the proposal for a regulation establishing the 9th EU Framework Programme for Research and Innovation, called "Horizon Europe". 64 amendments have been tabled and the rapporteur Ms Elsi Katainen (ALDE, FI) has negotiated 5 compromise amendments.

implementing Horizon Europe – the Framework Programme for Research and Innovation (Decision)



Members will also vote on the draft opinion to the ITRE Committee report on the proposal for a decision implementing the 9th EU Framework Programme for Research and Innovation, called "Horizon Europe". 224 amendments have been tabled and the rapporteur Ms Elsi Katainen (ALDE, FI) has negotiated 15 compromise amendments.

Apportionment of tariff rate quotas included in the WTO schedule of the Union following Brexit



Members will finally vote on the opinion on the apportionment of Tariff Rate Quotas in the WTO after the withdrawal of the UK from the EU, for which INTA is the lead committee. 23 amendments were tabled, out which the rapporteur Mr Carthy (GUE, IE) has negotiated 4 compromise amendments.
