The European Parliament Special Committee on Financial Crimes, Tax Evasion and Tax Avoidance (TAX3) is organising a parliamentary hearing on “Golden visas and other national schemes providing tax privileges (free ports, special economic zones)” for **Monday, 15 October 2018, from 3 pm to 6.30 pm, in room JAN 6Q2.**

The hearing will be structured in two panels. The first panel will be devoted to discuss risks and vulnerabilities in the area of money laundering linked to residence by investment schemes. The second panel, at which your participation will be much welcomed, will focus on free ports and special economic zones. The Members will be particularly interested in learning about actions taken by the Freeport Luxembourg to prevent risks of money laundering and tax evasion. Please find enclosed herewith a draft programme of the hearing.

The session will start with a short introduction by each of the invited speakers, which should not exceed 5 minutes. The introductory remarks will be followed by an exchange of views with Members of the TAX3 Committee, during which time speakers will be invited to respond to observations made and questions posed to them. Questions will be asked in slots of four minutes: each question will be put within one minute at maximum, with the remaining time devoted to the answer. If time allows, the Member will have the possibility to ask a follow-up question, without extending the overall four-minute slot.


I would be grateful if you could let us know about your interest and availability to participate at your earliest convenience and **preferably no later than Tuesday, 25 September 2018.**
