COMPROMISE AMENDMENTS ERDF OPINION

COMP 1 Recital 9 and recital 9 (new), (Am. 22, 21, 20, 23, 1, 24, 26, 27)

In order to support the efforts of Member States and regions in facing new challenges and ensuring a high level of security for their citizens as well as *inclusiveness for all citizens*, *involving a* prevention *policy to avoid marginalisation or* radicalisation, while relying on the synergies and complementarities with other Union policies, *such as culture, education, youth and sport, in particular with the Creative Europe (also through the seal of excellence), Erasmus and European Solidarity Corps* investments under the ERDF should *facilitate access to quality education, culture and grassroots sport by helping the authorities to upgrade their infrastructures and* contribute to security in areas where there is a need to ensure safe and secure public spaces and critical infrastructure, such as transport and energy, *as well as to the sustainability of cohesive societies, ensuring open cultural and public spaces*;

COMP 2 Article 2 – paragraph 1 – point d – point ii (Am. 56, 57, 58, 59, 60, 61, 62, 63)

improving access to inclusive and quality services in *formal, non-formal and informal* education, *early childhood care*, training and lifelong learning, *culture and sport* through developing infrastructure *and quality education and training programmes, including MOOCs and blended learning*;

<u>COMP 3.</u> Article 2 – paragraph 1 – point d – point iii (Am. 66, 67, 68, 69, 74, 75, 72, 73)

increasing the socioeconomic integration of marginalised communities, the unemployed, young people not in education, employment or training (NEETs) and low-skilled, migrants and disadvantaged groups, through integrated measures including housing and social services, cultural and sport activities, local education, culture and sport infrastructure and lifelong learning;

COMP 4 Article 2 – paragraph 1 – point e – point i (Am. 85, 78, 5, 80, 79, 81, 84)
