Petitions on forest management in Poland and non-compliance with EU environmental law

At its meeting of 21 November, the Petitions Committee examined two petitions on the state of forests in Poland. Petition 0805/2017 was submitted by seven Polish NGOs, alleging noncompliance with EU environmental law on forest management. Petition 0812/2017, submitted by Spanish citizens, concerned the Białowieża forest, one of Europe's last remaining primeval forests and natural habitats for bison.

The Commission informed the Committee it had sent to the Polish authorities a letter of formal notice under Article 258 TFEU concerning the improper transposition of the Birds and Habitats Directives with regard to forest management activities, and that it is currently assessing their reply. As regards the Białowieża forest, the Commission confirmed that, following a ruling of the Court of Justice of the European Union, the Polish authorities have committed to comply fully with the judgment and that the only activities currently carried out in the forest are those aimed at ensuring public safety and which have not been called into question in the judgment.

In view of the updates provided by the Commission and pending further assessment of the replies of the Polish authorities, the Committee decided to keep the petitions open and to send a letter to the Polish government, outlining its concerns over forest conservation and long-term compliance with the CJEU judgment. The Committee also decided to send the Oral Question of the PETI and ENVI Committees on Natura 2000 violations, and inform that the Oral Question will be followed by an upcoming Plenary debate.

Exchange of views with the European Ombudsman - European Commission Secretary-General Appointment

As the Committee in charge of the relations with the European Ombudsman, PETI cochaired a joint exchange of views with CONT and JURI with Ms. O'Reilly concerning her recommendations in joint cases 488/2018/KR and 514/2018/KR on the



European Commission's appointment of a new Secretary-General. In her remarks, the Ombudsman explained the reasoning of her decision, and confirmed that her office had found four instances of maladministration by the Commission in the appointment of Mr. Selmayr. The exchange of views was followed by a debate with Members from all three Committees. Joint PETI-JURI interparliamentary meeting

On 27 November, PETI and JURI held an Interparliamentary Committee Meeting, cooperation with the European Network of Ombudsmen. The programme focused on the empowerment of parliaments and the enforcement of citizens' rights in the



implementation and application of EU law. Panels also explored the role of complaints to Ombudsmen and petitions to parliaments as instruments to detect breaches of EU law.



Presentation of the update of the Study "Fit for purpose? The Facilitation Directive and the criminalisation of humanitarian assistance to irregular migrants"

The Committee heard a presentation by two experts, Ms. Lina Vosyliūtė from the Centre for European Policy Studies and Ms. Jennifer Allsopp from the Migration London International Development Centre on the Facilitation Directive. Due to a number of petitions received on the

criminalisation of humanitarian assistance provided to migrants by EU citizens, the Committee decided to request an update on the 2016 study initially commissioned by the LIBE Committee. The full study can be found via the following link:
