Mission to the Isle of Man**

Dear Ms Gray and Mr Moore

As you may be aware, on 22 March 2018, the European Parliament set up a Special Committee on Financial Crimes, Tax Evasion and Tax Avoidance (TAX3) based on a one-year mandate. The TAX3 Committee will mainly examine issues related to the fight against tax evasion, tax avoidance and money laundering.

In the framework of its work, a delegation of TAX3 committee will be travelling on a mission to the Isle of Man from 22 to 23 of November 2018. The delegation will consist, in principle, of eight high-ranking Members of the European Parliament, chaired by myself as the Chair of TAX3 Committee.

During its mission to the Isle of Man, the Delegation would like to engage with the tax and anti-money laundering authorities and members of the Tynwald of the Isle of Man. The Delegation will also engage with private sector representatives on topical issues relating to the fight against money laundering, tax avoidance and evasion and the transparency of beneficial ownership. Members of the European Parliament have indicated their deep interest in meeting representatives of the Law Society of the Isle of Man. Due to organizational reasons, suggested time for the meeting would be on **Friday 23 November** from **12:30** to **14:00 (TBC)** at **Mannin Hotel**.

Please be informed that we have also sent an invitation to representatives of the Board of the Isle of Man Society of Chartered Accountants and the Isle of Man Society of Trust and Estate Practitioners' (STEP) to attend this meeting.
