## **Highlights**

Establishing rules on support for strategic plans to be drawn up by Member States under the Common agricultural policy (CAP Strategic Plans)



Members will hold an exchange of views on the amendments to the Strategic Plans Regulation for which Ms Herranz García (EPP, ES) has been appointed as Rapporteur. In total 5253 AMs were tabled. 11 technical meetings and 3 shadows' meetings have taken place. Currently 40 articles and annexes have been the subject of compromise proposals at technical level, of which 20 articles and annexes have already been discussed by the shadow rapporteurs. A further 28 technical meetings and 3 shadows meetings are foreseen in the coming weeks.

# Financing, management and monitoring of the common agricultural policy (Horizontal Regulation)



Members will hold an exchange of views on the amendments to the Horizontal Regulation for which Ms Ulrike Müller (ALDE, DE) has been appointed as Rapporteur. In total 863 amendments were tabled. 4 technical meetings and 2 shadows' meetings have taken place. At present, 23 compromise amendments are being discussed which cover circa 50% of the amendments tabled. A further 4 technical meetings and 3 shadows' meetings are foreseen.

### Common organisation of the markets (CMO)/Amending Regulation



Members will hold an exchange of views on the amendments to the CMO Amending Regulation for which Mr Eric Andrieu (FR, S&D) has been appointed as Rapporteur. The report of Mr Andrieu consists of 109 amendments with an additional 687 amendments tabled by Members. 4 technical meetings and 3 shadows' meetings have taken place. More than half of the expected compromise amendments have been discussed at technical level. A further 6 technical meetings and 4 shadows' meetings are foreseen.
