3.1 Resolution on the long-term strategy for GHG emissions reduction

The Chair informed about the state of play with ITRE, AGRI and TRAN.

3.2 State of play on Brexit

The Chair informed that two meetings were held on Brexit recently: a CCC meeting with the Brexit negotiator, Mr Barnier, on 10 January and a workshop on preparedness and contingency plans in case of "No deal" held by the Commission SG.

In both occasions the Chair raised the issue of possible shortage of medecines.

As regards contingency legislation, ENVI is concerned by one Delegated Act on the ETS Union Registry. The deadline expired on Friday, and no objections were received.

For what concerns the EP consent, the procedure is currently on hold as the situation is very unclear and the referral of the withdrawal agreement to AFCO will take place in the January II part-session.

3.3 Temporary replacement of VP Sefcovic

The Chair informed that during VP Sefcovic unpaid electoral leave to take part in the elections in Slovakia, the Energy Union portfolio was transferred to Commissioner Arias Canete.

7.4 Case-law of interest for the ENVI Committee

• Judgement of 22 November 2018 in Case C-151/17, Swedish Match AB v Secretary of State for Health

The file included an information note from the EP Legal Service on the judgment of the Court of Justice on a request for preliminary ruling on the validity of the prohibition of placing on the market of tobacco products for oral use, contained in the Tobacco Products Directive 2014 (Directive 2014/40/EU). The Court of Justice upheld the validity of the prohibition by relying on the objective of ensuring a high level of protection of human health (as already done in cases C-434/02, *Arnold Andre'* and C-210/03, *Swedish Match*).

7.5 Documents recently published by the European Court of Auditors

<u>Special report</u> on "Combating desertification in the EU: a growing threat in need of more action" (No 33/2018)

Thirteen EU Member States have self-declared under the United Nations Convention to Combat Desertification that they are affected by desertification. Projections of climate change in Europe show that the risk of desertification is increasing. In 2015, the EU and Member States committed to strive to achieve land degradation neutrality in the EU by 2030. The Court found that, while desertification and land degradation are current and growing threats in the EU, the Commission does not have a clear picture of the challenges, and the steps taken to combat desertification have limited coherence.

<u>Special report</u> on "Floods Directive: progress in assessing risks, while planning and implementation need to improve" (No 25/2018)

The consequences of fluvial, pluvial and coastal floods in Europe will overall worsen as a result of local and regional increases in the intensity and frequency of flooding. The Court found that Directive 2007/60/EC led to progress in assessing the risks of floods, but that the planning and implementation of flood protection should be improved. The Court also warns that major challenges remain in the much fuller integration of climate change, flood insurance and spatial planning into flood risk management, and is critical of weaknesses in allocating funding.

•

Landscape Review "Towards a successful transport sector in the EU: challenges to be addressed"

The report explains that the EU had made progress in infrastructure development and the opening of the internal transport market, but that it needs to address six key challenges on the road towards improved mobility within the Union: matching objectives and priorities with resources, better planning, infrastructure maintenance, effective enforcement, shifting goods traffic off roads and ensuring EU added value. The review also provides an overview of and key facts on the transport sector in the EU, investment needs and availability of funds, as well as the state of play for the five main transport modes: road, rail, air, inland waterways and maritime.

<u>Summary of results</u> from the ECA's 2017 annual audit of the European research Joint Undertakings (F4E (ITER) – Development of Fusion Energy; BBI – Bio-Based Industries; Clean Sky – Clean Air Transport Technologies; IMI – Innovative Medicines Initiative; FCH – Fuel Cells and Hydrogen; SESAR – Single European Sky Air Traffic Management Research; ECSEL – Electronic components and Systems; S2R - Shift2Rail Innovative Rail Product Solutions).

The Court's audit for 2017 confirmed the positive results reported in previous years, but highlights some matters requiring further attention and indicates areas for improvement, related to budgetary and financial management, internal controls, leverage of industry and research partners' contributions, as well as the European Commission's evaluations.

<u>Special report</u> "Animal welfare in the EU: closing the gap between ambitious goals and practical implementation" (No 31/2018)

This report examines how the welfare of farm animals is checked, and the overall implementation of the EU animal welfare strategy. The Court concludes that EU action is successful in some areas, but that there are still weaknesses in compliance with minimum standards. There is room to improve coordination with cross-compliance checks, and better use could be made of the CAP to promote higher animal welfare standards.
