



Update on the REGI work on legislative MFF reports and opinions

The past eight months have been busy in the REGI committee, because the European Commission published its legislative proposals for the next Multiannual Financial Framework (MFF) for 2021-2027 in May and June last year, and REGI is in charge of several files. The Commission presented the proposals at a Committee meeting in June, and the designated rapporteurs started working on their files straight away.

The three legislative reports for which REGI is the lead committee - Common Provisions Regulation (CPR), European Regional Development Fund and Cohesion Fund (ERDF and CF) and Interreg - have all now gone through the committee phase, and CPR and Interreg already have negotiation mandates from the plenary. The next step after the mandate will be the interinstitutional trilogue negotiations.

In addition to its own MFF files, the REGI committee has had several legislative MFF opinions. These have all been voted in Committee. Some, including Horizon Europe, ESF+, LIFE, EGF, Connecting Europe Facility (CEF), TEN-T, Maritime and Fisheries Fund, InvestEU, Rule of Law and Reform Support Programme, were already voted last year to fit the schedules of the lead committees.

Several opinions have been put to the vote this year - three opinions that REGI prepared for the AGRI committee, the European Solidarity Corps and IPA III.

Northern Ireland continuation of PEACE Programme - next steps

The Brexit Withdrawal Treaty provides for the continuation of the European cross-border cohesion programmes between Ireland and Northern Ireland. However, it is unclear whether the United Kingdom will ratify the Withdrawal Treaty. The withdrawal of the United Kingdom, without such an agreement, would cause particular hardship in Northern Ireland and the border areas of Ireland, as their status under the Good Friday Agreement, which guarantees peace, is dependent on both parts of the island being in the European Union with open borders.

The Commission therefore submitted a proposal establishing a derogation to allow the continuation of the PEACE IV and United Kingdom-Ireland cooperation programmes, at least until the end of the current 2014-2020 programming period, of those two programmes, even if the Withdrawal Treaty is not approved.

The proposal does this by providing that funding to Northern Ireland continues as provided for in the INTERREG Regulation. Furthermore, the standard rule, which provides that no more than 20% of a cooperation programme's budget

may be spent outside the EU, will not apply to these two programmes as spending in Northern Ireland would otherwise be restricted.

The Committee on Regional Development carried out a mission to Northern Ireland in March 2018, and followed this up with an implementation report: one of the key conclusions was that the PEACE IV Programme should be maintained after Brexit, whatever the context. In order to allow the funding to continue, it is essential that the legislation is adopted and enters into force before 30 March.

The Committee on Regional Development approved the Commission proposal without amendment on 22 January 2019, under the simplified procedure (Rule 50(1) of the Rules of Procedure). The regulation is due to be adopted by the plenary during the March I part-session.

Vote on Common Provisions Regulation 2021-2027 - next steps

On 22 January, the Committee on Regional Development voted on the proposal for the new Common Provisions Regulation for the 2021-2027 period. In total, 2181 amendments were tabled to the proposal in the REGI committee, as well as opinions by the AGRI, BUDG, CONT, ECON, EMPL, ENVI, FEMM, LIBE and TRAN committees.

The Committee held an extensive debate on the proposal and on the amendments tabled thereto. The co-rapporteurs, Andrey Novakov and Constanze Krehl, and the shadow rapporteurs also held consultations on compromise text, leading to cross-party agreement on large parts of the proposal, including most of the major provisions.

The final report resulting from the vote contains 412 amendments. It forms the basis of a mandate for interinstitutional negotiations, as adopted by the plenary on 13 February. The first trilogue takes place on 19 February.

Exchange of views with the Romanian Presidency of the Council, Minister Plumb

On Tuesday, 22 January 2019, the REGI committee held an exchange of views with Ms Rovana Plumb, Minister of European Funds of Romania. You can watch the recording of the discussion here.

Ms Plumb spoke about the priorities of the Romanian Presidency, with a focus on the policies that are part of the REGI committee agenda. Ms Plumb stressed the importance of the future of the Cohesion Policy, and mentioned that the presidency takes places during an an important period, as the European Parliament elections will be held in May.

There were many questions on the timetable for the MFF related files and the trilogues. Ms Plumb said that on CPR file the Council had received mandates to negotiate on a couple of blocks, and the Council is ready to start the trilogues on them as soon as possible. She said also that they will follow the path of the Austrian Presidency, taking advantage of the steps already achieved, with the aim of having a strong basis post-2020 on Cohesion Policy.

Ms Plumb also mentioned that Romania wants to have a citizen-oriented approach to every legislative and non-legislative file. In this way, they aim to build a stronger and more democratic Union.

Exchange of views with Commissioner Corina Cretu

During the REGI meeting on 22 January, the REGI committee held an exchange of views with Commissioner Corina Creţu. You can watch the recording of the discussion <u>here</u>, starting at 16:35.

The Commissioner congratulated the rapporteurs of the CPR file and the whole committee for producing a high-quality report in record time. She also thanked the committee for supporting the guiding principles that the EC used when drafting the legislation - modernisation, flexibility and simplification, and for supporting the good level of funding for the policy.

Talking about timing for the MFF files, the Commissioner stressed that "now is the time to push forward". She said that to avoid delays with projects, it would be essential to adopt the regulations this year.

Vote on European Regional Development Fund and Cohesion Fund - next steps

On 14 February, REGI held the vote on the European Regional and Development Fund and on the Cohesion Fund for the 2021-2027 period. In total, 1146 amendments were tabled to the proposal in the REGI committee and by the BUDG, CONT, ENVI, TRAN, AGRI, CULT and LIBE committees.

The Committee held a debate on the proposal and on the amendments tabled thereto. The rapporteur, Mr Cozzolino, and the shadow rapporteurs have also held numerous consultations on compromise texts, leading to agreements on large parts of the proposal.

The report adopted in the form of amendments to the Commission's proposal will now be tabled for vote in plenary.

Vote on Amendment to the Common Provisions Regulation – pre-financing for 2021-2023- next steps

On 7 September, the Commission submitted a proposal to amend the current Common Provisions Regulation (CPR) for 2014-2020. This amendment concerns pre-financing rates for the years 2021-2023, under the 2014-2020 programmes. Funding under the CPR for 2021-2027 is not affected.

The Commission proposes reducing the annual pre-financing rate for the years 2021-2023 from 3% of the amount of the support from the Funds to 1%, in view of the cash-flow requirements for programme implementation. The reduction of the pre-financing rate takes into account the expected increasing number of interim payment claims, the addition of the performance reserve to the basis for the calculation of pre-financing, and the new pre-financing available under the 2021-2027 programming period.

The rapporteur for this proposal is Mirosław Piotrowski. At the meeting on 14 February, he presented his draft report, which approves the Commission proposal but suggests that the pre-financing rate for 2021-2023 should be set at an intermediate rate of 2%. A debate took place, with the deadline for amendments planned for 21 February. The vote on the proposal is scheduled for 21 March.

Products eligible for exemption from or a reduction in dock dues

In 2014, the Council adopted a Decision to extend the special regime for exemption or reduction to the 'dock dues' tax applicable to a number of products produced in the French outermost regions until the end of 2020. The aim of these

tax arrangements is to make local businesses competitive again by compensating part of the extra production costs entailed by local production in the French outermost regions.

On 13 December 2018, the Commission submitted to the Council, a report analysing the economic and social impact of the dock dues arrangements as well as a proposal for modifying the provisions of the Decision. The purpose of this proposal is to adapt the list of products eligible for a tax differential to reflect the latest changes in the local economies since the adoption of the Decision.

This proposal has been referred to REGI in the Parliament and is being considered under the consultation procedure: the Council is not obliged to take account of the Parliament's position, but it can act only after the EP has been consulted. On 17 January, REGI coordinators decided to apply the simplified proposal without amendment (Rule 50(1)) to this Commission proposal, with the Chair as rapporteur. Under this procedure, the Chair proposes in her draft report - to be considered by REGI during its meeting on 20 February - that this legislative proposal be adopted without amendment. Unless one-tenth of the Members of the Committee oppose this, the Chair will then present a report to plenary approving the proposal.

Study: "Digital agenda and cohesion policy"

Upon request of REGI, Policy Department B commissioned a study on "Digital agenda and cohesion policy". This study provides a critical analysis of the contribution of Cohesion Policy and the European Structural Investment Funds to the Digital Agenda for Europe and the Digital Single Market.

Based on the analysis of past and current patterns of ESIF digital investments and selected case studies, this study shows that Cohesion Policy should concentrate where its added value is highest, i.e., on support to the formulation of effective regional digital strategies and on the promotion of partnerships between relevant stakeholders, at regional level and beyond.

The research paper was completed in 2018 and was published and circulated to REGI Members last year. It will be presented on 20 February, by the lead researcher, Ms Julie Pellegrin, CSIL Centre for Industrial Studies (Milano, Italy).
