NOTICE TO MEMBERS

By Decision of 6 July 1988 and in accordance with the Resolution adopted by the European Parliament on 13 December 1985, the Enlarged Bureau of the Parliament (the Enlarged Bureau was the predecessor of the Conference of Presidents), instituted the 'Sakharov Prize for Freedom of Thought'.

At its meeting of 14 June 2006, the Conference of Presidents adopted a revised Statute for this prize.

The prize is awarded annually, for particular achievement in one of the following fields:

- the defence of human rights and fundamental freedoms, particularly the right to free expression,
- the safeguarding of the rights of minorities,
- the respect for international law,
- the development of democracy and implementation of the rule of law.

Nominations must obtain the support of at least 40 Members of the European Parliament or that of a political group. Individual Members may only support one candidate. Nominations must be signed and include supporting evidence.

STATUTE OF THE SAKHAROV PRIZE FOR FREEDOM OF THOUGHT

DECISION OF THE CONFERENCE OF PRESIDENTS

OF 15 MAY 2003 ¹

The Conference of Presidents,

- having regard to Parliament's resolution of 13 December 1985 instituting the Sakharov Prize for freedom of thought,
- having regard to the proposal from the Committee on Foreign Affairs, Human Rights,
 Common Security and Defence Policy,
- having regard to Rule 25(4) of the Rules of Procedure²,

HAS DECIDED

Article 1

Parliament shall annually award the Sakharov Prize for freedom of thought.

Article 2

The prize shall be awarded for a particular achievement in one of the following fields:

- defence of human rights and fundamental freedoms, particularly the right to free expression,
- safeguarding the rights of minorities,
- respect for international law,
- development of democracy and implementation of the rule of law.

'Achievement' shall mean any intellectual or artistic composition or active work in the above fields.

Article 3

The prize shall be 50 000 €

Parliament reserves the right to publish any work for which the prize is awarded.

Article 4

The prize may be awarded to natural persons or to associations or organisations, irrespective of whether they have legal personality.

The nationality, place of residence or seat of the candidates shall be immaterial.

Article 5

If a written work is submitted in support of an application, it must be in one of the official languages of the European Union.

An achievement within the meaning of Article 2 must be substantiated and verifiable.

Article 6

Nominations must secure the support of at least 40 ³ Members, or a political group, of Parliament. Individual Members may support only one nominee. Each proposal must be signed and include supporting evidence.

Article 7

Nominations which meet the formal criteria set out above shall be assessed in a joint meeting of the Committee on Foreign Affairs and the Committee on Development. Following that assessment, the two committees shall proceed jointly to an indicative vote producing a list of three candidates, in alphabetical order, from which the Conference of Presidents shall select one winner.

Article 8

The President of Parliament shall present the prize at a ceremony during a plenary session of Parliament.

Article 9

The procedures for the award of the prize shall be governed by internal implementing provisions to be laid down by the Committee on Foreign Affairs. Those provisions shall be communicated to any candidate at his or her request.

Article 10

The decision on the prize-winner shall be final and may not be challenged in the courts.
