Exchange of views

The Co-Rapporteurs on own resources, Mr Dehaene and Ms Jensen, have received informally the Council's position on the 3 remaining Own Resources files:

- Draft Council Decision on the system of own resources of the European Union COM(2011) 739 final
- Draft Council Regulation laying down implementing measures for the system of own resources of the European Union COM(2011) 740 final
- Draft Council Regulation on the methods and procedure for making available the traditional, VAT and GNI-based own resources and on the measures to meet cash requirements (Recast) -COM(2011) 742 final

The three dossiers are being checked by the lawyers-linguists but changes to the substance are not expected. The formal referral is scheduled for week 7.

The applicable procedures in the Parliament are as follows:

- Consultation on the ORD and on the Making-available Regulation
- Consent on the implementing measures regulation

The Council drafts are aligned with the conclusions of the European Council of 7 and 8 February 2013.

The main modifications compared to the existing own resources decision are:

- Change of the own resources ceiling for payment appropriations to 1,23% (as compared to 1,24% until now), and for commitment appropriations to 1,29% (as compared to 1,31% until now);
- Change of the percentage of collection costs Member States retain from traditional own resources to 20% (as compared to 25% until now);
- Because the proposal to reform the VAT did not hold in the Council, the provisions remain as in the current ORD;
- The UK rebate is maintained, as well as the rebates on the rebate for Austria, Germany, the Netherlands and Sweden and the reduced VATrates of call for DE, NL and SE; In addition NL, SE and DK will have lump-sum rebates for the duration of the next MFF, while AT will have one only for the first three years (until 2016).

The Implementing Regulation contains provisions of a general nature applicable to all types of own resources and which require appropriate parliamentary oversight. Article 311 (4) TFEU gives for the first time the possibility to adopt a Council regulation laying down implementing measures for the system of own resources of the European Union, after obtaining the consent of the European Parliament.

The proposal for draft Council Regulation on the methods and procedures for making available the traditional and GNI-based own resources and the measures to meet cash requirements is a recast of existing legislation in order to ensure that cash requirements are met under the new structure of own resources. The relevant legal basis for this regulation is laid down in Article 322 (2) of the TFEU.

9. Financial rules applicable to the general budget of the Union

• Exchange of views

In the framework of the last negotiations on the Financial Regulation, the European Parliament, the Council and the Commission agreed to revise the Financial Regulation in order to take into account the outcome of the negotiations on the multiannual financial framework (MFF) for the years 2014-2020.

Accordingly, Commission presented a legislative proposal adjusting some provisions of the Financial Regulation following the political agreement on - and subsequent adoption of - the MFF and CEF Regulations. It modifies Article 13 of the Financial Regulation in order to include the carry-over rules for the Emergency Aid Reserve and for projects financed under the Connecting Europe Facility.

Members will vote on the Rapporteur's draft report which includes, in addition, an amendment taking into account the outcome of negotiations on the Common Provisions Regulation on Structural and Investment Funds, in relation to the performance reserve and the financial instruments in favour of SMEs. No amendments were tabled to the Rapporteur's draft report.

The adopted report will constitute the mandate for Parliament's negotiators, and Members will also vote on the decision to enter into negotiations and on the negotiating team.

The draft calendar was defined with a view to be able to start negotiations as early as possible and allow any possible first reading agreement to be adopted by Parliament still under this term.

The EU negotiates with the Republic of Seychelles in view of renewing the Protocol to their Fisheries Partnership Agreement. The main aim of the Protocol to the Agreement is to provide fishing opportunities for European Union vessels in the waters of the Republic of Seychelles. The new Protocol covers a period of six years (2014-2019) and provides for a total financial contribution of EUR 30 700 000 for the whole period.
