Here you will find the topics which will be discussed at the next REGI committee meeting on 22 and 23 April 2013. The following items will be discussed as foreseen in the draft agenda. Please note that most committee documents (working documents, draft reports, etc.) are available at our website REGI.

1. Public Hearing on 'Smart specialisation - lessons learnt, prospects for the future' (Point 3 of the draft agenda)

Smart Specialisation is a strategic approach of the European Union to economic development through targeted support to Research and Innovation (R&I). It will be the basis for Structural Fund investments in R&I as the Smart Specialisation Strategy is one of the ex-ante conditionalities for Cohesion policy 2014-2020. Smart Specialisation involves a process of developing a vision, identifying competitive advantage, setting strategic priorities and making use of smart policies to maximise the knowledge-based development potential of any region, strong or weak, high-tech or low-tech. This public hearing should look at present developments in this field and should elaborate on the prospects for the future in the framework of the new legislation.

2. Effects of budgetary constraints for regional and local authorities regarding the EU's Structural Funds expenditure in the Member States (Point 4 of the draft agenda)

In the context of the ongoing financial and economic crisis sub-national (regional and local) authorities are increasingly faced with challenging conundrum as regarding their capacity to secure productive investment. On the one hand, they witness a sharp decrease in their revenues, as central governments cut transfers and ask regional and local governments to contribute towards austerity, while on the other they have to secure increasingly demanding social services, as result of the crisis, putting an extra pressure on their public purses.

The interest of this report in this particular context would be to analyse to what extent the current crisis has impacted on the capacity of sub-national authorities to pursue the objectives of growth and jobs contained in the Europe 2020 strategy and to suggest ways to improve financing capacity of these entities towards productive investment.

Given the ongoing negotiations on the future Cohesion policy, on the MFF and in more general terms the debate on the future Economic and Monetary Union, it is of utmost political importance for the European Parliament to analyse and recommend viable options for regional and local authorities to regain capacity to invest in smart, sustainable and inclusive growth.

3. Regional policy as a part of wider State support schemes (Point 5 of the draft agenda)

Along with the package on the Common provisions regulations 2014 - 2020, the European Union is modernising State aid rules, and in particular the regional aid guidelines, so that this type of aid plays an effective role and is concentrated on the most disadvantaged regions of European Union.

The Rapporteur, Mr. Vlasak, will submit a draft own initiative report, considering that that cohesion policy objectives have been widely discussed with public and within the Parliament, and some major priorities have been set. However, some of the proposed modifications of the Regional Aid rules raise questions on their compatibility and synergies with cohesion policy objectives. The flexibility of the system, in light of rapid and dramatic economic disruption, is called to question, and the redefinition of the aid schemes should be cautious and also discussed with a view to Cohesion Policy, so that they do not create more cross-regional disparities.

4. Promoting the European cultural and creative sectors as sources of economic growth and jobs (Point 6 of the draft agenda)

The Commission's position on Cultural and Creative Sectors (CCS), illustrated in its Communication (COM 2012 537 final), stresses the importance of such sectors within the Europe 2020 strategy, highlighting both their advantages and limits. The CCS are characterised by high fragmentation, making up for a need to overcome the current limits through the following measures: better access to credit, new regulatory framework for the Intellectual Property Rights, and a medium/long run strategy to take into account the existing investment plans for these sectors. The Commission's communication is also shared by the EESC and CoR as shown in their respective opinions on this issue.

The Rapporteur presents a set of suggestions in its motion for a resolution, encompassing several aspects, including among others: the inclusion of CCS in EU and national socio-economic strategies, especially in the medium-long run, the use of ESF and ERDF to support such sectors, as the future EU budgets should go in the same direction or the CCS possible contribution to create new jobs, with a positive impact on territorial integration. A delay for amendments will be open in order to allow MEPs to complete the Rapporteur's suggestions.

5. 2014 Budget - Mandate for the Trilogue (Point 8 of the draft agenda)

Mr Stavrakakis will submit to the committee his draft opinion, underlining the strategic role of Cohesion Policy in generating jobs and growth in the EU, and of structural and cohesion funds in public investment in the Member States and their regions. Expressing concern that the uncertainty linked to the adoption of the MFF constitutes an obstacle for any serious budgetary planning, the Rapporteur welcomes also the Commission's proposal on Draft Amending Budget 2/2013 for a total amount of EUR 11.2 billion, of which EUR 9 billion are devoted to Cohesion Policy and while he considers it as a first step in the effort to tackle the shortfall in payments, he underlines that this amount does not suffice to cover all unpaid payment claims from 2012. Finally, while asking that administrative deficiencies in the implementation of Cohesion Policy are effectively addressed on the ground, Mr Stavrakakis considers that the next programming period constitutes an opportunity to improve the positive impact

of Cohesion Policy and insists that the preparation of the Partnership Agreements and programmes should take place as soon as possible.

6. Promoting a European transport-technology strategy for Europe's future sustainable mobility (Point 9 of the draft agenda)

The initiative report tabled in the transport committee deals with the communication from the Commission on an European transport-technology strategy for Europe's future sustainable mobility. It follows the 2011 white paper on transport, that had set ambitious objectives for reducing Europe's dependence on imported oil, improving the environment, reducing accidents and sharply cutting greenhouse-gas emissions. The Communication presents the Commission's views on how transport research and innovation could contribute to the ambitious objectives of the White Paper on Transport and support the implementation of Horizon 2020 linking also up with strategies for smart specialisation.

The initiative draft report tabled in the lead committee insists particularly in being concerned with achieving the Union's targets in terms of the reduction of energy consumption, traffic noise, air pollutants, GHG emissions, accidents and land use, thereby reducing the impact of transport on climate change and contributing to improving the health of EU citizens and their quality of life.

The Rapporteur will present his draft opinion pointing out the importance of taking into account territorial cohesion and regional specificities when designing and implementing this Transport Technology strategy.

7. Regional strategies for industrial areas in the European Union (Point 10 of the draft agenda)

The INI report stresses the need for assistance when developing regional strategies for old industrialised areas and presents ideas on how the specific challenges and obstacles can be overcome by developing well structured regional strategies. It highlights that sustainable regeneration of old industrialised regions is very costly and therefore, European public funding needs to play an important role in possible future attempts to reconvert old industrialised regions. The Report highlights as well examples of successful conversion strategies aiming thus to bring a contribution to and shape the decision-making process in support of future integrated territorial investment and policy delivery for the 2014-2020 period.

60 amendments were tabled to the report drafted by Mr Jens Geier. The amendments emphasise the importance of the industrial reconversion in Europe with a view to a modern and sustainable re-industrialisation but also with the view of reaching the Union's priorities. The amendments highlight the challenges that old industrialised areas are faced with: such as regeneration of derelict land, rehabilitation of housing and infrastructure, addressing ecological needs, massive changes in economic activities and jobs. They also stress how Cohesion Policy has to contribute even further to these evolutions and how local and regional actors need to increase further their capacity to plan and develop a new base for future economic, social and territorial development.

The Rapporteur is working on a number of compromise amendments if possible.

8. Blue Growth - Enhancing sustainable growth in the EU's marine, maritime transport and tourism sectors (Point 11 of the draft agenda)

36 amendments were tabled to the Draft opinion, with possible compromise amendments under negotiation. before the vote.

The initiative report tabled in the transport committee deals with two communications from the Commission: the First on the second progress report on the EU's Integrated Maritime Policy and the second on "Blue Growth: opportunities for marine and maritime sustainable growth". The commission seeks for the future to maximize the contribution of the EU's Integrated Maritime Policy to achieving the goals of the Europe 2020 strategy for smart, sustainable and inclusive growth. The EU's blue economy represents 5.4 million jobs and a gross added value of just under EUR 500 billion per year. In all, 75% of Europe's external trade and 37% of trade within the EU is seaborne.

The Communication identifies five focus areas in which additional efforts at EU level could yield long-term growth and sustainable jobs: Blue energy, Aquaculture, Maritime, Coastal and cruise tourism, Marine mineral resources and Blue biotechnology.

For each of the five activities highlighted the Commission will analyse policy options and consider further initiatives.

10. Forward policy planning and long-term trends: budgetary implications for capacity-building (Point 13 of the draft agenda)

The draft opinion of Mr. Vlasak will be put to the vote, including 17 amendments that were tabled, and possibly a compromise amendment. The amendments tabled focus essentially on the need to involve economic and social partners, non-governmental organisations and other stakeholders in the development of long-term strategies alongside public bodies at the level of Member States and of the Union. Moreover, a strong emphasis is put on the need to reinforce and support administrative capacity in the use and implementation of Cohesion policy instruments. In this context, a reference is also made to e-governance, deemed to be able to play a key part in capacity-strengthening, administrative modernisation and better horizontal and vertical coordination.

During March 2013 REGI session, the rapporteur Mrs Mojca Kleva presented her Working Document outlining the basic concepts and content of her future draft report.

This months REGI session will host a mini - hearing with two guest speakers to discuss the aspects of Energy Efficiency and the support from the future Cohesion Policy, especially applied to housing stock in the EU.

Mr Julien Dijol, Policy Coordinator CECODHAS – HOUSING EUROPE -

Mr Dijol is co-author of a report entitled "Practical recommendations to increase the share of sustainable energy investments in the upcoming SCF programming period 2014-2020". This report is based on the outcome of SF Energy Invest project, whose aim is to help Structural Funds Managing Authorities to increase the spending for sustainable energy projects. After setting out the new policy scene for the Structural Funds in 2014-2020, the report tried to identify barriers and obstacles to a greater use of Structural Funds for sustainable energy projects and proposes recommendations at all levels of governance and on different issues, for instance partnership, prioritization of the funds on low-carbon economy, integrated approach, selection of projects, etc.

Mr Dijol will focus on recommendations for energy efficiency measures in the housing sector.

• Mr Markus Thrilling, EU funds campaign coordinator for CEE Bankwatch Network/Friends of the Earth Europe, will make a presentation on the "Opportunities and challenges for Energy Efficiency financing in Central and Eastern Europe".

12. Amendment to the fuel quality directive and the renewable energy directive (Indirect Land Use Change) (Point 15 of the draft agenda)

Policy context and COM proposal

The EU committed itself to reduce its greenhouse gas emissions by 2020 by 20% compared to 1990s levels, to increase the share of renewable energies in the total EU energy consumption by up to at least 20% and increase their energy efficiency by 20%. Moreover, by 2020 each Member State must ensure that the share of biofuels in transport-related fuel consumption is at least 10% ("20-20-20 Decision").

The use of biofuels in Europe has been growing in response to the target set in the EU Renewable Energy Directive. This requires that 10 per cent of energy used in transport should be from renewable sources in every EU Member State by 2020. The biofuels used for this must not be produced from resources derived from areas with a high level of biological diversity or high carbon stock (wetlands, forests) ("sustainability criteria", Art. 17 Directive 2009/28/EC and Art. 7b Directive 98/70/EC).

Overlooked at the time the Directive was agreed, the indirect land use change (ILUC) consequences of ramping up biofuel use have now been recognised. The onus has been on the European Commission to come forward with a means of addressing the ILUC problem in EU legislation.

The current proposal makes two major advancements:

- Takes account of indirect land-use changes in assessing the greenhouse gas balance of biofuels;
- Limits the extent to which conventional biofuels count to half of the 10% expansion target for renewable energy as a partial correction of political shortcomings.

In her opinion to ENVI committee, your draftsperson, Mrs Rikka Manner emphasizes the importance of second generation biofuels and their potential to create economic growth and jobs in the regions. She also puts the accent on the need to improve resource efficiency and at the importance of the European Union's regional policy and structural funds in promoting innovative and new biofuels.

The Rapporteurs will report back to REGI Committee on the outcome of the trilogue meetings on the CPR which took place on the 20th, 26th, 27th of March and 8th and 10th of April. Works focused on the negotiation of the following thematic blocks: Performance Framework, Ex-ante conditionalities, Technical Assistance, Eligibility, Monitoring and Evaluation, Management and Control, Information and Communication, Major Projects and Revenue Generating Operations and PPPs.

The interinstitutional negotiations led to concrete progress in all the opened thematic blocks enumerated above. There are still a number of highly political and technical issues, which are still under negotiation.

The Rapporteur will report back to the REGI Committee on the outcome of the trilogue meetings on the ERDF, which took place on the the 9th and 22nd of April. These trilogue meetings were mainly dedicated to Art. 4 on Thematic concentration, follow up on Art. 5 on Investment priorities, and the co-legislators have reached a provisional agreement on Art. 7 and 8 on Sustainable urban development. Until now the co-legislators came to a conclusion with regard to the scope of support (Art. 3) but some elements are still linked to the solution on Art.5. As far as Art. 6 on common indicators is concerned, the Parliament Negotiating Team works on a common solution for the CF, the ERDF and the ETC. Two trilogue meetings are still scheduled: on the 22nd of April and the 6th of May.

15. Cohesion Fund and repeal of Council Regulation (EC) No 1084/2006 (Point 18 of the draft agenda)

The second trilogue on this file was held on 27 February, with all Articles of the proposal for a Regulation on the agenda. At this trilogue, the institutions have come to some understandings on some issues and provisions, and some parts of the text will still be modified or rephrased for further consideration.

In the framework of the procedure of reporting back to the Committee on progress made so far in the negotiations, the four column table was distributed and circulated among Members of the Committee prior to the Committee meeting of 18-19 March.

The issue of the Connecting Europe Facility (amendment 15) was not dealt with, and was again left for a later stage, once the whole issue of the CEF is clarified. Indeed, the Rapporteur has reiterated that it is imperative to include a reference to the CEF in the Cohesion Fund Regulation. The Presidency considers that the CEF issue pertains to the CPR and not to the Cohesion Fund Regulation, while the Commission refers that although it is legally unnecessary to have a reference to the transfer to the CEF in the Cohesion Fund Regulation, as this is included in the CPR, there is however no major objection to keeping it.

The same goes for amendment 36 (Article 4a), which was left for later, as the discussion on this provision depends on the conclusions taken on the issue of macro-economic conditionality in the framework of the CPR.

Regarding the issue of common indicators (Article 4 - amendment 35), a joint meeting between the Negotiating Teams for the CF, the ERDF, the ETC, and the ESF, on one hand, and the Commission and the Council, on the other, took place on 18 March 2013, in order to discuss the possible approaches to the issue. Further to this joint meeting, another meeting between the Parliament's Negotiating Teams on the CF, the ERDF and the ETC is scheduled for 16 April, in view of establishing a common approach to this issue ahead of the future trilogues on the various concerned files.

The third trilogue on the Cohesion Fund is scheduled for 13 May 2013.

The Rapporteur may report back to the Committee the undergoing status of negotiations that have begun in the framework of trilogues.

The past trilogues of the 25th March and 08th April have enabled to conclude the negotiations on most of the articles, and to begin the discussions on articles 5 and 6 on Thematic concentration and Investments priorities.

The next trilogues planned in end of April and May will enable to conclude on the remaining articles:

- Article 3 on the geographical coverage
- Article 4 on financial resources
- Article 15 on indicators, that will be agredd according to an horizontal approach within the legislative package
- Art 28, now 24bis is about to reach an agreement on a common drafting

The Commission is now working on a drafting proposal for the recitals to be adjusted to the last version of the articles agreed in trilogues.

This gives good chances to come up by concluding by May the negotiations on all the articles of the regulation.

17. The second trilogue on the EGTC regulation took place on March 21st during which the review of the text in its entirety was completed. As an outcome, a number of issues subject to controversy were identified.

Most relevant issues are:

- Tacit approval of the establishment of an EGTC after 6 months. (EGTC Regulation Article 4; par 3);
- Single competent authority in MS responsible for examining the request for authorising an EGTC (Article 4; par 3);
- Rules applicable to staff of EGTCs (Article 8; par 2);
- Participation of 3rd countries to an EGTC (Article 3 (a).

During the committee meeting, the rapporteur Mr Joachim Zeller will give a full account of the advancement of the negotiations process. The updated 4-column document will be sent to REGI Members prior to the committee meeting.

4. Exchange of views with Johannes Hahn, Commissioner on Regional Policy on Multiannual Financial Framework and the ongoing Interinstitutional negotiations on the post 2014 EU Cohesion Policy

Commissioner Johannes Hahn gave an overview on his evaluation of the agreement of the Member States on the Multiannual Financial Framework. The proposed financial resources would principally provide a basis for the new strategic orientation of the Regional Policy. He underlined that the negotiations between European Parliament and Council on the MFF should come soon to a result so that the negotiations on the sectoral policies would not be delayed and a reliable programming would be possible. In the debate many Members gave their comments and asked questions, in particular on the level and allocation of the budget, the performance reserve, flexibility as well as macroeconomic conditionality or thematic concentration.

5. <u>Exchange of views with Liviu Dragnea, Romanian Vice Prime Minister and Minister of Regional Development and Public Administration, and with Eugen Orlando Teodorovici, Romanian Minister of EU Funds</u>

Vice Prime Minister Liviu Dragnea outlined the Romanian administrative reforms to prepare for the Cohesion Policy period 2014 - 2020 and to increase the absorption capacity for EU funds in Romania. He explained the intended restructuring of the country's regions and how the decentralization will be organized. Minister Orlando Teodorovici explained how Romanian government will improve the implementation and delivery of European Funds according to the rules. Members expressed their acknowledgement and support for the reforms and administrative reorganization.

6. Common provisions on European Funds and repealing Regulation (EC) No 1083/2006

The rapporteurs, Ms Constanze Krehl and Mr Lambert van Nistelrooij, gave account of the ongoing interinstitutional negotiations on the basis of the most recent four columns tables. The rapporteurs explained in detail the ongoing negotiations, the main political obstacles encountered and those ahead. The rapporteurs presented in detail the tentative calendar in order to conclude negotiations at the end of May, in order to vote in JULY and go to plenary in October I.

The committee agreed unanimously on the results of the negotiations presented by the rapporteurs and on the tentative calendar presented. As it was already agreed by the committee, the specific funds regulations will follow the same calendar as the CPR.

7. Specific provisions concerning the European Regional Development Fund and the 'Investment for growth and jobs' goal and repeal of Regulation (EC) No 1080/2006

The Chair, Ms Danuta Hübner, on behalf of the Rapporteur Jan Olbrycht, gave account of the ongoing interinstitutional negotiations on the basis of the most recent four columns table. The committee agreed on the results presented by the Chair.

8. Cohesion Fund and repeal of Council Regulation (EC) No 1084/2006

The rapporteur, Mr Victor Bostinaru, gave account of the ongoing interinstitutional negotiations on the basis of the most recent four columns table. The committee agreed on the results presented by the rapporteur.

The rapporteur expressed his satisfaction with the progress of the triologues so that in the next trialogue meeting the negotiations could be finalized.

9. Support from the European Regional Development Fund to the 'European territorial cooperation' goal

The rapporteur, Mrs Riikka Manner, gave account of the ongoing interinstitutional negotiations on the basis of the most recent four columns tables. The committee agreed on the results presented by the rapporteur.

The rapporteur expressed her view that there are good chances to come up by the end of April of May with a final agreement on all the articles of the regulation, except the article 4 with financial figures largely depending on the agreement on the Multiannual Financial Framework.

10. Amendment of Regulation (EC) No 1082/2006 of the European Parliament and of the Council of 5 July 2006 on a European grouping of territorial cooperation (EGTC) as regards the clarification, simplification and improvement of the establishment and implementation of such groupings
