5 October 2011

1. <u>Temporary suspension of autonomous Common Customs Tariff duties on imports of certain industrial products into the Canary Islands</u> (Point 5 of the draft agenda)

The Commission proposal concerns the exercise of an implementing measure under Article 349 of the TFEU. These measures will have a negligible effect on the Union's own resources, they will have a positive effect on the competitiveness of the economic operators and in the present economic climate are conducive to assisting economic recovery.

This report is presented under Article 55 of the Rules and not Article 46 (simplified procedure). This means that a short deadline for amendments must be given. It will be considered on 5 October and voted on 6th. If amendments were nevertheless tabled (which should not be the case), the vote would have to be in November.

2. Amendment of Council Regulation (EC) N° 1083/2006 as regards certain provisions relating to financial management for certain Members States experiencing or threatened with serious difficulties with respect to their financial stability (Point 6 of the draft agenda)

The objective of the proposal is to help countries particularly hit by the financial crisis by provide additional financial resources to these countries, also ensuring the continued implementation of projects. This would be done through temporarily topping-up the EU cofinancing of cohesion policy programmes, and would not modify their overall allocation under cohesion policy for the period 2007-2013. The assisted countries would include to date: Hungary, Romania, Latvia, Portugal, Greece and Ireland. The proposal fall under the ordinary legislative procedure.

In the exchange of views the Rapporteur will present her draft report. Given the political urgency of the proposal, the committee has the highest interest in reaching an agreement, referring the report to the plenary as soon as possible and finding an agreement with the Council in first reading.

3. Amendment of Council Regulation (EC) N° 1083/2006 as regards repayable assistance and financial engineering (Point 7 of the draft agenda)

Member States have had positive experiences with repayable assistance schemes at the level of operations during the programming period 2000-2006 and have therefore continued such schemes or have started to implement repayable assistance schemes in the current programming period 2007-2013.

Council Regulation (EC) No 1083/2006 laying down general provisions on the European Regional Development Fund, the European Social Fund and the Cohesion Fund set out financial engineering instruments with precise areas and scope of intervention. However, the schemes implemented by Member States in the form of reimbursable grants and of credit lines managed by managing authorities via intermediate bodies are neither appropriately covered by the provisions on financial engineering instruments, nor by other provisions of Regulation (EC) No 1083/2006.

It is therefore necessary to set out in a new Section of Regulation (EC) No 1083/2006 that the Structural Funds may co-finance repayable assistance. The Commission proposal aims to provide clarity about the legality of an existing legal practice. It provides for a definition of reimbursable grant as a direct financial contribution by way of donation which can be totally or partially reimbursable without interest. It clarifies that the assistance repaid, to the body providing the assistance or to another competent public authority of the Member State shall be kept in a separate account and reused to the same purpose or in line with the objectives of the operational programme. Furthermore, it introduces reporting of financial engineering instruments, having regard to the need to ensure appropriate monitoring, by the Member States as well as by the Commission, of the implementation of financial engineering instruments. It also introduces a legal obligation in order to ensure that the financial contribution paid by managing authorities for establishing or contributing to financial engineering instruments is spent for eligible expenditure within a timeframe of two years of the payment into the fund.

In the exchange of views the rapporteur will present her draft report. Given the political

urgency of the proposal, the committee has the highest interest in reaching an agreement, referring the report to the plenary as soon as possible and finding an agreement with the Council in first reading.

4. Comparative Study on the visions and options for the Cohesion Policy after 2013 (Point 8 of the draft agenda)

Policy Department B has drafted a <u>Note</u> for the Members of the REGI Committee in order to inform them about the state of play of the debate on the future of EU Cohesion policy after 2013. Based on the approach and indications provided by the recent budgetary proposals of the European Commission (Budget Europe 2020), the Note provides an insight into the key issues of the current debate, highlights the main decisions policy-makers will face and presents the upcoming legislative process. The paper also includes the role of National Parliaments which will be discussed at the Committee on Regional Development's 3rd Interparliamentary Committee Meeting with National Parliaments on 6 October 2011.

Furthermore, on 5 October 2011, an extensive Comparative Study Policy Department B commissioned following an Open tender procedure in 2010 will be presented at the REGI Committee meeting. The study was done by the European Policies Research Centre of University of Strathclyde (EPRC) and provides a detailed critical analysis of EU Cohesion Policy reform perspectives for the post-2013 period. On the basis of a literature review and budgetary modelling, the study offers an assessment of the policy's strengths and weaknesses, the main reform ideas and counter-positions, including the implications of different reform proposals. It also provides interesting recommendations to inform the position of the European Parliament in the upcoming negotiations on the legislative package of regulations for Cohesion policy.

5. Evolution of EU Macro-Regional Strategies: Present practice and future prospects, especially in the Mediterranean (Point 10 of the draft agenda)

In the framework of the initiative report on the evolution of EU Macro-Regional Strategies for which Mr François Alfonsi is draftsperson, REGI Committee is pleased to have an exchange of views on two essential aspects of the report under preparation.

The first one deals with the present practice of Macro-regional strategies: The Baltic sea Strategy is the most advanced, and is one of the priorities of the Polish EU presidency. Mrs Henryka Mościcka-Dendys, from the Polish Ministry of Foreign Affairs, will therefore present the Committee a state of play of the review process of the Baltic Sea Strategy, including the projects already delivered, its achievements and the lessons learnt to assess future potential macro regions.

The second one, concerns the potential future macro regions in the Mediterranean, with the Adriatic-Ionian Initiative, that has already been put in the political agenda of the Member

States: after receiving the official support from the President of the Committee of the Regions, Mercedes Bresso, the last European Council on 23-24 June has called the Member States and the Commission to assess the feasibility of a macro region for the Adriatic and Ionian region. Mrs Maria Cristina Stimola, from the Region of Sicily (that is very involved in this initiative), will therefore present the state of play of this initiative

6. Parliament's position on the 2012 Draft Budget as modified by the Council - all sections (Point 11 of the draft agenda)

The REGI Committee held an exchange of views on the draft opinion on its meeting of 11-12 July, where the Rapporteur considered that the only institution which has the available information to have an overview of the real budgetary needs of all regions is the Commission, and therefore proposes that any reductions proposed by the Council be cancelled and that the sums initially proposed by the Commission in the Draft Budget, be reinstated.

Furthermore, the Rapporteur referred the pilot projects and preparatory actions that should be adopted: "Enhancing regional and local cooperation through the promotion of EU regional policy on a global scale", and "The definition of governance model for the European Union Danube Region — better and effective coordination", "Towards a common regional identity, reconciliation of nations and economic and social cooperation including a Pan-European Expertise and Excellence Platform in the Danube macro-region", as well as the new preparatory action entitled "Atlantic Forum for the EU Atlantic Strategy".

Finally, in its draft opinion, the Rapporteur welcomed the intention of the Commission, as endorsed by the European Council, to enhance synergies between the current loan programmes to certain Member States and the Structural Funds, with a view to boost competitiveness and growth, and calls the Commission to enhance its effort in finding ways to effectively improve the capacity of Member States in general to efficiently implement Cohesion policy programmes.

6 amendments were tabled to this draft report and one compromise amendment is under negotiation and will be put forward before the vote on 6 October. These amendments aim at reinforcing the disagreement towards the cuts proposed by the Council, at highlighting the particularly difficult economic and fiscal context Europe is now facing, and at enhancing the added value of the current measures to support the macro-regional strategies in place, while reminding of the need for a more effective and purposeful implementation of those to the benefit of the regions concerned.

7. <u>Demographic change and its consequences for the future Cohesion Policy of</u> the EU (Point 12 of the draft agenda)

In her report Ms Westphal points to the fact that the effects of demographic change vary according to the type and characteristics of each region and that these effects are not always negative. She stresses the need to ensure that regions suffering from a depletion of population must make themselves family attractive. and calls on the European Commission to include demographic change as one of the thematic priorities of the future cohesion policy. She advocates the use of ERDF funds to provide loans with low interest rates which could support the adaptation of housing to the needs of the elderly and proposes that funds should be provided for sheltered housing complexes and multi-generational housing Turning to migration, Ms Westphal calls on the Member States to agree on a common migration strategy, since Europe is reliant upon the immigration of skilled workers for demographic reasons, and proposes that more funding should be provided for the integration of immigrants in order to dispel prejudices

170 amendments and 17 compromise amendments have been tabled to this report and the vote in committee will take place on 6 October.

8. Roadmap to a Single european Transport Area - Towards a competitive and resource efficient transport system (Point 13 of the draft agenda)

Since the 2001 White Paper on Transport, much has been achieved, but the transport system is still not sustainable, transport cannot develop along the same path in the future. The Roadmap of the Commission takes a global look at developments in the transport sector, at its future challenges and at the policy initiatives that need to be considered.

The transport industry in itself represents an important part of the economy: in the EU it directly employs around 10 million people and accounts for about 5% of GDP. Coherence at EU level is vital. The EU and Governments need to provide clarity on the future policy frameworks for manufacturers and industry so that they are able to plan investments. The objective for the next decade is to create a genuine Single European Transport Area by eliminating all residual barriers between modes and national systems, easing the process of integration and facilitating the emergence of multinational and multimodal operators.

The various actions and measures indicated in this Roadmap will be further elaborated. The Commission will prepare appropriate legislative proposals in the next decade with key

initiatives to be put forward during the current mandate. Each of its proposals will be preceded by a thorough impact assessment, considering EU added value and subsidiarity aspects.

Due to the cancelled REGI meeting on 19 September the draftsman could not present his draft opinion to the Committee. Nevertheless the deadline for amendments was set to 20 September, as the vote cannot be postponed due to the tight timetable of the lead committee.

36 amendments were tabled to this draft opinion. Amendments concern inter alia territorial cooperation, outermost regions, funding of transport infrastructure and environmental concerns.

9. The review of the European Neighbourhood Policy (Point 14 of the draft agenda)

The Committee of Foreign Affairs decided to draw up an own-initiative report on the Review of the European Neighbourhood Policy under rule 48 of the Rules of Procedure. This report aims at providing the opportunity to set down the Parliament's priorities for the ENP having regard to the current discussions on the new multiannual Financial Framework.

The AFET's draft report develops a variety of issues including every aspect of EU's Neighbouring Policy, such as democracy, sustainable economic and social development, sectorial cooperation, migration, or conflict resolution.

Considering that one of the main pillars of the ENP is cross border cooperation, and that the EU Cohesion policy can be of outstanding use, the REGI committee has prepared an opinion document to be discussed in this meeting.

Due to the cancelled REGI meeting on 19 September the draftsman could not present her draft opinion to the Committee. Nevertheless the deadline for amendments was set to 20 September, as the vote cannot be postponed due to the tight timetable of the lead committee.

25 amendments were tabled to this draft opinion and compromise amendments are under negotiation.

Mr Ahner will present to REGI Members the EC staff working paper on Analysis of errors in Cohesion Policy for 2006-2009 and actions taken by the Commission.

12. Report on the visit of a REGI delegation to the United Kingdom from 14 to 16 June 2011 (Point 17 of the draft agenda)

From the 14th to 16th June, a delegation of Members of the REGI committee visited the UK Participating Members were MEP Constanze Angela KREHL (S&D, Germany), Chair of the delegation, MEP Seán KELLY (EPP, Ireland), MEP Joachim ZELLER (EPP, Germany), MEP Oldřich VLASAK (ECR, Czech Republic), MEP Karin KADENBACH (S&D, Austria), MEP Vilja SAVISAAR-TOOMAST (ALDE, Estonia.). It was accompanied by MEP Catherine BEARDER (ALDE, United Kingdom).

The delegation wished to see how Cohesion Policy and particularly ERDF resources were being used in the UK. The visit was of particular interest in view of the restructuring of regional authorities undertaken by the government and the austerity measures being implemented by the UK government and its general approach to EU finances.

During various meetings with Ministers, fund managers and mayors, the committee Chair stressed Parliament's view that Cohesion Policy must remain a Pan European policy involving all regions and not simply those in the most need. Furthermore, to have the required effect of stimulating growth and achieving the aims of the EU 2020 strategy, over the next programming period (2014 -2020), the policy must have resources at least equal to those it enjoys at present.

This contrasted with the views expressed by government Ministers but was strongly supported by local authorities and all stake holders on the ground.
