It is my pleasure to welcome you to the EMPL Bulletin, the newsletter of the Committee on Employment and Social Affairs (EMPL Committee).

The first EMPL Committee meeting under this new legislative term will take place on 24 July 2019.

The EMPL Committee has 55 members and the same number of substitutes who represent Parliament's seven political groups. Our Committee's work is steered by the Chair, four Vice-Chairs and the coordinators of the political groups, who link the Committee's work with the priorities of their respective political families.

During the ninth legislative term, the EMPL Committee will continue its work on employment and all aspects of social policy including working conditions, social security, social inclusion and social protection. The EMPL Committee is also responsible for policies related to the free movement of workers and pensioners as well as for workers' rights, health and safety measures at the workplace and the European Social Fund. We also deal with vocational training policy, including professional qualifications, social dialogue and all forms of discrimination at the workplace and in the labour market except those based on sex.

Our Committee will also continue to closely cooperate with the European Commission, the Council and other relevant institutions and stakeholders as well as with the five EMPLrelated agencies: Cedefop, Eurofound, EU-OSHA, ETF and the newly created ELA.
