**Daniel Mullaney**Assistant United States Trade
Representative for Europe and
the Middle East

Dan Mullaney is Assistant United States Trade Representative for Europe and the Middle East at the Office of the United States Trade Representative. He develops, coordinates, and implements U.S. trade policy toward the European Union and other European trading partners, Eurasia, the Middle East, and northern Africa.

From 2006 to 2010, Mr. Mullaney was the Senior Trade Representative in the United States Mission to the European Union in Brussels, Belgium, where he advocated on behalf of U.S. trade interests in the various institutions of the European Union and represented USTR in the broader Brussels trade policy community. Before becoming Senior Trade Representative in Brussels, Mr. Mullaney was an attorney in USTR's Office of General Counsel, where he led negotiations and provided legal advice for free trade and other agreements and represented the United States in dispute settlement proceedings at the World Trade Organization. Mr. Mullaney's substantive area of responsibility in the general counsel's office included trade-related aspects of intellectual property rights, technical barriers to trade, sanitary and phytosanitary regulations, and trade and environment, among other areas.

Prior to joining USTR in 1999, Mr. Mullaney was a partner in a major international law firm, specializing in international trade law.

Mr. Mullaney is a native of Cincinnati, Ohio. He earned a B.A. degree from Amherst College in 1979, and a joint law/foreign service masters degree from Georgetown University. He is married and has two children.

Mrs Santiago Cid has been CEN and CENELEC Director General since 1 January 2010 (the CEN-CENELEC Management Centre employs 86 people and its annual budget is 13,5M€). CEN and CENELEC are two of the three recognized European Standardization Organizations supporting European Policies and Legislation. CEN and CENELEC are leading providers of European Standards that are driven by business and made through a transparent, balanced and consensusbased process in which all relevant stakeholders, including societal interest groups and SMEs are involved. CEN and CENELEC abide by the WTO TBT principles and beyond; they adapt proactively to new developments and support European competitiveness, the protection of the environment and sustainable growth for the well-being of citizens and the strengthening of the Single Market. CEN and CENELEC actively support international standardization and cooperate closely with the International Organization for Standardization (ISO) and the International Electrotechnical Commission (IEC) in order to foster and promote European competitiveness in the global market. Mrs Santiago Cid is responsible for the direction and management of the CEN-CENELEC Management Centre, providing executive support to the activities of the General Assemblies and Administrative Boards of CEN and CENELEC, and the CEN-CENELEC Presidential Committee, as well as their advisory committees. She manages the institutional relations with the European Union Institutions and EFTA, and is responsible for relations with the European sister organization ETSI, as a member of the Joint Presidents Group, and with the international organisations ISO and IEC, as a member of the Management Coordination Group. Previously, Mrs Santiago Cid, who was Director General of CENELEC since September 2003, was Director External relations in AENOR, the Spanish national standardization body and was seconded to the European Commission to support New Approach Directives in the electromechanical field, including coordination of market surveillance authorities. She graduated in Electronic Engineering from the Polytechnic University of Madrid and has more than 20 years experience in standardization.

**Monique Goyens**Director General BEUC



As Director General of BEUC, Monique represents 41 independent national consumer associations in 31 European countries, acting as a strong consumer voice in Brussels, ensuring that consumer' interests are given weight in the development of policies and raising the visibility and effectiveness of the consumer movement through lobbying EU institutions and media contacts.

As a consumer expert and advocate, she was member of the EU High-level Expert Group on reforming the structure of the EU banking sector (Liikanen group) and is a delegate in the Consultative **Commission** on Industrial Change of the European Economic and Social Committee. She is also member of the EU High-level Group on the sustainability of the food supply chain, of the EU Resource Efficiency Platform and is substitute member of the SEPA-Council. Recently, she has been appointed as Associate member of the EIF Board of Management (European Internet Foundation) and sits on the Advisory Group of the European Commission on the Transatlantic Trade & Investment Partnership (TTIP).

In her capacity as BEUC Director General, Monique is currently EU co-chair of the Transatlantic Consumer Dialogue (TACD) a network of EU and US consumer organisations (<a href="www.tacd.org">www.tacd.org</a>), and Treasurer of Finance-Watch (<a href="www.finance-watch.org">www.finance-watch.org</a>), a public interest association dedicated to making finance work for the good of society. She also represents BEUC at Consumers International, the international consumer organisation (<a href="www.consumersinternational.org">www.consumersinternational.org</a>).

## Session 3 - Panel discussion on the standards to be agreed for public procurement



**Tom Jenkins**OBE - Senior Advisor at
European Trade Union, ETUC



Tom Jenkins joined the International Department of the Trades Union Congress in Britain in 1973. He became Head of the TUC Europe Unit in 1994, and Secretary for EU & International Relations in 1999. He was seconded to the Foreign and Commonwealth Office in 1979-1980, where he served as Deputy International Labour Adviser.

In October 2003, he joined the European Trade Union Confederation as the Senior Adviser to the General Secretary (first to John Monks until 2011, and since to Bernadette Ségol). His responsibilities include the coordination of the ETUC's work in the external relations and trade fields.

He has represented the British and European trade union Movement in a range of international trade union and joint bodies, including the European Economic and Social Committee where he was elected President of the Workers Group, 1990-96, and President of the Committee, 1996-98. He has co-chaired joint civil society bodies including those between the EU and ACP countries; EuroMed; EFTA; and Turkey. He is currently Chair of the Domestic Advisory Group set up under the EU-Korea FTA, and co-chair of the joint Civil Society Forum. He is a member of the TTIP Advisory Group.

He is an Honorary Member of the Franco-British Council, of which he has been a Trustee. He was appointed Officer of the Order of the British Empire in 2000 for services to industrial relations in the European Union.



Hendrik Bourgeois Vice President European Affairs at GE (General Electric Company)



Hendrik Bourgeois is Vice President European Affairs at GE (General Electric Company). His most recent prior positions at GE include General Counsel EMEA, Senior Counsel, Competition, Regulation and Government Relations for Europe, and European Competition Counsel, serving all GE businesses on a wide variety of competition law matters involving mergers and acquisitions, distribution, R&D activities and compliance issues.

In his preceding role, Hendrik headed the legal department of one of GE's business divisions, GE Industrial Systems, as European General Counsel.

Prior to joining GE, Hendrik Bourgeois was an attorney with Jones Day, based in Washington DC and Brussels, where he practiced mainly US antitrust and European competition law.

Hendrik obtained his law degree at the Rijksuniversiteit Gent, Belgium and has an LL.M degree from Harvard Law School. He is a former member of the Brussels Bar and current member of the New York Bar. Hendrik is a frequent speaker and writer on competition law issues.

He was elected Chairman of AmCham EU in October 2011.
