As a consumer expert and advocate, she was member of the EU High-level Expert Group on reforming the structure of the EU banking sector (Liikanen group) and is a delegate in the Consultative Commission on Industrial Change of the European Economic and Social Committee. She is also member of the EU High-level Group on the sustainability of the food supply chain, of the EU Ressource Efficiency Platform and is substitute member of the SEPA-Council. Recently, she has been appointed as Associate member of the EIF Board of Management (European Internet Foundation).

In her capacity as BEUC Director General, Monique is currently EU co-chair of the Transatlantic Consumer Dialogue (TACD) a network of EU and US consumer organisations (www.tacd.org), and Treasurer of Finance-Watch (www.finance-watch.org), a public interest association dedicated to making finance work for the good of society.
