## Highlights

### **EU beef, veal and poultry sectors: Exchange of views with the Commission representatives (DG AGRI, DG COMP and DG TRADE)**



On 6 July, AGRI Members will discuss the situation of the EU beef, veal and poultry sectors with EC representatives. This discussion is to take place while beef and broiler prices paid to producers are going down. Farmers concerns are accentuated by the impact of EU trade agreements, the prospect of Brexit and the Farm to Fork and Biodiversity Strategies that will affect the European meat sector.

## Work in progress

### Transitional provisions for the support by the European Agricultural Fund for Rural Development (EAFRD) and by the European Agricultural Guarantee Fund (EAGF) in the year 2021



Rapporteur Ms Katainen (RE, FI) will present the outcome of the third trilogue, taking place in a mixed setting on 30 June. The co-legislators have successfully reached a partial provisional political agreement. Although provisional, the compromise reached involves all the essential aspects of the transitional CAP file, while only the pending issues linked to the MFF remain open.

### Sustainable Europe Investment Plan - How to finance the Green Deal



The Draft Opinion on the *"Sustainable European Investment Fund (SEIP): How to Finance the Green Deal?"* will provide the ECON/BUDG Committees, as leading committees, a valuable input on how the agricultural sector aim at participating to the financing of the SEIP; Members tabled 58 amendments and 6 compromise amendments are proposed by the AGRI rapporteur, Mr Salvatore de Meo.
