2.2. Budgetary procedure 2021 - Amendments and vote on the resolution

The coordinators:

- took note of the updated calendar of the budgetary procedure and agreed that it is formalised at the budgetary trilogue of 22 September;
- agreed that Members and political groups should table their budgetary amendments in English only;
- decided to convene a coordinators' meeting with the budget rapporteurs and shadow rapporteurs after the publication of the Commission's Amending Letter to assess it.

2.3. Draft Amending Budget 8/2020 - urgent procedure

The coordinators decided to request of the application of the urgent procedure (Rule 163) to DAB 8/2020, so that it is adopted at the September Plenary part-session.

At the same time, the coordinators express strong concern about the more and more frequent requests by the Commission that Parliament apply urgent procedures instead of allowing sufficient time for proper deliberation at the committee stage.

2.4. MFF/OR - state-of-play and next steps

The coordinators discussed the state of play and possible strategy as regards the negotiations on MFF/OR and Rule of Law.

2.5. 'Bridge solution' and Recovery instrument: way forward with legislative files

Pending coordination between the BUDG rapporteurs and the co-rapporteurs from other committees, the coordinators expressed the intention to continue work on the SSI file. A decision on EFSD will be taken after feedback from the co-rapporteurs.

3. POINTS FOR INFORMATION

3.1. Outcome of written procedures

1. ECON Early Non-Objection as regards streamlining the reporting requirements for euro area Member States if they have drawn on the Pandemic Crisis Support of the ESM

There was one objection by GUE to the ECON recommendation for early non objection. As this does not constitute a majority, BUDG has not communicated any objection to ECON.

2. <u>Amending Regulation (EU) No 514/2014 of the European Parliament and the Council, as regards the decommitment procedure COM(2020)0309</u>

In the absence of any reply by the deadline, the written procedure has resulted in the decision that BUDG will not deliver an opinion to the lead committee LIBE on the proposal for amending Regulation (EU) No 514/2014 of the European Parliament and the Council, as regards the decommitment procedure.
