Highlights

Evaluation of the CAP measures applicable to the wine sector: Presentation by the European Commission (DG AGRI)



The AGRI Committee invited DG AGRI on 19 November to present its evaluation of the CAP measures applicable to the wine sector. The EU is the world's leading producer, consumer and exporter of wine. We are however assisting to a change in this trend with a declining on domestic consumption and growing opportunities on the world market, and therefore the wine sector is increasingly focusing on competitiveness and quality rather than on volumes of production. We will hear how CAP measures impact on the reality of the wine sector.

Work in progress

CAP Strategic Plans, Horizontal regulation and CMO: Ongoing trilogue negotiations



Mr Jahr, rapporteur for the CAP Strategic Plans, Ms Müller, rapporteur for the Horizontal regulation and Mr Andrieu, rapporteur for the CMO, will update the AGRI Members on the outcome of the trilogue on the CAP reform of 10 November.

This joint trilogue launched the interinstitutional negotiation process for the 3 files in a single meeting.

Single market: Ongoing trilogue negotiations:



AGRI rapporteur, Ms Simone Schiedtbauer (EPP, AT) will update the Committee on the outcome of the third trilogue on the proposal for a regulation establishing the Programme for single market, competitiveness of enterprises, including small and medium-sized enterprises, and European statistics. The proposed programme brings together activities financed under five predecessor programmes. The AGRI Committee was granted associated status under Rule 57 of the Rules of Procedure, with shared, as well as exclusive, competences for parts of the Commission's proposal, namely on the "Food Chain Programme" part which relates to the sanitary and phytosanitary programmes as well as to the animal welfare programmes.

NextGenerationEU and Recovery Instrument programme for Rural Development: Ongoing trilogue negotiations:



Thanks to the speedy work performed by the co-legislators, the provisions as regard the NextGenerationEU/Recovery Instrument for the EAFRD are now concluded. It took 2 trilogues on 4th and 20th of November and several technical meetings to agree on a text to be integrated into the Transitional Regulation.
