EU agriculture after Brexit



On 7 December, the AGRI Committee organises a public hearing on EU Agriculture after Brexit to tackle the impact of Brexit on agricultural trade flows, including the particular situation of Ireland and the protection of geographical indications. It has been scheduled to take place at the end of the transition period, when the future EU-UK relationship and the challenges for EU agriculture would, be more apparent. The hearing will provide an opportunity for representatives of European Agriculture and Agri-Food to share their views on the matter with AGRI Members.

Work in progress

CAP Strategic Plans: Ongoing trilogue negotiations



Our rapporteur, Peter Jahr (EPP, DE) will present the outcome of the second trilogue on the Strategic Plans of 1 December. The negotiators made some progress on enhanced conditionality for eco-schemes and other technical points. The topics of conditionality rules, farm advisory services and GAEC/SMRs were also discussed with limited progress. The co-legislators agreed to continue their work and will meet again on the 10 December for another trilogue, with the aim to reaching a preliminary agreement on the conditionality package.

Horizontal regulation: Ongoing trilogue negotiations



Our rapporteur, Ulrike Müller (Renew, DE) will present the outcome of the first trilogue on the Horizontal regulation, which took place on 4 December. The first two packages, namely the Governance and the Financial Management, are at the core of the inter-institutional negotiations at this stage.

CMO: Ongoing trilogue negotiations



Our rapporteur, Eric Andrieu (S&D, FR) will present the outcome of the first trilogue on the CMO, which took place on 2 December. The discussions mainly focussed on the block of amendments concerning "wine, aromatized wine and quality schemes", followed by a first general discussion on the "market/crisis management" block of amendments.
