2.2. Annual Budget - Financial package for refugees from Syria

Coordinators and rapporteurs discussed the strategy to follow on the financial package for refugees for 2021 and 2022 in view of the budgetary trilogue of 15 July.

2.3. EP Budget 2022

Coordinators and the rapporteur agreed on the line to take in view of the budgetary trilogue of 15 July.

2.4. Regular Dialogue on Own resources

Coordinators agreed with launching the "regular dialogue" with the Council and the Commission on the Own Resources roadmap in October, once the Council has had a chance to consider the Commission proposals. They also mandated the Chair to send a letter to the Commission reminding it about its commitments under the IIA / Own Resources roadmap, in respect of the digital levy and as a follow-up to the new OECD agreement on international tax reform.

2.5. Implementation report on the NGEU borrowing strategy - Request for expertise

Coordinators decided to request external expertise (a briefing and a workshop) on "The borrowing strategy for Next Generation EU: design, challenges and opportunities" in the context of the implementation report under preparation.

2.6. Request of Rule 57 on decentralised agencies/bodies

Coordinators decided to request – as a rule – Rule 57 (with shared competence on the budgetary provisions) for all legislative proposals for new decentralised agencies/bodies or revisions of the basic acts of existing decentralised agencies.

2.7. Monitoring of climate and biodiversity mainstreaming in the EU budget

Coordinators decided to organise a workshop at staff level involving staff of the BUDG and ENVI committees, open to interested Members. They also decided to request an update of last year's study on climate mainstreaming in the EU budget.
