# 7. Follow-up of previous Coordinators decisions

7.1. Decent working and employment conditions in the aviation sector (Question for oral answer O-000019/2021)

Coordinators confirmed their wish to table again the EMPL Oral question in case it is not included in the June Plenary agenda (if possible jointly with TRAN OQ).

### 7.2. Public Hearing on various aspects of women in poverty following the COVID impact [MM]

Coordinators took note of the state of play as regards this hearing and welcomed the good cooperation with FEMM.

# 7.3. Public hearings and activities with national parliaments during the second half of 2021 (July-December) - state of play [EC]

Coordinators took note of the cooperation arrangements on hearings planned for the 2nd semester that were agreed with other Committees ahead of the CCC meeting of 27 April.

The majority highlighted that racism and xenophobia are u still relevant topics and a growing issue within the EU and are not only a LIBE issue. Thus, they noted the EU Anti-Racism Action Plan includes a part on "Employment, education, health and housing", (4 pages out of 26), addressing inter alia employment, Skills Agenda, VET, Erasmus+, Youth Guarantee, housing.... Coordinators therefore reiterated their support to the proposal made on 26 April as regards the proposed EMPL involvement in the LIBE hearing on the 'Implementation of the European Union anti-racism agenda with a focus on the implementation of the EU Anti-Racism Action Plan 2020-2025'<sup>2</sup>.

Coordinators also took note of the <u>possibility</u> that LIBE requests an ad-hoc hearing on the Report from the Commission to the European Parliament and the Council on the application 'the Racial Equality Directive' and the Employment Equality Directive'.

- Should it be confirmed, they agreed to request to co-organise this hearing (*viz.* selection of half of the speakers by EMPL; half of the speaking time for EMPL Members; co-chairing by EMPL and LIBE Chairs).
- Should LIBE not request this hearing, they agreed that EMPL will then request such a hearing.

In any case, Coordinators agreed that a representative of FRA should be invited (see also point 6).

# 8. Possible EMPL resolution on the social emergency - suggestion by the Left group [MM]

Coordinators endorsed the following:

- Oral question only, prepared under the leadership of the Chair, as proposed by the Left (with in addition one 'co-sponsor' to be appointed by each group);

#### Ad-hoc discussion

EMPL invited Jeff Bezos, the CEO of Amazon, or another high-level representative from Amazon S-team, to the Hearing "Amazon attacks on fundamental workers' rights and freedoms: freedom of assembly and association and the right to collective bargain and action.

Coordinators deplored that neither Jeff Bezos, CEO of Amazon, nor another high-level representative from Amazon's S-team, took part in the Hearing "Amazon attacks on fundamental workers' rights and freedoms: freedom of assembly and association and the right to collective bargain and action", held on the same day<sup>3</sup>.

Coordinators discussed different options how to react to this, in particular to 1) inform President Sassoli about this, 2) bring the matter to the attention of the CoP and 3) consider whether to issue a resolution. They also underlined the importance of close cooperation with ECON. Coordinators agreed to wait with the decision on the follow-up until after the Hearing.
