Coordinators and budget rapporteurs exchanged views on the overall strategy ahead of the vote on the 2022 budget and on the next steps in view of the budgetary conciliation.

2.3. DAB 5 / Package in favour of refugees from Syria and beyond

Coordinators confirmed their approach to have DAB 5 discussed during the budget 2022 conciliation.

Coordinators discussed the way forward regarding the role of BUDG in the Fit for 55 legislative procedures. They confirmed the original mandate to the Chair for the negotiations and underlined the strong interlink - and need for coherence - between the legislative package and the budgetary dimension, in particular as regards the new Own Resources.

Coordinators mandated the Chair to write to the President to request the initiation of the procedure of budgetary scrutiny for proposals based on Article 122 TFEU with potential appreciable implications for the Union budget.
