Subject:	Council recommendations on the discharge to be given to the bodies set up under the TFEU and the Euratom Treaty in respect of the implementation of the budget for the financial year 2018
	<ul><li>Adoption</li></ul>

- 1. In accordance with Regulation (EU, Euratom) 2018/1046<sup>1</sup>, and in particular Article 70(4) thereof, the Council is required to draw up recommendations to the European Parliament on a discharge to be given to the bodies set up under the TFEU and the Euratom Treaty and which have legal personality and receive contributions charged to the budget.
- 2. At its meetings on 14 and 30 January, and 6 February, the <u>Budget Committee</u> examined the thirty-two specific annual reports<sup>2</sup> of the European Court of Auditors related to bodies set up under the TFEU and the Euratom Treaty, having legal personality and receiving contributions charged to the budget, and reached an agreement on the draft texts as set out in the Addendum.
