SPEAKERS



Małgorzata BONIKOWSKA is President of the Centre for International Relations think tank in Poland. She also teaches at Warsaw University (Centre for European Studies) and Vistula Academy. In 1998-2001, she worked as head of the European Information Centre, as well as Adviser to the Minister of European Integration, in Warsaw. She has also worked for the European Commission as expert and Director of the EU Information and Communication Programme in Poland and in Bulgaria. She graduated from Warsaw University in neo-philology, Sorbonne University in Paris in history, and the Academy of Performing Arts in Warsaw in history of culture. She has a PhD from the Polish Academy of Sciences and the International PhD. School of RSM.



Lars BROZUS is a Senior Fellow at the German Institute for International and Security Affairs (SWP), the Berlin-based foreign-policy think tank. Before joining SWP in 2010, he was Managing Director of the Collaborative Research Centre (SFB) 700 for 'Governance in Areas of Limited Statehood: New Modes of Governance' at Freie Universität Berlin, having served as a foreign policy adviser at the German Bundestag, and held various teaching and research positions at several universities. He has a PhD from the University of Bremen.



Elisabetta CORNAGO is a research fellow at the Centre for European Reform (CER) in Brussels, focussing on EU energy and climate policy from an economic perspective. Before joining the CER, she worked as an environmental economist at the OECD, and as energy policy analyst at the International Energy Agency. She holds a PhD in economics from Université libre de Bruxelles (ULB).



Heather GRABBE is Director of the Open Society European Policy Institute, a Brussels-based think tank. She has served previously as Senior Adviser in the cabinet of the (then) European Commissioner for Enlargement, Olli Rehn, and as Deputy Director of the Centre for European Reform (CER). She has held positions and undertaken academic research at the European University Institute (EUI), RIIA Chatham House, the London School of Economics (LSE), and Oxford and Birmingham Universities, from the last of which she received her doctorate.



lan LESSER is Executive Director of the Brussels office of the German Marshal Fund (GMF), where he leads its work on foreign and security policy, the Mediterranean, Turkey and the wider Atlantic. He was previously a Public Policy Scholar at the Woodrow Wilson International Center for Scholars and Vice President at the Pacific Council on International Policy. He also worked at the RAND Corporation as a senior analyst and research manager. Earlier, he was a member of the Secretary's Policy Planning Staff at the U.S. Department of State. He was educated at the University of Pennsylvania, the London School of Economics, and the Fletcher School of Law and Diplomacy, and received his doctorate from Oxford University.



André SAPIR is Professor at the Université Libre de Bruxelles (ULB) and Senior Fellow at Bruegel, the Brussels-based economic think tank. He is also a member of the High-Level Advisory Group on post-COVID economic and social challenges convened by European Commissioner Paolo Gentiloni, and a member of the Royal Academy of Belgium for Science and the Arts. He has taught at a number of US and European universities, as well as serving as a visiting fellow at the IMF, World Bank and WTO. He holds a PhD in economics from Johns Hopkins University.
