# **Economic Dialogue and exchange of views with Fernando Medina, Minister of Finance of Portugal**

On Thursday, 8 September, 10:15 –11:15, the Minister of Finance of Portugal Fernando Medina will attend an Economic Dialogue with Members of the ECON Committee.

The focus of the exchange of views will be on the progress made by Portugal under the post-programme surveillance. This Economic Dialogue is part of a series of exchanges of views with a number of Member States taking place on the basis of Article 14 of Regulation (EU) No 472/2013 of the European Parliament and of the Council of 21 May 2013 on the strengthening of economic and budgetary surveillance of Member States in the euro area experiencing or



threatened with serious difficulties with respect to their financial stability. Similar exchanges already took place with the Ministers of Finance of Cyprus, Spain, Ireland and Greece. A further Economic Dialogue is planned with the Minister of Finance of Romania.

# Structured Dialogue with Margrethe Vestager, Executive Vice-President and Commissioner for Competition

ECON Members will hold a structured dialogue on competition policy with Margrethe Vestager, Executive Vice-President for A Europe Fit for the Digital Age and Commissioner for Competition on Thursday 8 September 2022, from 11.30 to 12.30.

The meeting provides an important opportunity to take stock of the current developments on competition policy and to discuss the progress on the review of key regulations and guidelines. The responses to Russia's invasion of Ukraine and the energy crisis will be likely subjects of interest together with the recently amended State aid Temporary Crisis Framework.

- the free movement of capital and payments (cross-border payments, single payment area, balance of payments, capital movements and borrowing and lending policy, control of movements of capital originating in third countries, measures to encourage the export of the Union's capital);
- the international monetary and financial system (including relations with financial and monetary institutions and organisations);
- rules on competition and State or public aid;
- tax provisions;
- the regulation and supervision of financial services, institutions and markets including financial reporting, auditing, accounting rules, corporate governance and other company law matters specifically concerning financial services;
- the relevant financial activities of the European Investment Bank as part of European economic governance in the euro area.
