The following reports were allocated as part of a package.

Renew particularly pointed out that a first package deal was not respected.

ID stated that it had never been part of a package deal. ID also expressed dissatisfaction at the fact that the methodology for attribution of files has been changed, and that the "bidding system", agreed by the coordinators at the beginning of the legislative term, was not followed.

3.1. Legislative Reports

- 3.1.1. Proposal for a Directive of the European Parliament and of the Council amending Directive 2009/148/EC on the protection of workers from the risks related to exposure to asbestos at work EMPL/9/10227 2022/0298(COD) [MP]
 - The report has been attributed to Renew.

3.1.2. EC proposal for a decision on European Year of Skills 2023 - EMPL/9/10315- 2022/0326 (COD) [MP/HH]

- Coordinators decided to apply the normal procedure for this file.
- The date of the start of the European Year of Skills will be decided in the course of the procedure. In this respect, Renew was in favour of the simplified procedure. Renew pointed out the importance of starting the European Year of Skills in January 2023 and warned about the risks of delaying the start of the European Year of Skills.
- Coordinators agreed on the modalities of cooperation with CULT, as set out in the circulated draft letter.
- The report has been attributed to the EPP.
